The CORPO Dedicated Funds Program will make available just under \$1 million of funding for member selected, eligible projects within the CORPO region. On November 1, 2021 the CORPO Committee passed a resolution adopting policies for managing the recently developed *CORPO Dedicated Funds Program*. CORPO PROJECT UPDATE

- CORPO staff is participating with ODOT and TMACOG on the Rt. 23 Connect Study, which aims to determine the feasibility of a free-flowing connection between Columbus and Toledo Regions.
- Fairfield County will soon begin an update to the county's Active Transportation Plan. CORPO will provide assistance as needed.
- CORPO staff will assist CORPO members and MORPC with Central Ohio Greenways' Trail Town Initiative. The purpose is to develop a framework for communities along the COG trail network to identify opportunities associated with trail tourism and other active transportation benefits.
- The Madison County Thoroughfare / Access Management Plan will be completed in December.

FUNDING APPLICATIONS AND UPDATES

CORPO staff is available to assist with funding application and technical assistance.

- ❖ Safe Routes to School (SRTS) The Safe Routes to School Program provides federal funds to enable and encourage safe walking and biking to schools. SRTS can fund up to 100% of project costs and is available for any phase, including preliminary engineering, detailed design, right-of-way and/or construction. Applications are typically due between January and March. Visit https://www.transportation.ohio.gov/wps/portal/gov/odot/programs/safe-routes-srts
- Highway Safety Improvement Program (HSIP) HSIP project applications are due on January 31, 2022. ODOT encourages applicants to focus on projects that will implement proactive systemic infrastructure improvements. - ❖ HSIP Abbreviated Safety Funding Application The abbreviated HSIP application process is meant to quickly implement safety improvements at locations with a crash pattern and safety concern. Project applications are due on March 31, 2022. - CORPO Dedicated Funds Program The CORPO Dedicated Funds Program will provide funding to selected transportation projects in Central Ohio.
