**Meeting Called to Order**

The meeting was called to order at 5:30 p.m. by Chair Catherine Girves.

**Approval of February 27, 2018 Minutes**

A motion was made by Len Fisher to approve the February 27, 2018 minutes, seconded by Bill Curlis; motion passed.

**Metropolitan Planning Organization (MPO) Report**

Thea Walsh reported that DATABus received notification from ODOT that it will be receiving 5307 funds from other parts of the state that would otherwise lapse. Also, an RFQ was drafted to assist DATABus with a mission and vision project that will help facilitate future activities and growth of the agency by confirming and redefining the agency's mission through visioning exercises with members of the Delaware County Transit Board. DATABus's board will then decide upon any additional or new services.

Walsh also discussed the Downtown CPass Program, which is the program MORPC is leading with the downtown building owners to provide 45,000 bus passes to their employees. The kick-off is June 1.

Walsh noted the survey from ORDC on the state rail plan in the Ohio Passenger Rail News (furnished by Larry Robertson). She said that this is the time to share concerns with rail, including passenger rail.

- **Monthly Report – Planning and Environment**

Kerstin Carr stated that she previously reported to this committee on the insight2050 Corridor Concept Study. The study kicked off late last year and its first project working group meeting was held the last week in March, with about 50 people in attendance representing the different corridors and interest groups. Those who are part of a specific corridor are invited to attend and give input during the individual corridor meetings held throughout May. The goal is to complete this project by fall 2018.

Carr also reported that the Mid-America Trail and Greenways Conference (MATAG) will be in Columbus from May 13 – 16, 2018. MORPC is hosting this conference. Carr distributed some information on MATAG. Registrations are open until April 30 [here](#).

- Monthly Report – Data & Mapping  
Aaron Schill gave a PowerPoint presentation to update the committee on his department's work progress. The presentation is available [here](#).
- COTA Update  
Doug Arseneault from COTA announced that COTA's new president and CEO is Joanna Pinkerton, who will begin at COTA within a few weeks. He also reported that CMAX ridership is up about 14 percent. The goal is 20 percent for the first five years.

Looking further into the future, a residual with COTA's NextGen long-range study is that COTA is now doing a first-mile/last-mile study to look at some of the alternative modes that can link up with its service to provide first- and last-mile connections. This study will be ongoing until about May when COTA will produce an initial report that will go before the board in June or July for review.

COTA is sponsoring Young Professionals Week at the Columbus College of Art and Design (CCAD), which will include a roundtable meet and greet with some COTA leadership. COTA is also working on a project with CCAD called MOBILIZE, in which a group of CCAD students is going to decorate a bus during the week of April 23.

Curlis asked why COTA's board redefined its mission, spending tax dollars for something no one asked them to do. Arseneault replied that it is because mobility is changing. COTA is looking at new models of how to move people around and doing it in a more cost-efficient way. Curlis was concerned because these studies involving other modes of transportation are paid for with tax dollars. He also feels it is a duplication of efforts. Arseneault encouraged Curlis to attend a public comment meeting. Girves said that we would revisit this comment later in the meeting.

### **2020-2050 Metropolitan Transportation Plan – Performance Measure Requirements**

Maria Schaper updated the committee on the Performance Measure Requirements of the 2020-2050 Metropolitan Transportation Plan. Her presentation is located [here](#).

### **Proposed Resolutions**

- T-5-18: "Adopting Policies for Managing MORPC-Attributable Funds." Nathaniel Vogt explained the purpose of this resolution. His PowerPoint presentation is available [here](#).

Ira Weiss moved to approve Resolution T-5-18, and Curlis seconded; the motion carried.

- T-6-18: "Adopting the 2018-2021 Delaware and Franklin Counties Coordinated Plan." Claire Jennings noted that she discussed the details of this plan at last month's meeting.

Weiss moved to approve Resolution T-3-18, and Curlis seconded; the motion carried.

**Informational Items:**

- Draft FY 2019 Planning Work Program (PWP). Walsh explained the different components of the Planning Work Program – Formula-Funded Planning Program Projects (\$2.838 million), Special Studies (\$1.154 million budget), Ridesharing and Air Quality Projects (\$1.345 million budget), and Projects Undertaken by Other Entities (\$0 budget). The formula-funded projects are mandatory, and the special projects are those which MORPC chooses to undertake. MORPC is meeting with ODOT this week to discuss the draft PWP.

Bernice Cage announced that the 2018 State of the Region will be held on April 19 at the Greater Columbus Convention Center.

# Transportation Systems & Funding

## *Metropolitan Transportation Plan*

### **2018 Report Card**

MORPC staff compiled and analyzed data to report the 2018 conditions for each of the adopted objectives and measures from the 2016-2040 MTP. The data are reported in the 2018 MTP Report Card, which summarizes the status of the region in reaching established targets for each measure. The report card will be finalized and presented to CAC, TAC and Policy Committee in May.

### **2020-2050 MTP**

MORPC Data & Mapping staff continued to work on updating existing and future land use data, and began the review process with local communities. Coordination with FHWA, ODOT, and LCATS continues as MORPC staff works to implement the national Performance Measure requirements.

## *Transit, Mobility & Human Services*

### **Gohio**

The 2018 ACT Emerging Mobility Summit was held in Columbus on April 24 and 25. Great information was shared about the future of mobility. MORPC's Gohio Commute Mobility Hub was featured in one of the sessions.

A webinar to demonstrate the Gohio Commute platform and the subnetwork features of the platform was hosted with eight of Central Ohio's top companies in attendance. Further discussions are in the works to see how our system can help them start their own Transportation Demand Management benefit for their employees.

MORPC staff participated in the Green Columbus Earth day at Genova Park providing the opportunity to share information about the Gohio Commute Platform. MORPC Staff also participated in the Smart Columbus drive and rides held at Huntington Bank.

## **DATABus**

MORPC and DATABus received four responses to the RFQ for DATABus's Mission and Visioning project. A consultant has been selected from the responses and the project should start in May.

DATABus has ordered its first large (30') transit vehicle to replace a trolley. This order was made possible through a Diesel Emission Reduction Grant provided by the Ohio EPA and ODOT.

## **COTA**

The First Mile Last Mile study steering committee met and with the consultant team leading the group through an evaluation of current conditions, review of best practices and discussion of technology.

Assistance continued to COTA and the Capital Crossroads SID for the Downtown C-pass program. The ability to sign up will launch on May 1<sup>st</sup>, with the program to begin on June 1<sup>st</sup>.

## **5310 Designated Recipient**

Two vehicles were delivered to the Association of Developmental Disabilities for the 5310 program.

## ***Transportation Planning Studies***

### **Rickenbacker Study**

MORPC, in collaboration with YayBikes, is organizing an informational bike tour of the Rickenbacker study area. Study stakeholders have been contacted with potential dates in the month of May, and MORPC staff is awaiting responses. The goal of this ride is to help decision makers and those who influence them understand what is already going well and where opportunities exist to improve mobility through cycling, and to support these decision makers in determining how they might prioritize any opportunities to improve conditions for people using bikes for transportation.

Communication with study funders and stakeholders continues as MORPC staff documents the study findings and recommendations and prepares to publish the study results in June. An implementation plan that will include action items, lead parties, and cost estimates is also underway.

### **Rapid Speed Transportation Initiative**

Proposals submitted for the Hyperloop Feasibility Study and the Tier I EIS Components Study were reviewed by the proposal evaluation committee as composed by the Cities of Columbus, Marysville and Lima, ODOT, MORPC and Union County. The proposal selection committee was based on Ohio RSTI corridor partners who are funding the RSTI studies at this time. The Feasibility Study consultant has been selected with no need for consultant interviews, and AECOM will be retained for this study's execution. Contract negotiations have begun. The Tier I EIS Components Study proposals submitted were more competitive in nature, and interviews will be arranged with all three consultants who submitted proposals. Interviews will be conducted in early to mid-May.

In addition, MORPC has confirmed dates for a visit to Virgin Hyperloop One's headquarters in Los Angeles on May 17, with a visit to the DevLoop hyperloop test track in Nevada on May 18. MORPC is working with corridor partners in Indiana, Ohio, and Pennsylvania to finalize travel arrangements.

## **Central Ohio Rural Planning Organization (CORPO)**

Multiple CORPO County Subcommittee meetings were held in April. The CORPO Member County Subcommittees are currently developing project lists for the CORPO transportation plan. The next two CORPO Committee meetings have been scheduled - one on May 24 and the other on June 18. The purpose of the next two meetings is to review and adopt a recently developed 2019 Planning Work Program for CORPO and to review and adopt the CORPO transportation plan. Additional elements of the Future Considerations section of the plan are nearly complete and will be sent out for review in the coming weeks.

## **Infrastructure Funding**

### **Transportation Improvement Program (TIP)**

MORPC is coordinating with ODOT to ensure that the TIP adequately incorporates safety performance management measures. Any needed updates will be addressed with the next resolution to amend the TIP in June.

### **MORPC Attributable Funding**

MORPC approved the Policies for Managing MORPC-Attributable Funds in April. Team members are preparing an online application form, which is expected to be available after May 1. The attributable funds workshop will be held on May 14 at 2:30 p.m. Updates to previous funding commitments are due on June 4, and screening applications for new projects are due June 11.

### **TIGER/BUILD**

The passage of the federal omnibus included a large increase in the USDOT discretionary surface transportation grant program previously known as TIGER. Now rebranded as BUILD (Better Utilizing Investments to Leverage Development), the next round will be three times as large as the last cycle, with \$1.5 billion available nationally. The Notice of Funding Opportunity (NOFO) was released on April 24, 2018, and applications are due July 19, 2018. MORPC is helping to coordinate meetings among partners of Competitive Advantage Projects that may be ideal for submission to BUILD and is aware of several projects in the region that are being considered for submission.

### **ATCMTD Grant**

The third round of Advanced Transportation and Congestion Management Technologies Deployment (ATCMTD) grant funding has also been announced by USDOT, and applications are due June 18, 2018. This program provides funding to develop model deployment sites for installation and operations of advanced transportation technologies.

As a result of multiple meetings with local stakeholders in preparation for this round, MORPC coordinated a meeting in Bellefontaine to discuss the extension of the 33 Smart Mobility Corridor through Logan County and beyond to I-75. This project was identified as a Competitive Advantage Project priority by Logan County. Officials from ODOT Jobs and Commerce, ODOT Districts 6 & 7, and Logan and Auglaize counties attended and determined next steps to further explore the scope and development of the project.

### **Ohio Public Works Commission (OPWC)**

The three-year terms of office for the current members and alternates of the District 3 (Franklin County) Public Works Integrating Committee (PWIC) will expire on May 31, 2018. The Ohio Revised Code establishes the composition of the PWIC. District 3 staff has asked the appointing authorities of the county, the City of Columbus and townships to make appointments in April. The other cities

and villages are submitting ballots by April 30 to appoint two members and two alternates from seven candidates.

### **Natural Resources Assistance Council (NRAC)**

Members of the District 3 (Franklin County) NRAC have completed scoring of four final applications from three agencies requesting \$3,950,902 from the Clean Ohio Conservation Fund. The district currently has approximately \$5 million available to preserve open spaces, sensitive ecological areas, and stream corridors. The NRAC approved on April 26 all four final applications for submittal to the Ohio Public Works Commission for funding.

The NRAC will next meet in June to approve the criteria and policies for the next round of applications, for which screening applications are due in December 2018.

# Data and Mapping

## ***Regional Data Advisory Committee (RDAC)***

On March 30, the RDAC held its regular first-quarter public meeting. Items discussed included the proposed Regional Data Agenda, including a brainstorming exercise with the members.

The Smart Regional Task Force and the SmartColumbus Operating System were also discussed in detail.

Joe Garrity presented a brief overview on current legislation related to data activities.

The next Regional Data Advisory Committee meeting will be on June 8.

## ***Transportation***

Several map updates and revisions were prepared for the Central Ohio Rural Planning Organization existing and future conditions report, including mapping of traffic congestion and existing and proposed bike and pedestrian facilities.

Data & Mapping staff published a Request for Proposals to redesign the Paving the Way construction and road closure notification system. Proposals are due in early May.

Data & Mapping staff are currently working on updating the Attributable Funding Application Database, which provides an online tool for local governments and their consultants to update existing and submit new applications for MORPC-attributable transportation funding.

Data and Mapping staff continue to work on updating land use data, and population and employment projections for the upcoming (2020-2050) Metropolitan Transportation Plan (MTP).

The Data & Mapping team completed data collection and analysis for the 2018 update to the MTP Report Card for the current (2016-2040) MTP. This includes updating data such as mode split, new miles of pedestrian and bicycle facilities built, and population & employment.

Data & Mapping staff have begun storyboarding the final deliverable for the Rickenbacker Area Comprehensive Study. The final plan will be formatted as a digital story map, which will present the results in a concise, but information-rich way.

## ***Data & Mapping Support to MORPC Members, Programs and Projects***

The Smart Region Task Force continues with its regular meetings, the latest on March 29. The meeting consisted of presentations from the Union County Chamber of Commerce regarding the US 33 Smart Corridor Project and from the City of Columbus regarding SmartColumbus. Thea Walsh presented an analysis of a recent survey back to members, and Aaron Schill reported on Task Force administration, research, and structure. The next Smart Region Task Force meeting will be on May 4.

The Data & Mapping team continued work with the insight2050 Corridor Concepts Data Committee and consultants with regard to data collection, modeling, analysis, and next steps. The full Data Committee will meet in Westerville on May 1.

Early in April, the Data & Mapping team provided 2010-2017 Franklin County population counts and 2018-2023 Franklin County population projections to SWACO.

Data & Mapping staff are providing support for the insight2050 Technical Assistance program for Violet Township, attending regular meetings and performing data activities.

Data & Mapping staff completed the Central Ohio Blueways webmap for MORPC's Water Resources Working Group.

To assist with program reporting, the Data & Mapping team mapped all WarmChoice jobs completed in 2017 and aggregated the cost of work by geography.

### ***Data and Mapping Outreach and Collaboration***

MORPC's work leading development of use cases for the Smart Columbus Operating System (SCOS) continues. MORPC regularly hosts meetings with group members and shares its perspective as a regional data collector/provider. The goal of the SCOS is that it will grow into a regional open data hub that serves a broad range of users.

Aaron Schill is serving on an Urban Land Institute (ULI) task force to develop strategies and tools that support managed growth for the region that are in-line with MORPC's insight2050 efforts.

Data & Mapping staff attended an Open Data Bootcamp on April 17 hosted by the City of Columbus and presented by Johns Hopkins University and GoveEx. This day-long seminar covered strategies and best practices for encouraging open data practices in local governments.

Jason Kaper is now serving as the Data & Mapping Department representative on MORPC's Diversity & Inclusion internal working group. This group will explore ways to improve the implementation and tracking of MORPC's Diversity & Inclusion Plan.

Liz Whelan wrote articles for the State of the Region brochure and for Columbus Business First.

# Planning & Environment

## ***Active Transportation Planning***

### **Non-Motorized System Monitoring**

Team members presented Central Ohio Greenways 2017 Trail Monitoring updates to COG Forum attendees on April 3. Attendees were also provided with a general overview of the COG Monitoring Program.

Team members organized outreach materials for MORPC's spring 2018 Bike/Ped Manual Count effort taking place on May 16. Volunteers will collect count data at 30 locations throughout Central Ohio, with data informing several MORPC active transportation and transportation safety efforts.

Team members fulfilled a count data request from the City of Westerville relating to locations of interest identified through the city's pedestrian planning initiatives.

### **Complete Streets Outreach & Implementation**

Team members completed a Stage 1 and 2 Complete Streets Review of the Columbus Recreation and Parks Department's Olentangy Trail/Bethel Road multi-use path connection and trail widening project. This project will provide direct connections between Bethel Road and the Olentangy Trail via a multi-use path. The team made safety recommendations surrounding the Olentangy River Road and Bethel Road intersection, and also emphasized the need for more crossing opportunities for non-motorized users accessing the area west of Olentangy River Road.

Team members completed a Stage 2 review of the City of Columbus' Refugee Road (Winchester Pike-Hamilton Road) project, focusing on the addition of active transportation facilities along the project extent. The team shared ideas for pedestrian crossing opportunities along the corridor, recommending high-visibility crosswalk markings at signalized intersections and the addition of unsignalized crossing opportunities. Also recommended were the addition of ADA-accessible transit pads at COTA bus stops.

Team members facilitated a Complete Streets Equipment Library request placed by the Short North Alliance for the collection of pedestrian count data during the April Gallery Hop event.

## ***insight2050***

### **Outreach**

Director Kerstin Carr discussed insight2050 efforts at the April 11 CMC Lunch Panel titled "Megalopolis 2050: Building Tall" to an audience of nearly 300 people. Staff also presented insight2050 efforts as part of a panel discussion titled "Dynamic Innovation: The City-Region Partnership" at the APA National Planning Conference.

### **Technical Assistance Program**

Technical analyses are underway related to employment and industry trends (Westerville and Violet Township) and transportation network mobility and active transportation for all four of the projects (Delaware, Westerville, Worthington, and Violet Township).

## **insight2050 Corridor Concepts Study**

The Project Working Group held its first meeting and invited members of the Corridor Working Groups to attend. Over 50 participants were present to prioritize key issues across Central Ohio, reach consensus on development constraints and opportunities, and identify opportunities for improved transportation access and mobility along the corridors.

## ***Transportation Safety***

### **Assistance to Members**

Team members began the annual regional crash data analysis process, with 2017 crash data provided by the Ohio Department of Transportation (ODOT) and the Ohio Department of Public Safety (ODPS). These data will ultimately be used to inform MORPC regional crash data analysis products, including the High Crash Locations lists and State of Safety Report.

### **Participation in Local and State Safety Committees**

Team members attended the Franklin County Safe Communities Fatality Review Board meeting at Columbus Public Health. Crashes reviewed included two pedestrian fatalities, three motorcycle fatalities, and three fatalities involving unrestrained individuals.

Team members provided an overview of MORPC's Transportation Safety Program and regional crash data analysis products to the Franklin County DUI Task Force.

## ***Sustainable2050***

### **Pilot**

The MORPC team is summarizing the findings of the Sustainable2050 Program Pilot in order to provide recommendations to the Sustainability Advisory Committee (SAC) in June. The recommendations will include adjustments to membership requirements and the "Identifying Your Tier Status Checklist," as well as an estimate of expected MORPC and community team staff needed to manage and participate in the program. The recommendations will also include an estimate of additional funding needs for program management and development of tools & resources.

### **Meetings**

The Sustainable2050 Communities met on April 11. They provided initial feedback on findings from the Pilot, as well as updates on sustainability-related projects and accomplishments of their communities and organizations. The Solid Waste Authority of Central Ohio (SWACO) shared its new recycling education program: Recycle Right. SWACO is providing a toolkit to communities to help educate their residents and businesses on recycling best practices. MORPC team members shared information about the Air Quality Program and Gohio Commute as they pertain to the Sustainable2050 Communities. Both programs offer tools and resources to communities and employers to improve air quality and incentivize commuting in ways other than via a single-occupant vehicle.

## ***Greenways & Water Resources Program***

### **Water Resources Working Group**

The Water Resources Working Group (WRWG) met in March where the group received the regular policy updates, Central Ohio Watershed Council updates, and MORPC programmatic updates. The group also participated in work sessions to prioritize activities and topics for the remaining 2018 meetings, and to brainstorm activities related to implementation of the goals and objectives outlined in the Sustainable2050 program. The group also heard two special presentations on the City of Columbus BioSolids Management Program and an overview of the Ohio Scenic Rivers program, and activities associated with the 50th Anniversary of the State Scenic Rivers Act. The

Sustaining Scioto subcommittee has met twice this year and is beginning the implementation planning process as related to the short-term strategies of the Sustaining Scioto Adaptive Management Plan. The Data subcommittee is scheduled to meet in late April.

### **Participation in Local and State Committees**

Team members attended the Central Ohio Partnership for Regional Invasive Species Management (PRISM) Steering Committee to refine the goals and objectives of the group's guiding document. MORPC will be working with The Nature Conservancy to provide general planning services through the strategic planning process. The scope of this effort helps to meet goals and objectives of the Water Resources Working Group 2016-2020 Action Plan.

Team members attended the Natural Resources Assistance Council site visits and scoring session meetings, which determine distribution of Clean Ohio conservation funding for conservation, greenspace, and stream corridor protection in Franklin County.

# Energy & Air Quality

## ***Air Quality***

Forecasting for ozone and particulate matter air pollution continues daily from March 1 to October 31. No Air Quality Alerts were issued during the month. Forecasted and observed levels for both pollutants remained in the good to low-moderate range.

Submissions to an RFQ for media services for the summertime 2018 Air Quality Awareness campaign were received by air quality staff, and a review of the submissions is proceeding. Staff also developed a social media plan addressing themes for Air Quality Awareness Week, which takes place April 30 – May 4. The goal is to promote messages or events that increase awareness and inspire people to take actions to reduce air pollution. Members are encouraged to check MORPC's Facebook and Twitter feeds April 30 – May 4 and share/retweet messages about air quality.

Air Quality team members are developing a partnership with educators at Dempsey Middle School in Delaware, Ohio for an educational Idle-Free pilot to educate students on the health impacts of air quality and to increase awareness of the source of air pollution that idling vehicles near schools poses.

Air quality staff completed the 2017 City of Columbus Greenhouse Gas Inventory. A final report with the resulting inventory was delivered to city staff to support reporting to the Carbon Disclosure Project (CDP) in compliance with Columbus' membership in the Global Covenant of Mayors for Climate and Energy.

Air quality staff also finalized an analysis of available air quality data for Ross County to include both cancer and respiratory risks and shared the results with the Ross County Air Quality Subcommittee. The Ross County Air Quality Subcommittee was formed as a result of the outcomes of the Ross County Community Health Needs Assessment. Due to identified high rates of lung cancer and respiratory disease in Ross County, members of the partnership who completed the assessment decided to form a subcommittee focused on determining potential opportunities to assess air quality and its health impacts on the community. MORPC staff worked with consultants at Sonoma Technology, Inc. to provide an analysis of existing air quality data for Ross County to inform the Subcommittee's plans.

## ***Energy & Air Quality Working Group***

A meeting of the Energy and Air Quality (E&AQ) Working Group was held on March 27. The agenda included a presentation by Dr. Andrew May on use of low-cost air quality sensors for education and monitoring programs at local schools and an update from the E&AQ Working Group Review Committee.

The E&AQ Working Group Review Committee meets again on April 16. Over the next few months, this group will engage in a process to establish priorities that are shared among the members and aligned with MORPC's existing work toward the Regional Sustainability Agenda goals and objectives. Staff presented on the history of MORPC working groups and working group reorganization processes. At the next meeting, Review Committee members will discuss the potential scope of regional energy and air quality issues for the Energy and Air Quality Working Group and how to prioritize them.

### ***Alternative Fuels/Electric Vehicles***

EAQ staff continues to work with Smart Columbus, Clean Fuels Ohio and the Electrification Coalition regarding their continued efforts to increase public fleet Electric Vehicle procurement. MORPC currently plays an advisory and outreach role with regard to member governments.

### ***Local Government Energy Partnership***

MORPC continues to enroll local governments identified in the beta-group for the energy benchmarking program in partnership with JadeTrack. All of the members from this group are expected to be enrolled in this process by June. MORPC will also host a training session for this group. The focus is currently on energy benchmarking for local government buildings, and over time MORPC will be incorporating other sustainability metrics into the tracking, including fleet fuel consumption. EAQ staff also continues to work on expanding the future offerings of the Local Government Energy Partnership.

### ***Franklin County Energy Study***

EAQ staff will meet with Commissioner O'Grady in May to review the recommendations resulting from the Franklin County Energy Study. Once this meeting occurs we will conclude our meetings with the County Commissioners and take the recommendations to the full Advisory Committee in May for final approval. EAQ staff will brief key stakeholders in the process and coordinate the announcement and communications strategy with the county.

Annually, MORPC submits a Planning Work Program (PWP) that outlines the work of the MPO, the use of regional transportation planning funds, and the regional planning activities that will be undertaken in the coming year. The PWP outlines MORPC's annual scope of work with ODOT using federal planning dollars. The total Fiscal Year 2019 budget of all work elements is \$6,276,947. The work elements of the PWP as shown in the summary attached to the resolution (T-7-18) are divided into four sections:

- 1) Formula-Funded Planning Program Projects (total budget of \$2,938,203) for SFY 2019)  
This includes work elements related to the core federally required planning activities. These touch on all areas including active transportation planning, safety planning, the Transportation Improvement Program, transportation data and analysis, the Metropolitan Transportation Plan and member and public involvement and education. The funding includes an estimated \$100,000 carried over from SFY 2018.
- 2) Special Studies (total budget \$1,993,744 for SFY 2019 or later)  
These are special studies completed with funding outside of the core planning funds. These include work elements related to the Rapid Speed Transportation Initiative, Regional Corridor Analysis, insight2050 Technical Assistance, Paving the Way, supplemental planning and 5310 designated recipient for enhanced mobility of seniors and individuals with disabilities programs.
- 3) Ridesharing and Air Quality Projects (total budget is \$1,345,000 for SFY 2019)  
This includes transportation services related to Ridesharing (Gohio) and Air Quality Awareness activities.

**“Certification of the MORPC Metropolitan Transportation Planning Process”**

WHEREAS, the Transportation Policy Committee of the Mid-Ohio Regional Planning Commission is designated as the metropolitan planning organization (MPO) for the Columbus Urbanized Area; and

WHEREAS, 23 CFR 450.334 requires that the state and MPO certify, at least every four years, that the transportation planning process is being carried out in accordance with all applicable requirements, including:

- (1) 23 U.S.C. 134 and 49 U.S.C. 5303 (Metropolitan Transportation Planning requirements);
- (2) Sections 174 and 176(c) and (d) of the Clean Air Act, as Amended (42 U.S.C. 7504, 7506 (c) and (d) and 40 CFR part 93;
- (3) Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. 2000d-1) and 49 CFR part 21;
- (4) 49 U.S.C. 5332, prohibiting discrimination on the basis of race, color, creed, national origin, sex or age in employment or business opportunity;
- (5) Section 1101(b) of the FAST-Act (Pub. L. 114-94) and 49 CFR part 26 regarding the involvement of disadvantaged business enterprises in USDOT-funded projects;
- (6) 23 CFR part 230, regarding the implementation of the equal employment opportunity program on federal and federal-aid highway construction contracts;
- (7) The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) and 49 CFR parts 27, 37 and 38;
- (8) The Older Americans Act, as amended (42 U.S.C. 6101) prohibiting discrimination on the basis of age in programs or activities receiving federal financial assistance;
- (9) Section 324 of Title 23 U.S.C. regarding the prohibition of discrimination based on gender; and
- (10) Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and 49 CFR part 27 regarding discrimination against individuals with disabilities; and

WHEREAS, this “self-certification” is separate from the MPO certification done by the Federal Highway Administration and Federal Transit Administration, which was last conducted at MORPC in 2014; and

WHEREAS, as a prerequisite to the receipt of federal financial assistance (per 49 CFR Subtitle A, Section 21.7), MORPC is required to provide the Title VI Assurances included in Attachment A; and

WHEREAS, the Community Advisory Committee at its meeting on April 30, 2018 and the Transportation Advisory Committee at its meeting on May 2, 2018 recommended approval of this resolution by the Transportation Policy Committee; now therefore

**BE IT RESOLVED BY THE TRANSPORTATION POLICY COMMITTEE OF THE MID-OHIO REGIONAL PLANNING COMMISSION:**

- Section 1. That it certifies that the urban transportation planning process is carried out in conformance with all the applicable federal requirements to the degree that is appropriate for the size and complexity of the area.

**PART 1**  
**STANDARD DOT TITLE VI ASSURANCES**

The Mid-Ohio Regional Planning Commission (MORPC) hereby agrees that as a condition to receiving Federal financial assistance from the Department of Transportation (DOT), it will comply with Title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d et seq.) and all requirements imposed by 49 CFR Part 21 - Nondiscrimination in Federally Assisted Programs of the Department of Transportation - Effectuation of Title VI of the Civil Rights Act of 1964 (hereinafter referred to as the "Regulations") to the end that no person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which MORPC receives Federal financial assistance and will immediately take any measures necessary to effectuate this agreement. Without limiting the above general assurance, MORPC agrees that:

1. Each "program" and "facility" (as defined in Sections 21.23(e) and 21.23 (b)) will be conducted or operated in compliance with all requirements of the Regulations.
2. It will insert the clauses of Part 2 of this assurance in every contract subject to the Act and the Regulations.
3. This assurance obligates MORPC for the period during which Federal financial assistance is extended to the program, except where the Federal financial assistance is to provide, or is in the form of personal property or real property or interest therein or structures or improvements thereon, in which case the assurance obligates MORPC or any transferee for the longer of the following periods:
  - (a) the period during which the property is used for a purpose for which Federal financial assistance is extended, or for another purpose involving the provision of similar services or benefits, or
  - (b) the period during which MORPC retains ownership or possession of the property.
4. It will provide for such methods of administration for the program as are found by the Secretary of Transportation or the official to whom (s)he delegates specific authority to give reasonable guarantee that it, other sponsors, sub-grantees, contractors, subcontractors, transferees, successors in interest, and other participants or Federal financial assistance under such program will comply with all requirements imposed or pursuant to the Act, the Regulations, and this assurance.
5. It agrees that the United States has a right to seek judicial enforcement with regard to any matter arising under the Act, the Regulations, and this assurance.

THIS ASSURANCE is given in consideration of and for the purpose of obtaining Federal financial assistance for this Project and is binding on MORPC, its contractor, subcontractors, transferees, successors in interest and other participants in the Project. The person whose signature appears on this resolution is authorized to sign this assurance on behalf of MORPC.

**PART 2**  
**CONTRACTOR CONTRACTUAL REQUIREMENTS**

During the performance of this contract, the contractor, for itself, its assignees and successors in interest (hereinafter referred to as the "contractor") agrees as follows:

1. **Compliance with Regulations.** The contractor shall comply with the Regulations relative to nondiscrimination in federally assisted programs of the Department of Transportation (hereinafter "DOT"), Title 49, Code of Federal Regulations, Part 21, as they may be amended from time to time (hereinafter referred to as the "Regulations"), which are herein incorporated by reference and made a part of this contract.
2. **Nondiscrimination.** The contractor, with regard to the work performed by it during the contract, shall not discriminate on the grounds of race, color, or national origin in the selection and retention of subcontractors, including procurements of materials and leases of equipment. The contractor shall not participate either directly or indirectly in the discrimination prohibited by Section 21.5 of the Regulations, including employment practices when the contract covers a program set forth in Appendix B of the Regulations.
3. **Solicitations for Subcontracts, including Procurements of Materials and Equipment.** In all solicitations either by competitive bidding or negotiation made by the contractor for work to be performed under a subcontract, including procurements of materials or leases of equipment, each potential subcontractor or supplier shall be notified by the contractor of the contractor's obligations under this contract and the Regulations relative to nondiscrimination on the grounds of race, color, or national origin.
4. **Information and Reports.** The contractor shall provide all information and reports required by the Regulations or directives issued pursuant thereto and shall permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the Mid-Ohio Regional Planning Commission (MORPC), the Ohio Department of Transportation (ODOT), or DOT to be pertinent to ascertain compliance with such Regulations, orders, and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish this information, the contractor shall so certify to MORPC, ODOT or DOT, as appropriate, and shall set forth what efforts it has made to obtain the information.
5. **Sanctions for Noncompliance.** In the event of the contractor's noncompliance with the nondiscrimination provisions of this contract, MORPC shall impose such contract sanctions as it, ODOT or the DOT may determine to be appropriate, including, but not limited to:
  - a. Withholding of payments to the contractor under the contract until the contractor complies, and/or
  - b. Cancellation, termination, or suspension of the contract, in whole or in part.
6. **Incorporation of Provisions.** The contractor and subcontractor(s) shall include the provisions of paragraphs 1 through 5 in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Regulations or directives issued pursuant thereto. The contractor and subcontractor(s) shall take such action with respect to any subcontract or procurement as MORPC, ODOT or DOT may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, however, that in the event a contractor or subcontractor(s) becomes involved in, or is threatened with, litigation with a subcontractor or supplier as a result of such direction, the contractor or subcontractor(s) may request MORPC or ODOT to enter into such litigation to protect the interests of MORPC or ODOT and, in addition, the contractor may request the United States to enter into such litigation to protect the interests of the United States.
