### **Question 1**

Since the scope of work does not include signage design, are you expecting a general design for how the strategy would be implemented on the Ohio to Erie Trail?

#### **Answer 1**

An entirely new signage design is not expected; however, we encourage the detailed example/case study as requested in Part 2 of the scope to include recommendations for how existing signage may be modified along the Ohio to Erie Trail to implement the recommended wayfinding strategy.

## **Question 2**

What is the length of the Ohio to Erie trail where the data will be collected, and the strategy applied?

#### Answer 2

The Ohio to Erie Trail within Madison, Franklin, Delaware, and Knox Counties is approximately 100 miles. Smaller locally known trails follow the same route as the Ohio to Erie Trail.
