TSI Overview

- Transit supportive infrastructure
 - Increase non-motorized access to transit stops
 - Facilitate improved transit service
- Subset of overall LinkUS program
 - TSI Capital Improvement Program
 - Governed by TSI Committees



TSI Activities to Date

- Regional outreach with jurisdictions (Jan 2022 – July 2022)
- Regional TSI workshops (June/July 2022)
- ORC language revised allowing COTA to fund TSI projects (HB 338)
- Established framework for TSI Committees, program management agreements
- Developing guiding principles for program policies and guidelines

June 9th TSI Workshop

- Regional stakeholder workshop
- Informal precursor to formal convening of TSI Committees later this summer
- Focused on identifying parameters to build the program
 - TSI definition, project eligibility, phases
 - Funding categories, limits, and uses

Upcoming Regional Engagement

- Next round of engagement begins June 2023
- Multiple opportunities to understand local goals for LinkUS
 - TSI program development
 - Corridors 4 and 5 identification
 - Transit-oriented development (TOD) and zoning
 - Local CIPs

- Increase capacity and/or reduce congestion
- Proves to support jobs and/or job creation

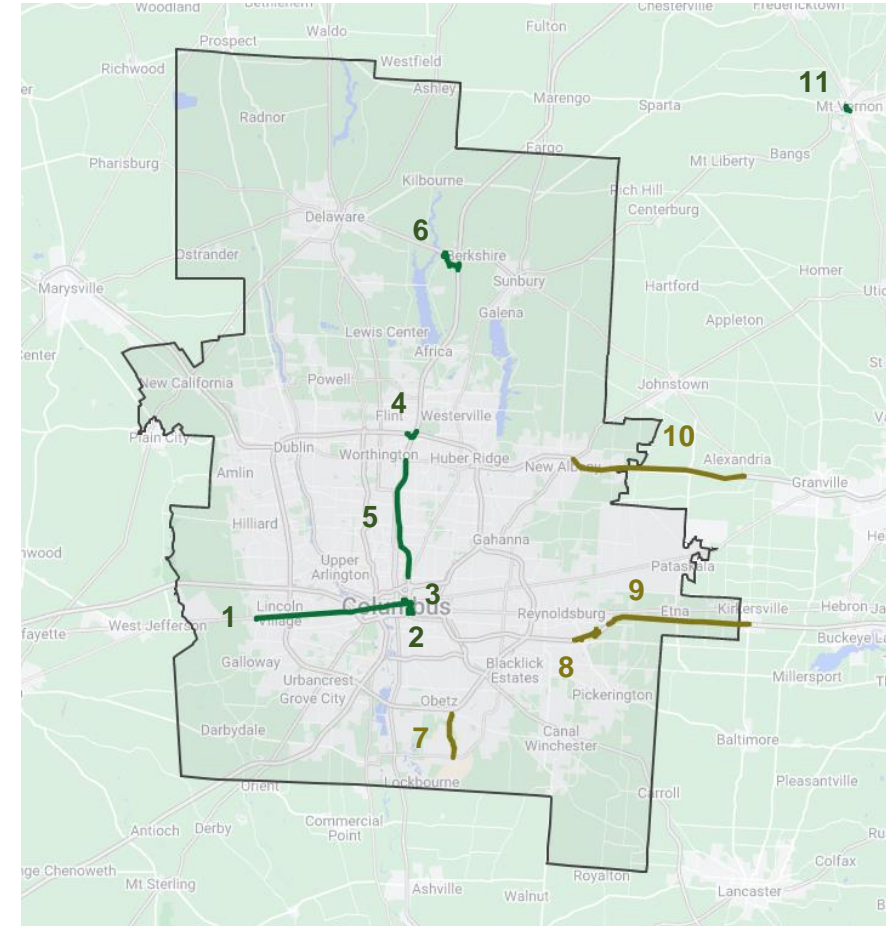
