


Pedestrian Crashes and Fatality Data



- The percentage of pedestrian deaths almost doubled between 2018 to 2020 (8.7% and 15.6% respectively).
- During 2021, there were 259 crashes and 61% (158) of the crashes were either fatal or incapacitating
- The average age of the pedestrian struck in Marion County during 2021 was 37 years old with a range of 2-87. However, a quarter (25%) of people struck were between the ages of 51-70.

Pedestrian Crashes and Fatality Rates 2010-2021



Public Transit



- May 2023 saw the second highest rate of ridership since the onset of the COVID-19 pandemic in March 2020. Usage was up just over 50,000 passengers compared to May 2022.
- Ridership in June and July of 2023 has gone down slightly by about 40,000 passengers, but has remained consistent.






Transportation Access



- An estimated 12,200 Black households are without a car and live outside hightransit neighborhoods, compared to 8,200 White households.
- Nationally, we know that pedestrians in lowerincome areas are struck and killed at higher rates.





Estimated percent of households with no vehicle access and living outside high-transit neighborhoods. White is White alone, not Hispanic or Latino. Black is Black alone, not Hispanic or Latino. Hispanic or Latino can be of any race with that ethnicity.

Solutions



- Updated Ten-Year Old Complete Streets Ordinance
 - Built 100 miles of bike lanes
 - 43 miles of new or rehabilitated trails
 - 1 million linear feet of sidewalks
 - More than 3,000 new or rehabilitated crosswalks



Solutions



- Ordinance Updates include:
 - Now applies to city projects and private developers, and virtually everyone else (e.g. IndyGo)
 - Performance metrics (e.g. projects that are within ½ mile of a school and the % located in underserved neighborhoods) reported publicly
 - Created the Fatal Crash Review Commission








- Four pedestrian deaths at this location, last 24 months
