Gohio Commute

Four new vanpools joined the MORPC Vanpool Program. Team Members met with companies interested in forming vanpools. Gohio ran a marketing campaign on social media focusing on vanpooling and carpooling.

Active Transportation Planning

MORPC participated in the City of Columbus Bike Plus Plan Open House for stakeholders on March 18. Team Members provided information regarding critical cross-jurisdictional connections for the consultant team and City staff to consider in their network planning process.

The next Active Transportation Committee meeting is May 22, 10 a.m.-Noon.

MORPC hosts virtual group viewings of the Association of Pedestrian and Bicycle Professionals (APBP) monthly Professional Development webinars. The webinars are eligible for 1.0 hour of American Institute of Certified Planners (AICP) Certification Maintenance credit. Transportation Safety

The Ohio Traffic Safety Office is hosting the first annual Ohio Traffic Safety Summit in Columbus, May 20-21. This is a great opportunity to hear from engaging speakers, participate in workshops, share resources and ideas, and network with colleagues from around the state. Registration is free. Technical Assistance Program

Team Members hosted workshops with Jefferson Township and Franklin Township. Key community stakeholders and regional partners joined MORPC and the townships to discuss existing conditions and needs related to infrastructure for pedestrians and bicyclists in the townships.

Central Ohio Greenways (COG)

The COG Board met March 27 and heard project updates and working group progress. The COG Trail Towns Working Group met March 11 to discuss implementation of the COG Trail Town Framework.

The Outdoor Trails Pass partnership with Experience Columbus is upgraded with new features every Spring. This Spring local tourism groups submitted trail itineraries that include stops at trail side businesses, restaurants, and cultural amenities. These new curated experiences will be highlighted in the 2024 Outdoor Trails Pass, launching on Celebrate Trails Day, April 27, at Genoa Park.

MORPC is convening the COG Trail Closure and Detours Steering Committee in the Spring to develop guidelines for managing and communicating trail closures and detours. The committee will meet monthly for six months.

MORPC hosted a COG Forum on March 20 bringing together nearly 100 trail planners, advocates, elected officials, and government staff to learn about regional projects that are going beyond basic trail infrastructure to provide an enjoyable and comfortable trail user experience.

MORPC submitted an application to the federal Rebuilding American Infrastructure with Sustainability and Equity (RAISE) program for a project called Trail Towns in the Nation's Heartland. This project will expand the Regional Trail Vision to 15 counties and design trail town elements in three communities. The proposal is a partnership with Buckeye Trail Association, the Village of Buckeye Lake, the City of Mount Vernon, and the Ohio to Erie Trail Board.

MORPC is considering an application to the federal Active Transportation Infrastructure Investment Program (ATIIP) – due in June. The proposal will expand bikeways and trail planning in the region.

Central Ohio Blueways

The Central Ohio Blueways Steering Committee postponed their meetings until May while Steering Committee Members were contacted regarding the timing and their other commitments. The initial meeting will focus on the development of an official mission and vision for Central Ohio Blueways. Members will also consider the development of working groups to focus on components of Central Ohio Blueways which are more pertinent to Members' organizational interests. Working Groups are anticipated to include Water Trail Designation, Water Stewardship, and User Experience.

Regional Housing Strategy

Conversations around housing issues continue with MORPC member communities. Team Members continue to promote the identification of barriers and solutions related to housing for members through connections with MORPC's Community Assistance Programs and by giving presentations to councils and other organizations. MORPC is also involved in national conversations surrounding the housing crisis to learn how peer organizations are approaching housing issues.

Are you interested in a housing/growth workshop for your community's elected officials, staff, or community leaders? MORPC is accepting requests for presentations and workshops. Sustainability Advisory Committee (SAC)

The Sustainability Advisory Committee met March 20. The SAC heard updates on the Climate Pollution Reduction Grant, the Regional Sustainability Agenda, and discussed sustainability-focused educational videos. Team Members completing member appointments for 2024. The next meeting is June 5.

Sustainable2050

Sustainable2050 membership and tier status certification is open to MORPC members. Contact Brandi Whetstone at <u>bwhetstone@morpc.org</u> if interested in earning tier status certification. A certification workbook will be provided, and a kick-off meeting is encouraged to review the process. The deadline for completed workbooks is May 3 to be considered at the June Sustainability Advisory Committee meeting. The next Sustainable2050 meeting is May 9.

Sustaining Scioto Board

Team Members are creating a GIS data layer for the 208 water resources planning. The GIS data layer shows facility planning boundaries and additional details, such as the designated management agencies responsible for the collection and treatment of wastewater in the 10-county area.

The Agricultural & Rural Communities Outreach Team met March 28.

Energy & Air Quality

The Energy and Air Quality Working continues to recruit candidates interested in serving as either Chair or Vice-Chair. Email recommendations to Brian Filiatraut, <u>bfiliatraut@morpc.org</u>, MORPC's Energy and Sustainability Program Manager. The next meeting is May 22.

MORPC'S 2022-2023 End of Season Air Quality Report released March 4, can be found <u>here</u>. Air quality was worse in the 2022-2023 season compared to the previous year, primarily due to the influence of external wildfire smoke. While there is some variation year-to-year due to weather and external factors, overall, air quality continues to improve, and the region is in attainment with federal standards.

A recent report by IQ Air again claimed that Columbus has the worst air quality of the major cities in the United States. This claim is inaccurate and inconsistent with official data from Ohio EPA's regulatory air monitors. In addition, the report also identified Grove City as having worse air quality than Columbus – this is also misleading. The Sustainability team investigated these claims, and the report appears to be based on two PurpleAir sensors. One of the sensors was malfunctioning during the analysis period, and the other is located at a school. School buses and drop off traffic could impact the readings of that second sensor. Industry best practices do not recommend drawing conclusions from one sensor to characterize an entire community.

Neighborhood Air Monitoring Project/U.S. EPA Project

Team Members continue to move forward the U.S. EPA funded air monitoring project working in partnership with Franklin County Public Health. MORPC is collocating 40 PurpleAir sensors with Ohio EPA monitors to test and validate their performance before placing them in the community. MORPC hosted the March 15 Project Advisory Committee meeting.

Climate Pollution Reduction Grant (CPRG)

MORPC continues to collaborate with the City of Columbus and the rest of the core project team to lead regional planning and pollution mitigation actions. The regional efforts are informed by the CPRG Strategy Subcommittee, which met in February. The first deliverable of the planning grant, submitted by the March 1 deadline, was the Priority Climate Action Plan (PCAP). The City of Columbus and MORPC Teams are putting forward a proposal for the Phase Two implementation grant integrating key elements of the LinkUS West Broad Street Mobility Corridor with the Regional Community Energy Strategy (ReCES). ReCES will provide solar installations on publicly owned buildings throughout the 10-county Columbus Metropolitan Statistical Area. The application was submitted by April 1.

Regional Data Advisory Committee (RDAC)

RDAC Met April 2. Their focus this year is on the areas of Workforce & Job Quality; Diversity, Equity & Inclusion; Cyber Security; and Regional Data Coaches projects and initiatives.

- Data Day Working Group: Data Day was February 7 and was a success, being sold out for the second year in a row. Post-event survey respondents rated the event at a 4.31 out of 5. Respondents also provided feedback for improvement in 2025 which includes a larger facility, dedicated networking spaces, and more refreshments available throughout the day. The Data Day Working Group reviewed attendee feedback and is planning for Data Day 2025.
- The Regional Information & Data Group (RIDG): RIDG met March 6. The meeting focused on data around the historic, current, and the projected future state of housing in Central Ohio. Bill LaFayette and Ethan Hug provided presentation. The tentative dates for the RIDG Steering Committee (SC) meetings and general RIDG meetings are: SC April 8, July 9, and October 8; General May 29, August 14, November 13.
- Central Ohio GIS User Group (COGUG): The next meeting is May 15.
- DEI & Data Working Group: The group met in March to begin outlining the key aspects of a proposed DEI & Data workshop for later this year. Group members will report on proposed rubrics recommended to facilitate what is expected to be a wide range of stakeholders and types of data sets.
- Cyber Security Working Group: The group met in March for the second time and added two new members. The group will assemble documentation from a host of state, higher education, and federal agencies around cybersecurity best practices, programs, and services. During the next meeting, the group plans to consider how to compile the information into a singular document and presentation best suited for educating local government stakeholders.

Data & Research Activities

Team Members began developing the MORPC Insights platform. Insights is a web application whose purpose is to improve access to a curated set of data and analyses from MORPC, and eventually from our partners. The platform includes data on a variety of topics summarized at the regional, county, and community levels. Team Members are developing the platform in three phases. Phase 1 focuses on extracting more value from and improving access to MORPC's primary data products. Phase 2 focuses on derivative data products that highlight trends, patterns, and relationships between, within, and among those primary data products. Phase 3 focuses on engagement with our external partners and highlighting their data products. MORPC hired a dedicated Data Management Intern to exclusively assist with this product, thanks to a grant from The Columbus Foundation.

Staff created a two-step pipeline for retrieval and standardization of data from the American Community Survey (ACS) to help streamline the implementation of workflows relying ACS data.

MORPC produced the Leaders Listen: Housing Survey – the third in the series. Working with Measurement Resources Company (MRC) and The Columbus Dispatch, Team Members collected over 1,600 responses from residents across 140 zip codes. The survey concluded March 22. MORPC presented the preliminary survey results at the 2024 State of the Region along with other key insights derived from the comprehensive analysis of recent Census data. Team Members are producing an "Actionable Insights" report to share the results with Central Ohio stakeholders in the coming months.

Team Members are developing county-level forecasts of households/housing by type to better predict future housing needs. This is an extension to existing county forecasts for households and housing in general. Household types may include people living alone, two or more working-age adults with children, families with children, and adults of retirement age. Housing types may include attached housing, single-family small lot, and single-family large lot.

Mapping Activities

The ESRI User Conference accepted MORPC's proposal on our Active Transportation Bike & Pedestrian network. Team Members will attend the July conference.

Team Members created a Central Ohio Greenways map to include in the new Franklin County Engineer's County Road Map.

Diversity, Equity & Inclusion

MORPC partnered with COMTO Columbus to host a panel conversation, *Reimagining an Inclusive Equitable Future in Transportation*. COMTO Columbus is known as "The voice of equity in transportation."

DRIVE INVESTMENT

Metropolitan Transportation Plan

Team Members posted the Draft Metropolitan Transportation Plan (MTP) on MORPC's website. MORPC hosted an MTP Open House March 19. Staff continue to present MTP updates to communities. On schedule to present the final MTP for adoption at the May Commission Meeting.

Comprehensive Economic Development Strategy (CEDS)

Team Members interviewed seven peer MPOs with Economic Development Districts (EDDs) to gather insights on how other organizations structured their EDD Governing Boards and CEDS committees. The U.S. Economic Development Administration (EDA) is reviewing the proposed framework.

MORPC is working with the Village of Alexandria in Licking County on a proposed project to be discussed with the United States Department of Agriculture – Rural Development programs.

LinkUS Mobility Initiative

The Transit Supportive Infrastructure (TSI) Committees continue to meet to identify priority projects and work towards a regional TSI capital improvement program. LinkUS partner agencies continue to meet with local and regional stakeholders to share status updates on LinkUS activities.

Passenger Rail

MORPC continues to work with the Ohio Rail Development Commission (ORDC), the City of Fort Wayne, and the Southwestern Pennsylvania Commission (SPC) to begin planning for two routes through Central Ohio as part of the Federal Railroad Administration (FRA)'s Corridor Identification and Development Program. MORPC also continues to engage with the FRA on evaluating the potential for additional longdistance passenger rail routes going through our region.

Mobility Management

Team Members attended transportation advisory committees in Fairfield County, Licking County, and Union Counties. Staff presented and facilitated a conversation on Mobility Planning for older adults with Village Connections. MORPC attended the American Society on Aging Conference and presented alongside the Age Friendly Innovation Center (AFIC) on the Regional Mobility Plan, Mobility Planning, and collaborative work with AFIC.

Central Ohio Rural Planning Organization (CORPO)

A draft of the CORPO Safety Action Plan was posted on the <u>MORPC website</u> for public comment. The plan identifies the most significant roadway safety concerns and establishes specific strategies and action items for implementation to address the identified roadway safety issues. The goal of this plan is to develop a

holistic, well-defined approach to prevent fatal and serious injury crashes in the seven CORPO counties. Completion of the Safety Action Plan will make local agencies within the CORPO planning area eligible to apply for implementation funds through the Safe Streets and Roads for All (SS4A) program. The public comment period is open through Friday, April 19, 5:00 p.m. The CORPO Committee will consider final approval of the Safety Action Plan at their May 6 meeting.

MORPC-Attributable Funding

Team Members made no additional changes to the Policies for Managing MORPC-Attributable Funds based on comments received during the public comment period. The policies will be presented for adoption in the May transportation meetings.

Ohio Public Works Commission (OPWC)

The District 3 Public Works Integrating Committee began discussing potential modifications to the District's Evaluation Methodology in advance of soliciting applications for SFY 2026 State Capital Improvements Program (SCIP) and Local Transportation Improvement Program (LTIP) funding.

Transportation Review Advisory Council (TRAC)

TRAC approved the 2024-2027 Major New Construction Program at its February 28 meeting. A total of \$127 million in new commitments were awarded to 18 projects. Of these, seven projects in Central Ohio received \$63 million in new funding.

Applications for new commitments for the 2025-2028 program are expected to open in May.

Federal Competitive Programs

The United States Department of Transportation (U.S. DOT) announced awards for their Strengthening Mobility and Revolutionizing Transportation (SMART) grant program. MORPC supported three applications in Central Ohio and partnered with The Ohio State University to apply. No awards were in MORPC's region.

The Central Ohio Transit Authority (COTA) announced they will receive a \$42 million grant award from U.S. DOT from their Reconnecting Community Pilot Program, Neighborhood Access, and Equity grant program. MORPC was identified as a Partner in this application and worked with COTA and the City of Columbus to submit the grant application.

The Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant program, administered by U.S. DOT, concluded February 28. MORPC supported four applications from Central Ohio and submitted one;

- MORPC: Requested \$1.58 million in planning funds to study trail, and trail town development throughout Central Ohio.
- City of Columbus: Requested \$12 million in construction funds to develop the Linden Greenline.
- Franklin County Engineer's Office: Requested \$25 million in construction funds to develop Alum Creek Drive from I-270 to Rickenbacker International Airport.
- City of Heath: Requested \$2.5 million in planning funds to study the development of the Thornwood Drive Corridor.
- City of Lancaster: Requested \$800,000 in planning funds to study the development of their Eastside Industrial Park Connector project.

MORPC submitted our first grant as an Economic Development Administration (EDA) Economic Development District. The application was submitted to the EDA's Partnership Planning Grant program. The award will support the implementation of the Comprehensive Economic Development Strategy (CEDS).

U.S. DOT announced the release of their Prioritization Process Pilot Program (PPPP) in late February. Team Members met internally to discuss how this program can support Metropolitan Planning Organization (MPO) activities and strategized on the creation of a competitive application.

Brownfield Assessments

An update from the U.S. Environmental Protection Agency on MORPC's 2024 Brownfield Assessment application is expected April-May 2024.

Clean Ohio Conservation Fund

The Clean Ohio Conservation Fund has approximately \$5 million available for FY 2025. Preliminary screeners are encouraged and due June 3. Final applications are due August 30. Residential Services

Team Members are on target to meet Home Weatherization Assistance Program (HWAP) goals. Zero compliance issues were found, and zero actions were recommended following the recent HWAP Technical Monitoring. Team Members are streamlining the intake process using the Neighborly software system.

MORPC is shifting from the Information Management System (IMS) to new software for WarmChoice. WarmChoice applications are down.

Lead safe grant work begins in April. The Affordable Housing Trust grant for mold remediation is in review. Teams Members continue discussions with ECDI concerning an expedited contractor payment proposal.

SUBJECT: Draft State Fiscal Year (SFY) 2025 Planning Work Program (PWP) Summary

Annually, MORPC prepares a Planning Work Program (PWP) that outlines the work of the metropolitan planning organization (MPO), the use of regional transportation planning funds, and the regional planning activities that will be undertaken in the coming year. The PWP constitutes MORPC's annual scope of work with ODOT using federal planning dollars. The draft PWP was submitted to ODOT on March 8, 2024. This memo and the attachment provide a summary of the full PWP draft. The full draft document is available in the PWP section of our website, https://www.morpc.org/programs-services/planning-work-program-pwp/ Any comments can be directed to me, Nick Gill at ngill@morpc.org. The final SFY 2025 PWP will be adopted during the May meeting cycle.

The total Fiscal Year 2025 budget of all work elements is approximately \$8,504,760 to be spent in SFY 2025 or later. The work elements of the PWP as shown in the summary attached are divided into four sections:

- 1. Formula-Funded Planning Program Projects (total budget \$4,762,431 for SFY 2025)
 - This includes work elements related to the core federally required planning activities. These touch on all areas including Management & Operations, Transit & Human Services Planning, Metropolitan Transportation Plan, Active Transportation Plan, Transportation Improvement Plan, Public Involvement, Regional Strategic Initiatives (insight2050, housing, trail planning, Rapid5), as well as work related to data, mapping, and modeling.
- 2. Special Studies (total budget \$3,757,329 for SFY 2025 or later)

Meeting Called to Order – Chris Amorose Groomes (City of Dublin), MORPC Chair

Chair Chris Amorose Groomes called the Transportation Policy Committee Meeting to order at 2:15 p.m.

<u>Metropolitan Planning Organization (MPO) Report</u> – Parag Agrawal, MORPC Chief Mobility & Infrastructure Officer & Senior Director of Programming

Parag Agrawal presented the <u>Metropolitan Planning Organization Report</u>. Mr. Agrawal reported the Metropolitan Transportation Plan (MTP) is one of the most important documents MORPC puts together. It is a vision of transportation over the next 25 years. The 2024-2050 MTP plans for \$35 billion of investments. It includes \$15 billion in transit and \$2 billion in stand-alone bicycle and pedestrian facilities. It funds 600 regional projects. Team Members are meeting with communities to share the plan. The MTP will be presented to the transportation committees in May for adoption. Nick Gill is giving an extensive presentation later in today's meeting.

The Transportation Improvement Program (TIP) amendment on the consent agenda is an administrative amendment. No activities are being added or deleted, just adjusting funding sources.

MORPC is working with communities to bring in more federal and state grants to the region. Five Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grants were submitted from the region this year totaling \$42 million. Award announcements are expected in June.

Mr. Agrawal gave an update on LinkUS activities. The March 6 CMC Luncheon featured LinkUS. The Advisory Council meets March 27. The Transit Supportive Infrastructure Committees continue to meet regularly. Maria Schaper is the MORPC Project Manager for LinkUS.

<u>2024-2050 Metropolitan Transportation Plan Update</u> – Nick Gill, MORPC Transportation Study Director

Nick Gill presented the <u>2024-2050 Metropolitan Transportation Plan Update</u>. The Metropolitan Transportation Plan (MTP) is the long-range transportation vision for the Metropolitan Planning Organization (MPO) and is updated every four years. Mr. Gill shared the 2024-2050 MTP development timeline:

- November 2022 adopt goals (Resolution T-15-22)
- February 2023 adopt measurable objectives (Resolution T-1-23)
- 2023 develop strategies to achieve goals
 - o Begin with population estimates for regional and county levels
 - Refine estimates to determine where growth will occur (traffic analysis zone level forecasts)
 - Receive feedback from communities
 - Strategies are about maintaining current systems and expanding the transportation systems

- September 2023 adopt 2050 forecast household and employment variables (Resolution T-15-23)
- Interactive web map of specific projects
 - o 174 additional projects suggested by the public
 - o 1,052 comments received

 - Project evaluation process related to the adopted goals
 - Public comment period
- Draft MTP <u>www.morpc.org/mtp</u>

Executive Director's Report – William Murdock, MORPC Executive Director

William Murdock welcomed members to the March Pi Day Commission meeting and shared new regional leadership announcements. Monica Tellez-Fowler is the next President/CEO for COTA and Luke Messinger is the new RAPID 5 CEO.

Mr. Murdock stated the Census Bureau released updated numbers and shows Central Ohio as a growing region, but not the fastest growing region in the United States. We are still the fastest growing region in Ohio. The regions growing faster than Central Ohio are producing more housing. The population growth is proceeding as expected.

Mr. Murdock reported a delegation of MORPC Members and Staff attended the National Association of Regional Council's (NARC) National Conference of Regions in Washington, DC, where they heard best practices from other regional councils around the country. They had an opportunity to meet with U.S. DOT, Amtrak, the Federal Railroad Administration (FRA), and the U.S. Economic Development Administration. MORPC led a nationwide panel on housing and Níel Jurist led diversity efforts while there.

Work continues on the Midwest Connect line. MORPC entered an MOU with the City of Fort Wayne and partners in Pittsburgh. Significant work has been done with the FRA. MORPC is setting up a passenger rail committee soon to act as an advisory group.

A Central Ohio Delegation of public and private stakeholders travelled to Florida to see passenger rail and how it is implemented in other regions. They met with the Orlando Airport CEO and saw how rail is integrated into the airport. They discovered what private passenger rail looks like with the Brightline. The delegation also met with the local transit agency and MPO. They are looking for opportunities to see other projects.

The Member Benefit of the Month is our educational partnership with Franklin University. Any employee of a member government can take advantage of the tuition discounts to further their professional development. Franklin University offers a 20% tuition discount for associate, bachelor's, and master's degrees. They offer a 10% tuition discount for doctoral programs and free textbooks for all programs. The Grant Opportunity of the Month is Safe Streets and Roads for All. The FY24 round is open for the grant looking for initiatives to prevent roadway deaths and serious injuries. Over \$3 billion is available.

The Leaders Listen Survey is open until March 22. MORPC will share preliminary results at the March 15 State of the Region. We received nearly 2,000 responses covering all of MORPC's region.

The State of the Region is sold out. Keynote Speaker Majora Carter will talk about the value of connecting communities. Panel guests include ODOT Director Jack Marchbanks, Columbus City Council President Shannon Hardin, COTA Deputy CEO Monica Tellez-Fowler, and new RAPID 5 Executive Director Luke Messinger.

<u>Central Ohio Rural Planning Organization</u> – Parag Agrawal, MORPC Chief Mobility & Infrastructure Officer & Senior Director of Programming

Parag Agrawal gave the <u>Central Ohio Rural Planning Organization (CORPO) Report</u> on behalf of CORPO Chair Mark Forrest. CORPO is the transportation planning organization for the seven counties in the nonmetropolitan area and includes Fairfield, Knox, Madison, Marion, Morrow, Pickaway, and Union Counties. MORPC Team Member Mary Turner serves as the program manager. CORPO received three applications for the SFY 2024-2025 CORPO Dedicated Funds. After funding all three applications, CORPO had \$1 million available and opened a second round. They received six applications this time and dedicated \$1.1 million for five projects.

MORPC is working with CORPO members to draft a Roadway Safety Plan for CORPO counties. CORPO received a federal grant to create a safety action plan. The goal is an annual reduction of two percent in fatalities/serious injuries. A one-month public comment period for the plan starts next week. Once the plan is in place, CORPO communities can pursue implementation funding for projects identified in the plan.

MORPC Team Members are visiting each CORPO county to get feedback on how MORPC can assist them.

<u>Regional Policy Roundtable</u> – Lourdes Barroso de Padilla (City of Columbus), Regional Policy Roundtable Chair

Lourdes Barroso de Padilla presented the <u>Regional Policy Roundtable Update</u>. The Regional Policy Roundtable met February 29 with new chair, City of Columbus Council Member Lourdes Barroso de Padilla, and new vice chair, City of New Albany Mayor Sloan Spalding. Senator Andrew Brenner gave the Regional Leader Update focusing on his work on the Senate Special Housing Committee, which MORPC testified to last year. The committee plans to release its findings in a report over the next few weeks and introduce legislation based on that report. Commission Minutes March 14, 2024 Page 4

While at the NARC Conference, MORPC's delegation met with Central Ohio legislators and provided information on and advocated for 47 regional projects. They also shared MORPC's Public Policy Agenda. The delegation also met with the U.S. Department of Transportation and Amtrak and had promising conversations regarding regional connecting opportunities.

<u>Sustainability Advisory Committee</u> – Laurie Jadwin (City of Gahanna), Sustainability Advisory Committee Vice Chair

Laurie Jadwin presented the <u>Sustainability Advisory Committee Report</u>. Mayor Jadwin recognized the Sustainability Advisory Committee and welcomed new members joining in 2024:

- Christine Houk, Council Member, City of Grove City
- Carol Kaufman, Executive Director, Ohio Environmental Council
- Kenneth Wright, Mayor, City of Westerville

Appointed members serve a two-year term, with the option to renew. Several members continue to serve multiple terms. Mayor Jadwin thanked them for their service.

MORPC released its annual End of Season Air Quality Report on March 4, coinciding with the start of ozone monitoring season (March 1-October 31). MORPC issues air quality forecasts and alerts for ozone and fine particulate matter (PM2.5). During the 2022-2023 season, Central Ohio experienced worse air quality compared to the previous year, largely influenced by wildfire smoke from outside the region. MORPC issued eleven alerts for both pollutants. Central Ohio exceeded the federal standards on nine of those days. The region also experienced "red" or unhealthy PM2.5 levels for the first time in twelve years due to the wildfire smoke from Canada. The full report is available on MORPC's website.

Air Quality Awareness Week is May 6-10. The annual initiative's goal is to increase public understanding and awareness of air quality issues that affect our health and the environment. This year's theme is "Knowing Your Air." To raise awareness, MORPC encourages local governments to adopt a proclamation recognizing Air Quality Awareness Week. Contact Mauro Diaz-Hernandez, MORPC Air Quality Sustainability Coordinator, for more information and for a sample proclamation.

Working in partnership with MORPC, OSU, Power a Clean Future Ohio, and IMPACT, Sustainable Columbus submitted the first deliverable for Phase 1 of the Climate Pollution Reduction Grant (CPRG). Regional priorities were selected by polling over 400 people from different sectors across ten counties. The full Priority Climate Action Plan (PCAP), along with PCAPs submitted by the state of Ohio and others, is available <u>here</u>. The Phase 2 implementation grant proposal is due April 1. The team is finalizing their proposal for the Regional Community Energy Strategy (ReCES), which provides no-cost solar installations on public buildings, as well as measures along the LinkUS W. Broad corridor to support bus electrification and other measures that save energy and lower emissions.

Ohio EPA is leading a Regional Water Study working together with other state agencies, MORPC, and a consultant team. The review team selected a consultant, Hazen and Sawyer, who brought together several consultants with diverse areas of expertise to ensure completion by the end of the

year. MORPC and Ohio EPA will host monthly webinars to update key stakeholders throughout the process.

The next Sustainability Advisory Committee Meeting is March 20, 2:30 p.m. at MORPC. Meeting topics include ongoing priorities and updating the 2021-2024 Regional Sustainability Agenda.

"To authorize the executive director to enter into agreements with the Affordable Housing Trust (AHT) for \$100,000 for a 12-month period to perform mold remediation on properties identified through MORPC's Weatherization Program."

WHEREAS, The Affordable Housing Trust (AHT) has awarded a grant to MORPC for the purpose of mold remediation; and

WHEREAS, MORPC will identify homes with mold through its existing weatherization program; and

WHEREAS, upon completion of mold remediation MORPC will then perform additional weatherization measures on said properties; and

WHEREAS, MORPC has been providing free residential home repairs and energy efficiency services in Franklin County to eligible residents for over 30 years through public-private partnerships; and

WHEREAS, the services performed pursuant to properties identified as part of MORPC's weatherization program will be under the oversight of MORPC and be implemented through a combination of MORPC staff and local businesses that are contracted in MORPC's service area; now therefore

BE IT RESOLVED BY THE MID-OHIO REGIONAL PLANNING COMMISSION:

- Section 1. That the executive director is hereby authorized to enter into agreement with AHT for work described in the forthcoming contracts to be awarded to MORPC in the amount of \$100,000 through 2025 and enter into related subcontracts.
- Section 2. That the executive director is authorized to approve one or more extensions for performance of services under the foregoing agreements and change orders for amounts up to the financial authorization levels in the MORPC bylaws without further authorization from this Commission.
- Section 3. That the executive director is authorized to take such other action and execute and deliver such other documents as, acting with the advice of legal counsel, he shall deem necessary and appropriate to carry out the intent of this resolution.
- Section 4. That this Commission finds and determines that all formal deliberations and actions of this Commission concerning and relating to the adoption of this resolution were taken in open meetings of this Commission.
