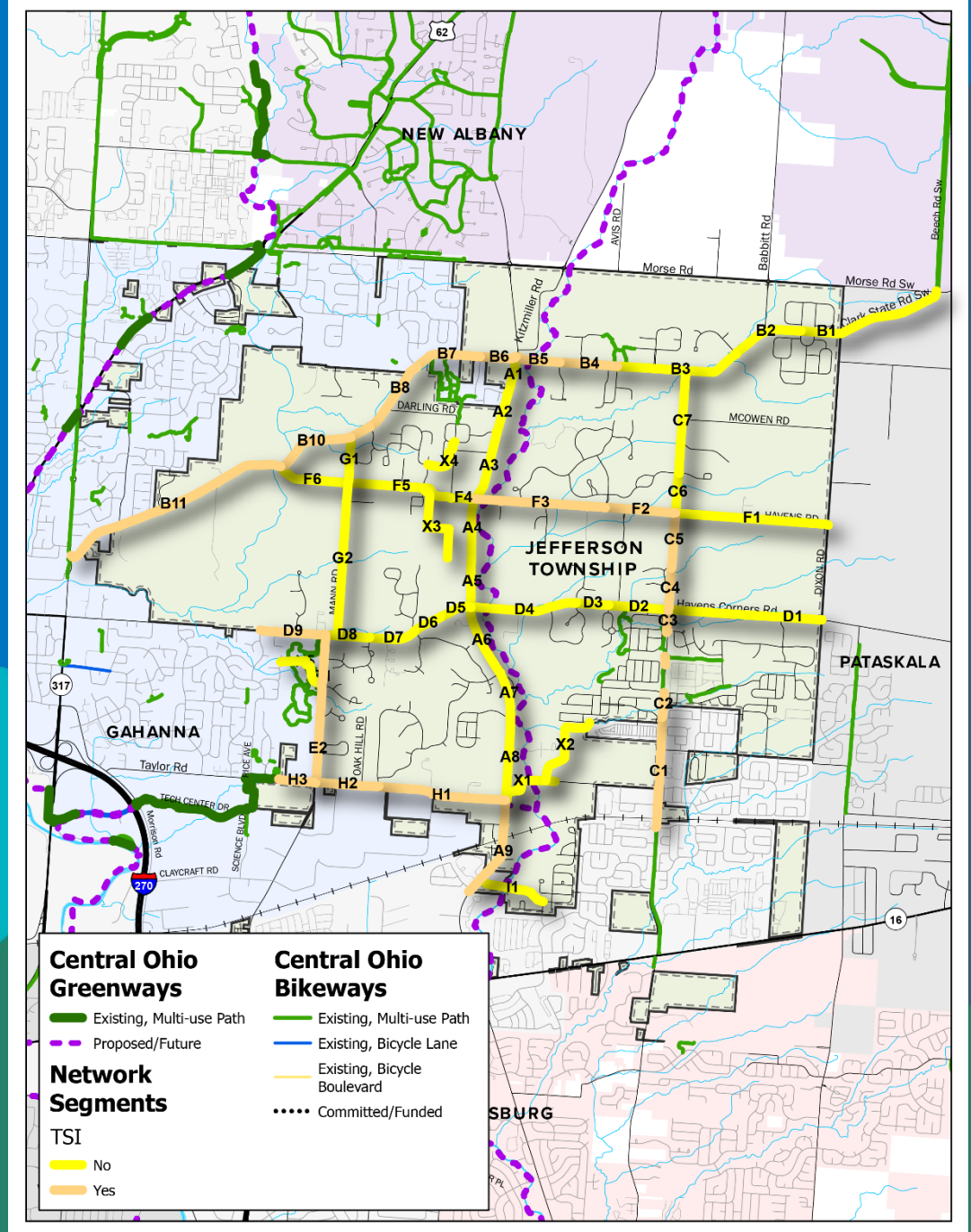

JEFFERSON TOWNSHIP

- **Study Goals** (*non-exhaustive*):
 - Co-create an active transportation vision
 - Identify & organize opportunities by priority and feasibility
 - Provide township with confident sense of next steps
- **Key Study Components**
 - Public Survey, 652 responses
 - Strong support for walking & biking
 - Two (2) Community Workshops
 - Initial visioning
 - Refinement of priorities, next steps
 - Geospatial Analysis
 - Network analysis to inform priorities
 - Connectivity between neighborhoods, to parks/trails



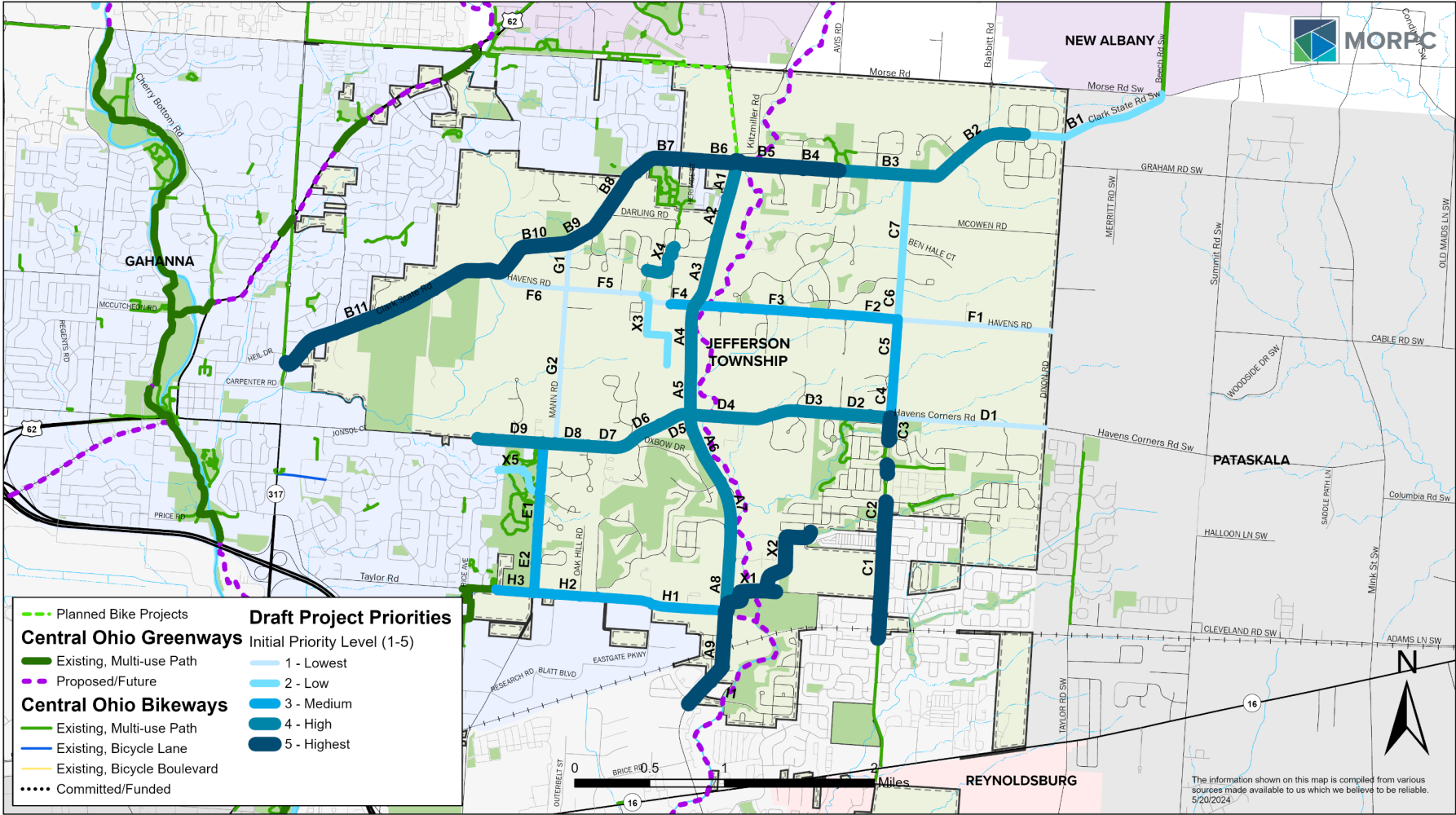

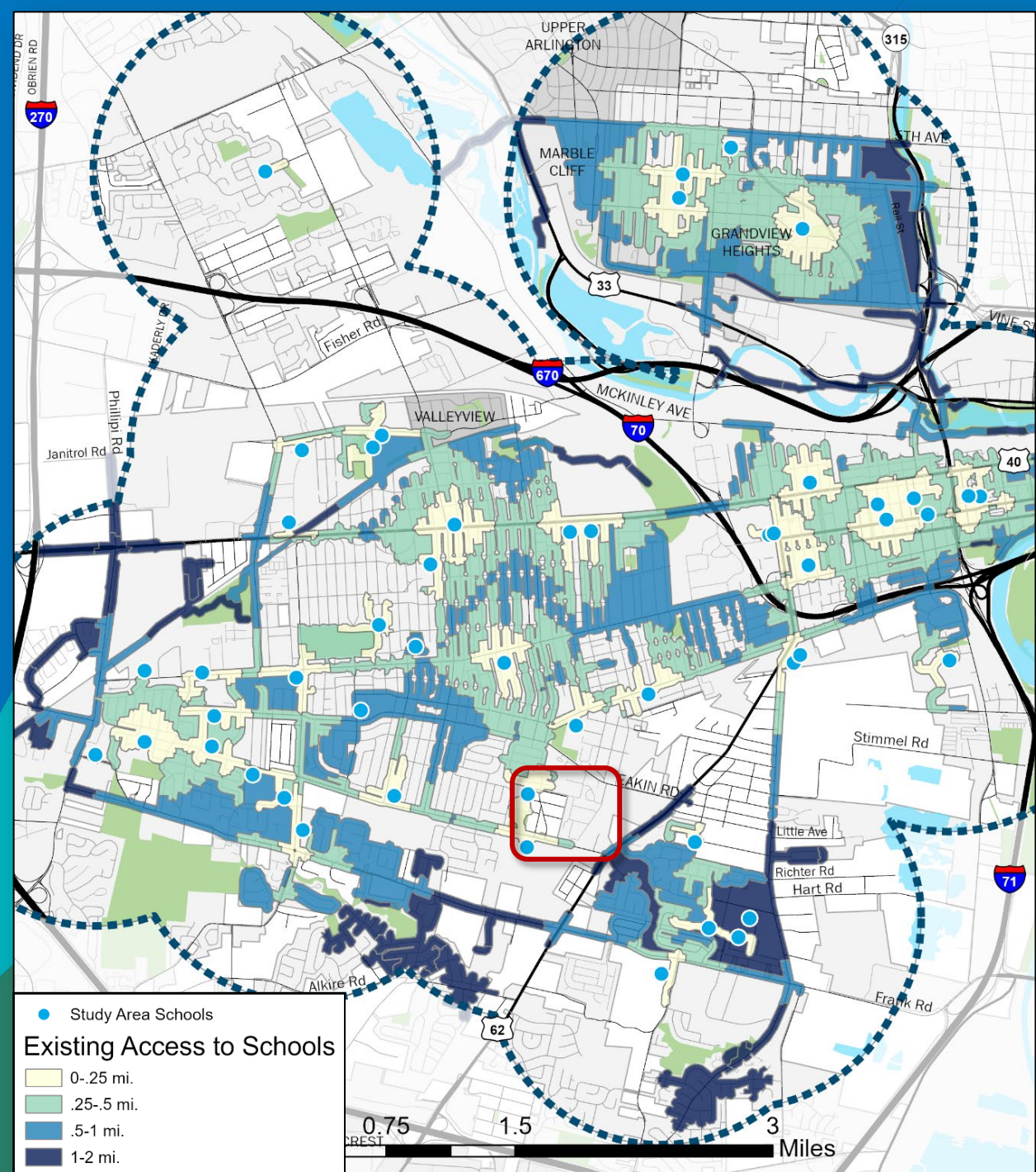


FRANKLIN TOWNSHIP

- **Study Goals** (*non-exhaustive*):
 - Organize priorities & inform next steps
 - Focus on sidewalk gaps & schools
 - Identify focus area for field study
 - i.e., Walk audit
- **Key Study Components**
 - Geospatial analysis
 - Walk sheds, schools as destinations
 - Next: transit, parks, more
 - Stakeholder Workshop
 - Discussed opportunities & challenges
 - Columbus Bike+ coordination
 - Walk Audit – Thursday, June 20th
 - Sidewalk gap near schools, community park

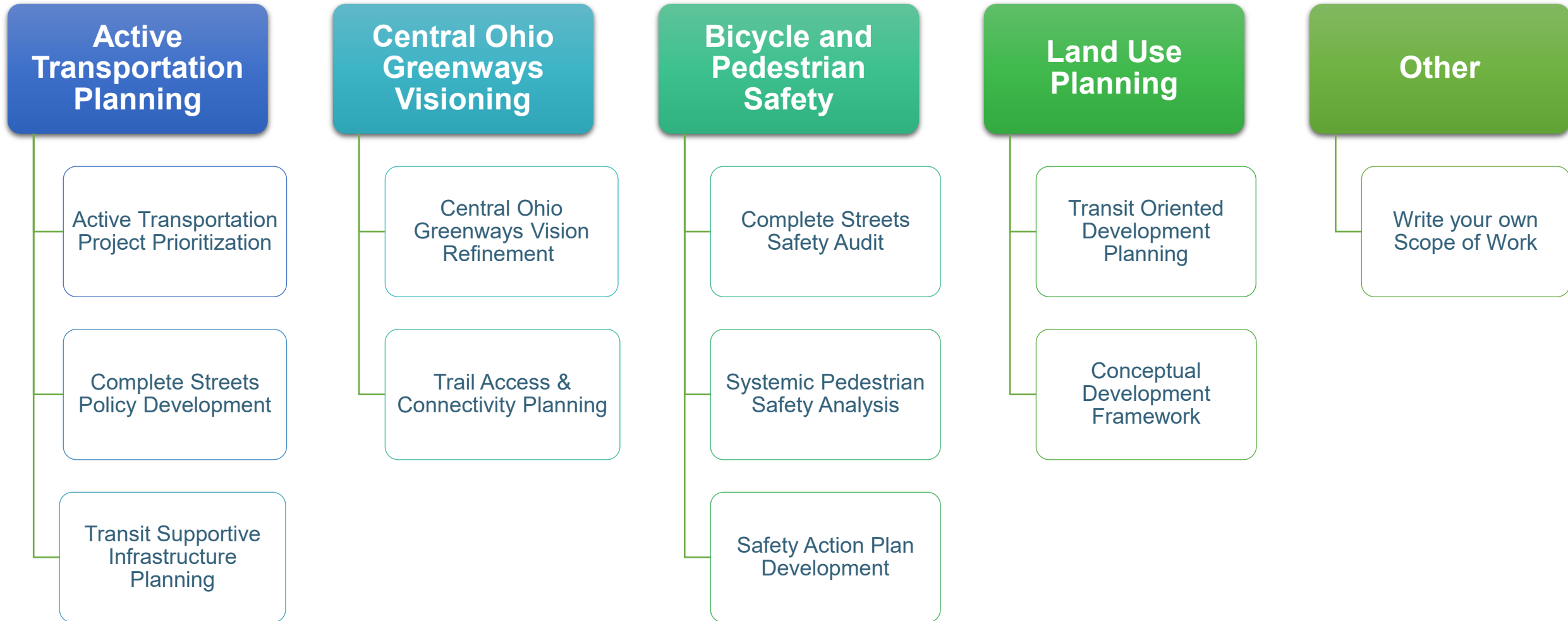
