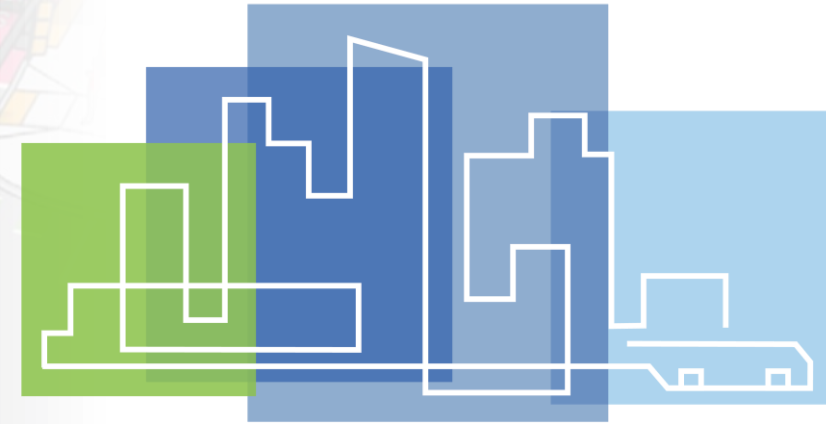
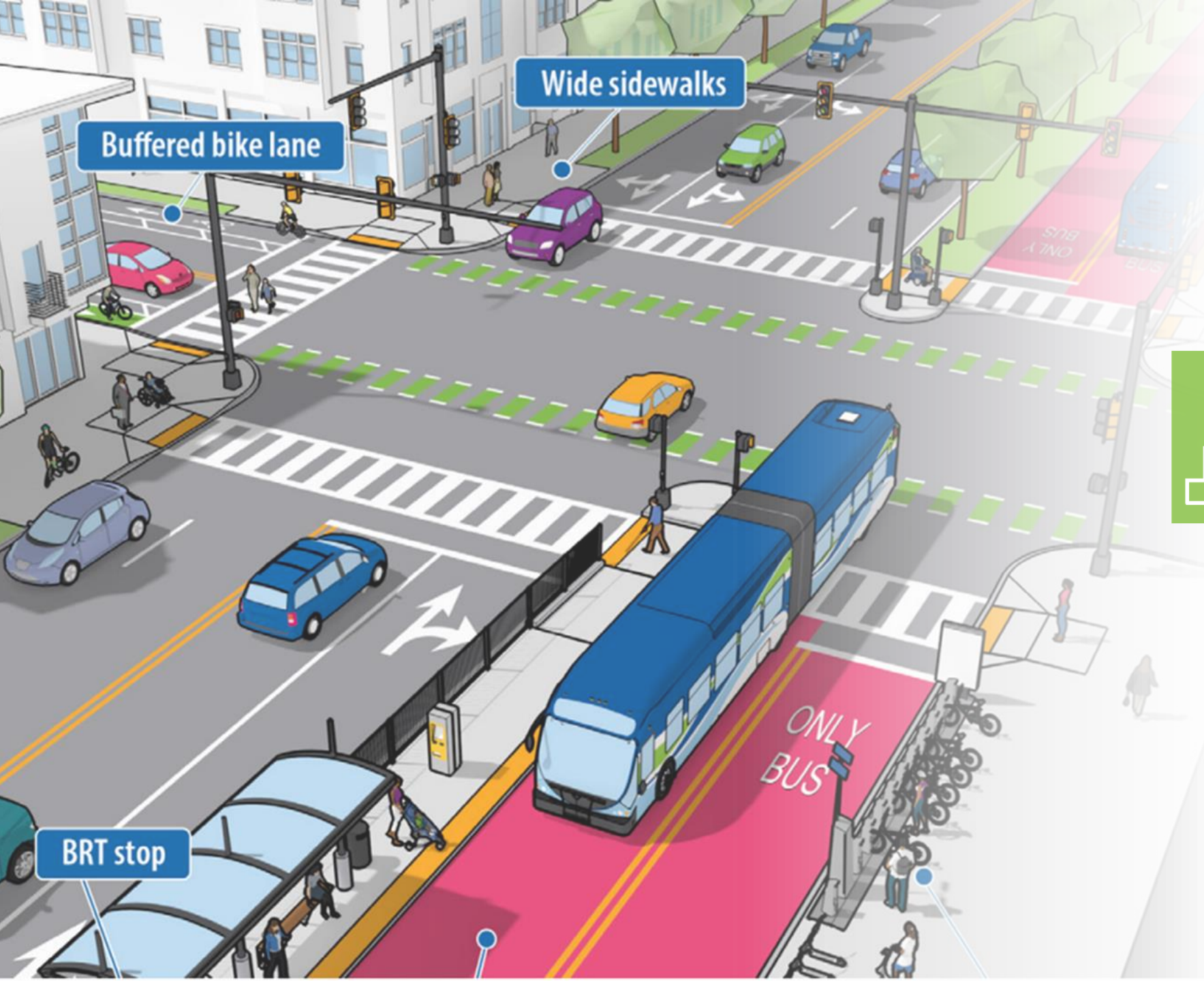

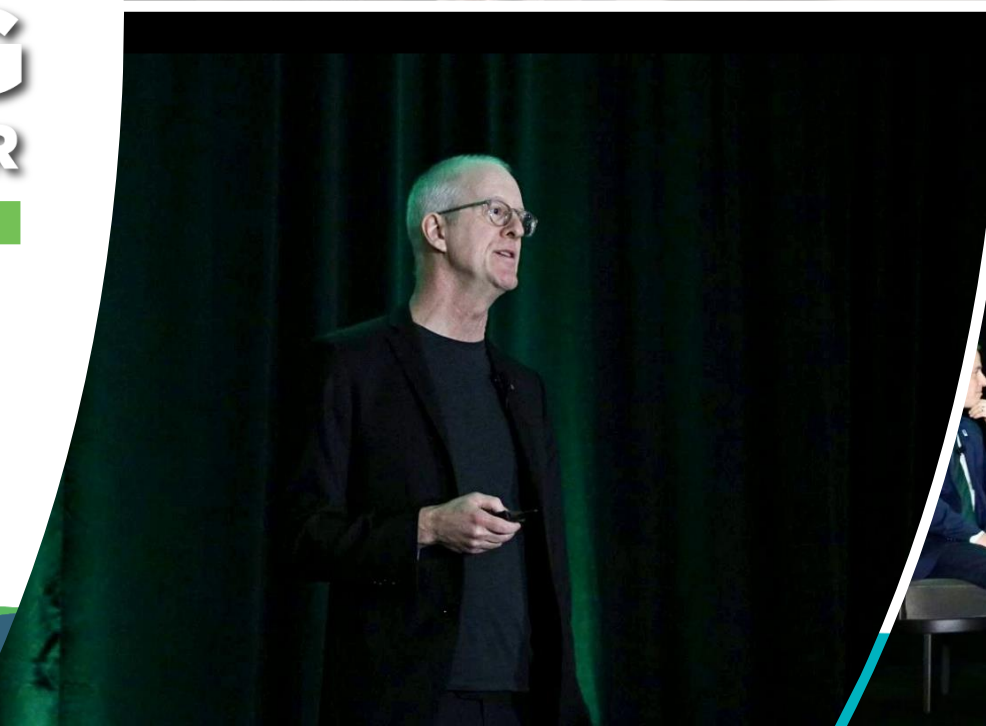

Capital University Partnership Benefits

- For Employees
 - MBA Cohort - \$5,250/calendar year (for 3 calendar years), following a set schedule (only 2 years of classes)
 - MSN – 5% discount
 - 15% discount on graduate level programs, including the MAEd, MSW, and on the MBA should the student not follow the cohort model
- For dependent children of employees:
 - \$1,500 scholarship per academic year when attending full time
 - This is in addition to the \$80,000 Main Street Scholarship
