# 2. Data Collection – esri Field Maps

a. Access Points

Members and staff discussed updating community-contributed access points, emphasizing the importance of accurately populating attribute tables with details such as parking availability and restroom facilities.

b. Permanent Hazards

The Working Group decided to focus on permanent hazards like low head dams and discussed the removal of outdated temporary hazard data from 2018.

#### c. Portage Routes

The Working Group agreed that including detailed portage routes is essential for user safety, especially around hazardous areas like low head dams.

d. Private Property / No-Stop Zones Members and staff reviewed the mapping of private property lines to designate no-stop zones, utilizing intern-compiled data for accuracy.

#### 3. Big Walnut Communities

Members and staff discussed the strategic engagement with the 14 communities along the Big Walnut waterway. The aim is to enhance collaborative efforts and gather detailed, localized data from these communities to support the water trail designation process. Members discussed the necessity of having all communities involved in the water trail designation process, even if only a few have actual access points. This inclusiveness ensures that any future expansions or modifications are seamlessly integrated and supported by all relevant stakeholders. There was conversation about potentially expanding community involvement through regular updates and meetings to keep all stakeholders informed and engaged in the water trail designation efforts.

### 4. OuterSpatial Updates

Staff shared updates regarding ongoing discussions with OuterSpatial to integrate trail data into their platform, which would include event listings and hazard reports from the community.
