Welcome and Introductions

MORPC Updates

Planner Pool Services

Karina Peggau gave an overview of MORPC's Planner Pool Program (<u>https://www.morpc.org/planner-pool-program/</u>). She asked Members if they have Sustainability needs that can be addressed by this program, and what services the Members would like to see the Planner Pool Program provide. Projects in process or recently completed are a car/parking permit survey for the City of Grandview Heights, a visioning project for the City of Newark, and traffic studies for several MORPC Member communities.

Summit on Sustainability

Amanda McEldowney announced that the Summit on Sustainability will be on September 30, 2025. She asked for feedback from Members on the sessions of the 2024 Summit. Chair Kessler asked Members to forward topics and ideas to MORPC staff.

The City of Gahanna was previously a Silver-certified community and worked with the MORPC team to meet the requirements for the Sustainable2050 Gold certification. The presentation included a few highlights from each of the Regional Sustainability Agenda's goals:

<u>Goal 1: Improve Air Quality and Reduce Climate Change Impacts to Protect Public Health and the</u> <u>Environment</u>

- In 2024, the City of Gahanna joined Power Clean Future Ohio (PCFO) to help the community build a clean future and provide the city with tools and resources to create carbon reduction plans and implement them in a way that is achievable, measurable, equitable and economical. PCFO helped the City of Gahanna conduct their Greenhouse Gas Reduction study in 2024.
- The City of Gahanna joined SOPEC, helping the City create its Community Choice Aggregation Program offering 100% renewable energy for City residents. The City also held a public meeting regarding the Community Choice Aggregation Program where residents had the opportunity to speak with City staff on this issue.
- The City contracted with Donovan Energy to perform site evaluations at all current electric vehicle charging stations to identify applicable improvements the City should make to their current infrastructure.
- The City purchased their first Electric Vehicle, a 2023 Nissan Leaf, which will be used by fleet technicians to drive to and from sites to make repairs on other vehicles, transport drivers, and perform other maintenance as needed.

Goal 2: Protect and Preserve Natural Resources to Support a Healthy and Resilient Region

- The City of Gahanna participated in Goats on the Go, an event held for targeted grazing of poison ivy, honeysuckle, multiflora rose, grapevine and other problem vegetation. The purpose of this event was to explore alternative mitigation methods to the use of herbicides for invasive species control.
- The City of Gahanna and SWACO teamed up with The Recycling Partnership to improve the curbside recycling program and bring recycling education to Gahanna. The program intends to increase the amount of quality recyclables – items that are accepted for recycling that are empty and dry, so they can circulate back into the recycling system to become new products or packaging.

Goal 3: Improve Quality of Life for All Residents by Creating Sustainable and Equitable Communities

- In 2023, the City adopted its first-ever Capital Improvement Plan and Parks Master Plan. Both
 plans discuss future projects for park and trail construction, sidewalk improvements, and other
 sustainability initiatives. The Parks Master Plan includes plans to complete the Big Walnut Trail
 within the next two years, as well as the creation of the Link to Literacy trail connecting with the
 new library. As a part of the City's Capital Improvement Plan, a citywide sidewalk program aims
 to close gaps in sidewalks and to prolong the life of current infrastructure through maintenance
 and upkeep.
- In 2023, the City of Gahanna Department of Parks and Recreation was awarded a grant for assistance to develop an Active Transportation Plan. The City expects to adopt the Plan by Q1 of 2025. The purpose of the Active Transportation Plan Assistance Grant was to support local governments with the development of a standalone active transportation plan that impacts Ohio's Active Transportation goals: Safety, Equity, Network Utilization, Livability, and Preservation.

Goal 4: Promote Robust, Inclusive and Sustainable Growth and Development

• The City's new Municipal Complex is being reimagined from an existing building that was previously an office building. In 2024, the City received funding from the US Department of Energy's Energy Efficiency Community Block Grant to upgrade and/or deploy clean energy technologies within the new Municipal Complex construction.

 The City of Gahanna has been working to improve the sewer systems on the west side of the City, which is a historically disadvantaged community. This initiative aligns with Sustainable2050's goal of prioritizing infrastructure investments in underserved communities with the greatest need. The City's Capital Improvement Plan includes an analysis of the continued work of the West Gahanna Sanitary Sewer System efforts.

Member Keeler moved to approve the City of Gahanna's proposed tier status certification at Gold (Plus Equity Champion) Level. Motion seconded by Member Lombardi, motion carried with Vice-Chair Jadwin abstaining.

Board and Working Group Reports

Regional Sustainability Agenda Sub-Committee

The Subcommittee met three times, and has identified areas of the agenda to maintain, modify, delete, or add. The framework of the existing Sustainability Agenda will be maintained, with a few modifications to the language. The Subcommittee is proposing three new objectives related to agriculture and a new climate resilience goal. The SAC members will be engaged further for input when a draft is firmed up.

Current Draft Agenda (changes still underway) -

Goal 1: Improve air quality and reduce climate change impacts to protect public health and the environment.

Objectives

- 1.1 Reduce per capita vehicle miles traveled.
- 1.2 Increase alternative fuel vehicles and infrastructure.
- 1.3 Reduce energy consumption across all sectors.
- 1.4 Increase local clean energy generating capacity.
- 1.5 Reduce regional greenhouse gas pollution.
- 1.6 Increase the number of days that meet federal standards for ozone and fine particulate matter pollution.

<u>Goal 2: Protect and restore natural resources to support a healthy and resilient region.</u> Objectives

- 2.1 Reduce the amount of solid waste disposed of in the landfill.
- 2.2 Reduce water consumption across all sectors.
- 2.3 Improve water quality in Central Ohio watersheds.
- 2.4 Increase land area designated for conservation of biodiversity and natural resources.
- 2.5 Support agricultural best management practices that enhance production and environmental quality.

<u>Goal 3: Improve quality of life for all residents by advancing healthy, connected, and equitable</u> <u>communities.</u>

Objectives

- 3.1 Improve transportation and mobility safety for all residents.
- 3.2 Increase and enhance transportation options for all users.
- 3.3 Increase access to parks, greenspace, and regional trails.
- 3.4 Reduce household energy cost burden.
- 3.5 Reduce the rate of elevated blood lead levels among children.
- 3.6 Increase access to and knowledge about local foods and agricultural products.

<u>Goal 4: Advance sustainable, attainable, and equitable economic growth and development.</u> Objectives Sustainability Advisory Committee Notes, December 18, 2024 Page 4 of 6

- 4.1 Increase support for businesses to develop and execute sustainability policies and practices.
- 4.2 Prioritize development in locations along existing infrastructure and encourage density.
- 4.3 Increase availability of affordable housing options near transit or job centers. Members discussed the term "affordable housing" vs "workforce housing" vs "attainable housing." Staff will continue to refine this language.
- 4.4 Increase employment and availability of green jobs.
- 4.5 Protect working agricultural lands. Members discussed that Objective 4.5 could be interpreted as anti-solar and anti-wind. Member Shelton noted that the intent is to preserve agricultural use and yet not limit housing or energy development. Staff will continue to refine this language.

<u>Goal 5: Create communities that are aware, prepared, and resilient to climate impacts.</u> Objectives

- 5.1 Increase preparedness for extreme weather events.
- 5.2 Increase community resilience to flooding, severe weather, and extreme temperatures.
- 5.3 Create more resilient infrastructure and built environments.

Central Ohio Greenways Board (COG)

- The COG Board met on November 20 to hear project updates and Working Group progress.
- The COG Trail Towns Working Group received a Collaborative Achievement in Sustainability Award at the Summit on Sustainability in October. The Group is working to implement the COG Trail Town Framework and the COG Wayfinding Strategy and is exploring opportunities to use Outerspatial as the Statewide trail user map platform. Additionally, the Group is looking at branding opportunities for the Trail Town Program and continuing to seek funding for a Trail Town Ambassador Training Program, the Trail Towns in the Nation's Heartland Project, and Operational Funding.
- COG is offering technical assistance to member communities to begin implementing the Wayfinding Strategy at a local level.
- MORPC is hosting a COG Forum: Experiencing Central Ohio's Rural & Small Town Trails on December 18th. MORPC is debuting the new Greenways Planning Studio (GPS) with 8 Greenway Planning Studio Workshops across the region.

Sustainable2050

- The Q4 Sustainable2050 meeting was held on December 5, with a presentation from Franklin County Public Health and Columbus Recreation and Parks regarding the recent Franklin County & Columbus tree canopy assessment. MORPC staff provided program updates and presented on the Regional Sustainability Agenda.
- Members provided input on priorities for 2025, including topics such as textile recycling, organics diversion, community engagement, streamlining the Sustainable2050 certification process, and data informed decision-making to identify impactful projects and initiatives.

Sustaining Scioto Board

• The Board met on December 11 to continue the discussion on the Board's transition to a regional entity under the Regional Water Advisory Council (RWAC) which will meet on a

quarterly basis starting in 2025. The discussion included proposed bylaws, regional representation, and scope of work among other details. The proposed Regional Water Advisory Council will continue to advance broad regional water priorities including sustainable water resource management, climate resiliency, and adaptation in the face of growth, development, and changing weather patterns. MORPC and the RWAC will play a role in educating regional stakeholders about the outcomes from the Regional Water Study.

- The Agricultural & Rural Communities Outreach Team will reconvene in 2025.
- The consultants have requested an extension for completion of the Central Ohio Regional Water Study through February 2025, due to significant modeling efforts to account for numerous growth and weather scenarios over the next few decades. The consultants will hold a Licking County specific workshop with elected officials and stakeholders on December 16, with the full report available in February.

Energy & Air Quality Working Group

The Energy and Air Quality Working Group (EAQWG) held its final meeting of the year on November 20, with updates from MORPC staff, as well as a featured update on the Central Ohio Climate Action Plan (COCAP) from Sustainable Columbus and MORPC staff. For more information on the COCAP, please read the more detailed update below. The EAQWG is still looking for candidates to serve as the Chair and Vice-Chair. If interested in leading the EAQWG, please contact Brian Filiatraut Electric Vehicle (EV) Infrastructure

- MORPC is in the final stages of awarding and contracting out the full scope of work of its \$2M USDOT-FHWA Electric Vehicle Charger Reliability and Accessibility Accelerator (EVC RAA) award to repair and or replace non-operational EV chargers throughout the 15-county region. The EVC RAA work should begin in December 2024 and continue into 2025 to fulfill the award completion deadline of August 2025.
- MORPC is working rapidly to finalize the grant agreement with FHWA on its \$15M MORE EVS project award to install over 400 EV charging ports in 13 counties as part of the USDOT-FHWA's Charging and Fueling Infrastructure (CFI) Round 1B Program. As soon as the grant agreement is completed, staff plan to issue an RFI to set up the RFP process.
 US EPA Climate Pollution Reduction Grant (CPRG) Program
- Sustainable Columbus, MORPC, and others continue to develop a more comprehensive climate action plan and pollution reduction strategies through the Central Ohio Climate Action Plan (COCAP) for the ten-county Columbus Metropolitan Statistical Area (MSA). MORPC recently completed the regional greenhouse gas inventory (R-GHGI), which will serve as a roadmap and benchmark mitigation strategies that will be developed over the coming months. Outreach and education have been ongoing throughout the development of the COCAP and future opportunities for community members and stakeholders to provide input will be available in 2025.

Air Quality

- The US EPA funded air monitoring project, co-led by Franklin County Public Health, made great progress in 2024. The team welcomed Ramboll Americas Engineering Solutions, Inc. as modelers for the project. Their Shair Platform will utilize MORPC's PurpleAir sensors to better track air pollution and source apportionment in Franklin County. MORPC staff has deployed 21 additional sensors in the community and intends to place an additional 14 by December 31.
- The Air Quality team met with and presented to multiple community groups and partners and will continue the goal of meeting with at least one group per month, as part of the project's educational outreach efforts.

MORPC is working rapidly to finalize the grant agreement with FHWA on its \$15M MORE EVS project award to install over 400 EV charging ports in 13 counties as part of the USDOT-FHWA's Charging and Fueling Infrastructure (CFI) Round 1B Program. As soon as the grant

US EPA Climate Pollution Reduction Grant (CPRG) Program

The core project team—led by Sustainable Columbus, MORPC, and others—continues its work in developing a more comprehensive climate action plan and pollution reduction strategies through the Central Ohio Climate Action Plan (COCAP) for the 10-county Columbus Metropolitan Statistical Area (MSA). MORPC just completed the regional greenhouse gas inventory (R-GHGI), which will serve as a roadmap and benchmark mitigation strategies that will be developed over the coming months. Outreach and education have been ongoing throughout the development of the COCAP through online surveys, in-person meetings, technical working groups with experts, and future opportunities for community members and stakeholders to provide valuable input will be available into 2025. Air Quality:

The US EPA funded air monitoring project, co-led by Franklin County Public Health, made great progress in 2024. Their Shair Platform will utilize our PurpleAir sensors to better track air pollution and source apportionment in Franklin County. With guidance from Ramboll and input from the Project Advisory Committee, the team has deployed 21 additional sensors in the community and aiming to place an additional 14 by end-of-year. The team met with and presented to multiple community groups and partners and will continue the goal of meeting with at least 1 group a month, as part of the project's educational outreach efforts. Sustainable2050

Next meeting: November 14, 2024

The Q4 Sustainable2050 meeting was held on December 5 from 9:30 – 11:00 a.m. at MORPC. The meeting featured a presentation from Franklin County Public Health and Columbus Recreation and Parks about a recent Franklin County & Columbus tree canopy assessment. This project also

provides results about tree canopy coverage for individual jurisdictions in Franklin County. The MORPC team provided program updates and presented on the Regional Sustainability Agenda. Members provided input on priorities for 2025, including topics such as textile recycling, organics diversion, community engagement, streamlining the Sustainable2050 certification process, and data informed decision-making to identify impactful projects and initiatives.

Sustainable2050 membership is open to all MORPC members, and current Sustainable2050 members interested in earning their tier status certification should contact Brandi Whetstone at bwhetstone@morpc.org. A certification workbook will be provided, and a kick-off meeting will be set up to review the process. Once a completed workbook has been submitted and reviewed by the MORPC team, the next step is to present the proposed certification to the SAC for approval at their quarterly meetings.



Sustaining Scioto Board (Chair: Glenn Marzluf, P.E) Next Meeting: TBD 2025

The Board met on December 11 to continue the discussion on the Board's transition to a regional entity under the Regional Water Advisory Council which will meet on a quarterly basis starting in 2025. The discussion included proposed by laws, regional representation, and scope of work among other details. The proposed Regional Water Advisory Council will continue to advance broad regional water priorities including sustainable water resource

management, climate resiliency, and adaptation in the face of growth, development, and changing weather patterns. MORPC and the RWAC will likely play a role in educating regional stakeholders about the outcomes from the Regional Water Study.

To conclude the year, MORPC staff provided a recap of the Board's activities as well as its working team's activities from its inception in 2020 to present. Key outcomes include a Precipitation Forum held in 2021. The forum was aimed at providing information on existing precipitation data resources, perspectives on the need for updated data for Ohio, and potential avenues for creating the needed data. The Board also applied for an OWDA funding proposal to develop a smart water quality monitoring network. While unsuccessful, the effort laid the foundation for ongoing discussions around water monitoring efforts in the region. One other recent outcome of the working team is the Communication Plan focused on promoting awareness and encouraging the adoption of water quality practices among farmers and landowners.

Agricultural & Rural Communities Outreach Team

The working team will reconvene in 2025.

Central Ohio Regional Water Study

The consultants have requested an extension through February to complete the Water Study. The delay is due to significant modeling efforts to account for numerous growth and weather scenarios over the next few decades. The consultants will hold a Licking County specific workshop with elected officials and stakeholders on December 16, with the full report out occurring sometime in February. GOAL 1: IMPROVE AIR QUALITY AND REDUCE CLIMATE CHANGE IMPACTS TO PROTECT PUBLIC HEALTH AND THE ENVIRONMENT

- In 2024, the City of Gahanna joined Power Clean Future Ohio (PCFO) to help the community build a clean future and provide the city with tools and resources to create carbon reduction plans and implement them in a way that is achievable, measurable, equitable and economical.
- PCFO helped the City of Gahanna conduct their Greenhouse Gas Reduction study in 2024.



GOAL 1: IMPROVE AIR QUALITY AND REDUCE CLIMATE CHANGE IMPACTS TO PROTECT PUBLIC HEALTH AND THE ENVIRONMENT

SOPEC

- In 2024, the City of Gahanna joined SOPEC, helping the City create its Community Choice Aggregation Program offering 100% renewable energy for city residents.
- Aggregation impacts approximately 69% of single family, two family, and condominium housing units (~9,900 units) and approximately 1,000 small businesses.
- The City also held a townhall regarding the Community Choice Aggregation Program where residents had a chance to speak with City staff on this issue.

GOAL 1: IMPROVE AIR QUALITY AND REDUCE CLIMATE CHANGE IMPACTS TO PROTECT PUBLIC HEALTH AND THE ENVIRONMENT

Electric Vehicles and Infrastructure

- The City contracted with Donovan Energy to perform site evaluations at all current Electric Vehicle Charging Stations to inform any applicable improvements the city should make to their current infrastructure.
- The City recently purchased their first Electric Vehicle, a 2023 Nissan Leaf, which will be used by fleet technicians to drive to and from sites to make repairs on other vehicles, transport drivers, and perform other maintenance as needed.



GOAL 2: PROTECT AND PRESERVE NATURAL RESOURCES TO SUPPORT A HEALTHY AND RESILIENT REGION

- The City of Gahanna participated in Goats on the Go, an event held for targeted grazing of poison ivy, honeysuckle, multiflora rose, grapevine and other problem vegetation.
- The purpose of this event was to explore alternative mitigation methods to the use of herbicides for invasive species control.



GOAL 2: PROTECT AND PRESERVE NATURAL RESOURCES TO SUPPORT A HEALTHY AND RESILIENT REGION

- The City of Gahanna and SWACO teamed up with The Recycling Partnership to improve the curbside recycling program and bring recycling education to Gahanna.
- The program intended to increase the amount of quality recyclables – items that are accepted for recycling that are empty and dry, so they can circulate back into the recycling system to become new products or packaging.
- Additionally, the City of Gahanna was awarded a grant from SWACO to improve and promote recycling.



Pictured above is a recycling container located on the Gahanna Municipal golf course, which was purchased with grant funds awarded from SWACO.

GOAL 3: IMPROVE QUALITY OF LIFE FOR ALL RESIDENTS BY CREATING SUSTAINABLE AND EQUITABLE COMMUNITIES

- In 2023, the City adopted its first-ever Capital Improvement Plan and the Parks Master Plan. Both plans discuss future projects for park and trail construction, sidewalk improvements, and other sustainability initiatives.
- The Parks Master Plan includes plans to complete the Big Walnut Trail within the next two years, as well as the creation of the *Link to Literacy* trail connecting with the new library.

GOAL 3: IMPROVE QUALITY OF LIFE FOR ALL RESIDENTS BY CREATING SUSTAINABLE AND EQUITABLE COMMUNITIES

- The City's Streets and Sidewalk Program are part of the City's Capital Improvement Plan.
- A Citywide sidewalk program aims to close gaps in sidewalks and to prolong the life of current infrastructure through maintenance and upkeep.



GOAL 3: IMPROVE QUALITY OF LIFE FOR ALL RESIDENTS BY CREATING SUSTAINABLE AND EQUITABLE COMMUNITIES.

- In 2023, the City of Gahanna Department of Parks and Recreation was awarded a grant for assistance to develop an Active Transportation Plan. The City expects to adopt the Plan by Q1 of 2025.
- The purpose of the Active Transportation Plan Assistance Grant was to support local governments with the development of a standalone active transportation plan that ultimately impacts Ohio's Active Transportation goals:
- 1. Safety
- 2. Equity
- 3. Network Utilization
- 4. Livability
- 5. Preservation



GOAL 4: PROMOTE ROBUST, INCLUSIVE AND SUSTAINABLE GROWTH AND DEVELOPMENT

- The City's new Municipal Complex is being reimagined from an existing building that was previously an office building.
- In 2024, the City received funding from the US Department of Energy's Energy Efficiency Community Block Grant to upgrade and/or deploy clean energy technologies within the new Municipal Complex construction.
- The funds from this grant will be used for LED lighting.



GOAL 4: PROMOTE ROBUST, INCLUSIVE AND SUSTAINABLE GROWTH AND DEVELOPMENT

- The City of Gahanna has been working to improve the sewer systems on the West Side of the City, which is a historically disadvantaged community. This initiative aligns with Sustainable2050's goal of prioritizing infrastructure investments in underserved communities with the greatest need.
- The City's Capital Improvement Plan includes an analysis of the continued work of the West Gahanna Sanitary Sewer System efforts.


