Welcome

Discuss Outcome of Last Meeting

Members and staff discussed the decision to wait for Member Wedel's opinion regarding platform options, agreement on the nine subject matter expertise areas, and identification of three main priorities: evaluating platform options, defining the advisor role, and beginning to recruit advisors. Progress was noted in narrowing down the focus areas and the need for one advisor per subject matter area for the beta test.

RDAC Feedback

Dave Dixon shared feedback from the RDAC, highlighting a suggestion to include cybersecurity as one of the domains. Members suggested that cybersecurity could be grouped with privacy, confidentiality, data use, data ethics, and Al under a broader category of "Methods and Management."

Platform Options Update

Members and staff reviewed platform options, listing several potential platforms including Google Classroom, Confluence, and Docuware Wiki. The Group also discussed the strengths and limitations of each platform, with a focus on ease of use, integration capabilities, and budget considerations. Raj Roy was tasked with updating the platform evaluation matrix with the new options discussed.

Other business

Members and staff discussed the recruitment of advisors for the pilot, emphasizing the need to identify individuals with expertise in the ten core areas. Dave suggested leveraging the RDAC network and other professional connections to find suitable advisors. The importance of defining the advisor role and setting realistic expectations for time commitment was highlighted.

Next Steps

- Staff will
 - Update the platform evaluation matrix and distribute it to the Members.
 - Circulate the advisor recruitment message to the RDAC and follow up with potential advisors.
- Members will review the platform options and provide feedback.
- Member Tesfai will prepare a draft definition of the advisor role for discussion at the next meeting.
