Central Ohio Greenways (COG): Alerts and Closures

Central Ohio Greenways Alerts and Closures is your reliable source for bike trail alerts and closures in the region. Keep yourself informed on the latest developments, closures, and detours to ensure a safe and pleasant biking or walking experience on the trails and greenways. Kindly report any unlisted trail disruptions to our Facebook or Instagram, as closures and restrictions across Central Ohio may change, and we aim to update our information as soon as possible.





Current Alerts and Closures:

Olentangy Trail Section Closure (May 2023 through Summer of 2024)

The Olentangy Trail adjacent to Ohio State University will be closed; this closure includes a detour around Ohio Stadium, Morrill Tower, and Lincoln Tower to rejoin the original trail near West 12th Avenue.

Scioto Trail Construction (August 2023 through Summer 2024)

Attention Scioto Trail users! Columbus Recreation and Parks is thrilled to announce the start of an essential pedestrian bridge project for the Scioto Trail near Souder Avenue.

Starting in August, 2023, the trail will undergo construction to build a new pedestrian bridge parallel to Souder Avenue. Additionally, the Department is building a new shared use path along Souder Avenue to Broad Street. Construction will be complete in Summer of 2024.

For everyone's safety, the affected trail section will be temporarily closed during the construction period. Please adhere to the designated detour route provided on-site for a seamless journey to your favorite outdoor activities. We appreciate your cooperation.





Safe Streets and Roads for All (SS4A) FY23 Award

MORPC was awarded \$1,032,000 for the MPO Planning Area!

What we committed to do with the funding:

- Update the Central Ohio Transportation Safety Plan (COTSP);
- Advance our regional non-motorized volume data program;
- Develop a regional program for conducting Complete Streets Safety Audits; and
- Implement pilot pedestrian safety countermeasures at 20 priority locations.

Proposed Planning and Demonstration Grant Activities

COTSP Update:

- Incorporate new federal guidance (NRSS, Safe System Approach...)
- Develop online dashboard
- Engage new partners
- Update High Injury Network
- Conduct in-depth data analyses
- Identify critical regional priorities
- Adopt before Spring 2025

Demonstration Activities:

 Collaborate with local partners to install low-cost, quick-build, highimpact pedestrian safety countermeasures at 20 priority safety locations

Non-Motorized Volume Data Collection Program (NMVDP):

- Collaborate with local and state partners to build out existing program
- Purchase and install new equipment (on and off street)
- Develop understanding of nonmotorized activity and safety risk
- Identify key areas for safety investments

Complete Streets Safety Audit Program (CSSAP):

- Build upon existing program and partnerships with Public Health agencies to expand services
- Conduct walk and bike audits throughout the region
- Identify low-cost, high-impact safety improvements in priority safety locations
