#### 2. Program Alignment

Jessica Kuenzli reported that the purpose of the meeting is to discuss the overall program alignment of the Central Ohio Blueways and to move forward with next steps, especially considering other concurrent programs.

Jessica mentioned that the User Experience Working Group and the Water Trail Designation Working Group were consolidated into one cohesive group called the River Ready Working Group, aiming to move forward with both user experience and water trail designation goals. MORPC staff has been working on various planning documents, including a draft project implementation guideline and a waterway hazard removal contract, but has not received as much engagement as hoped.

Jessica proposed pausing work on the Central Ohio Blueways over the Summer to better align efforts with other ongoing projects and alleviate duplication, with plans to reconvene in the Fall.

#### 3. Central Ohio Greenways Trail Towns Update

Melinda Vonstein provided updates on the Central Ohio Greenways, including the progress made in connecting the region by trail, the ambitious vision of adding 500 miles of trails, and the launch of the Trail Towns program.

Melinda also discussed the Greenways Planning Studio, which aims to encourage bold and collaborative visions for Central Ohio, offering technical assistance to regional partners and potentially advancing water trail designation as a technical assistance offering.

Melinda reported on the recent completion of an environmental sensitivity index for Franklin County, which identifies the most environmentally sensitive areas and aims to encourage green infrastructure to protect these areas.

### 4. Regional Water Advisory Council Update

Edwina Teye discussed the Regional Water Advisory Council, which has been formed to provide strategic leadership on water resources planning, management, and resiliency, and to implement recommendations from the Regional Water Study.

Member Rayburn shared information about the City of Dublin's water recreation opportunities, including kayak launches at Amberlee Park and Riverside Drive, and plans for further improvements at Riverside Crossing Park.

- Discuss reconvening the Steering Committee and Working Groups again in Fall.
- Evaluate the feasibility of designating local water trails within individual jurisdictions before stitching them together for cross-jurisdictional water trail opportunities.
- Email Members with an opportunity to sign up for the bike map update project and volunteer to ride the routes.
