## **Topic Discussion**

Blue Chip Economic and Housing Forecast - Bill LaFayette, Ph.D.

A deeper look at the economic forecast produced by Bill LaFayette. Here we will hear from Bill Lafayette about his forecast for the region with a focus on the housing conditions facing Central Ohio and how these forecasts were generated.

Bill LaFayette presented the Central Ohio Economic Forecast, discussing employment trends and the methodology used, including reliance on the Philadelphia Federal Reserve's quarterly survey and the Bureau of Labor Statistics data.

### **Employment Statistics and Forecasting**

Bill detailed the process of generating employment forecasts for Columbus, including the challenges of working with local employment data and the need for seasonal adjustments. He highlighted the importance of the Quarterly Census of Employment and Wages in verifying the accuracy of employment statistics.

### **Columbus Employment Trends**

The Columbus economy is expected to underperform the national economy for the third consecutive year, with a forecasted gain of 9,800 jobs or 0.9%. Bill noted that construction remains a bright spot, while other key sectors like financial activities and healthcare have underperformed.

### Population Growth and Labor Force

Bill discussed the population growth in the Columbus MSA, noting a slowdown in recent years. He explained the factors contributing to this trend, including natural increase and net migration, and highlighted the impact on the labor force and employment growth.

## **Housing Market Challenges**

Bill addressed the challenges in the housing market, including the need for increased housing production to meet demand. He emphasized the importance of building affordable housing at various price points to support economic growth and population retention.

### Current Housing Conditions: American Community Survey – Ethan Hug, MPA

An exploration of the data available through the ACS that MORPC has used to look at the current housing conditions in the MORPC Region.

Ethan presented data on the housing market conditions in Central Ohio, focusing on the diversity of housing units, changes in population for owner and renter-occupied units, and the impact of income growth on housing affordability. He highlighted the challenges faced by renters and the need for more affordable housing options.

#### Income and Housing Costs

Ethan analyzed the changes in household incomes and housing costs over the past decade, noting that while incomes have increased, the cost of housing has risen significantly. He discussed the impact of higher income households renting longer and the challenges faced by lower income households in affording housing.

### Housing Affordability and Supply

Ethan discussed the impact of rising housing prices and mortgage rates on homeownership, highlighting the need for increased housing supply to meet demand. He emphasized the importance of building diverse housing options for low and middle-income households to address affordability issues.
