Welcome & Introductions

Dave Dixon welcomed new Working Group Member Julie Mosca, City of Columbus

Overview of the Working Group's Purpose

Dave provided context on the DEI & Data Working Group, explaining that it is one of five under the Regional Data Advisory Committee (RDAC). The Working Group's primary goal is to complete a project that aligns with DEI principles in data practices. The approved project involves hosting a "bring your own data" style event to help stakeholders assess their data through a DEI lens.

Project Concept: DEI Data Event

Members and staff discussed the concept of the event, which aims to support stakeholders in evaluating their data for representation of marginalized communities, equity-focused analysis, accessibility and usability, and communication clarity for general audiences. The event will be voluntary and targeted at stakeholders interested in improving DEI in their data practices. The discussion emphasized the importance of practical impact and stakeholder engagement.

Considerations for Data Sharing and Privacy

Members raised concerns about data sensitivity and the need for non-disclosure agreements or clear guidelines to prevent data breaches. Members and staff agreed that participants should deidentify data and possibly focus on sharing visualizations or summaries rather than raw datasets. Member Mosca Julie suggested using existing visualizations to avoid privacy issues while still enabling meaningful discussion.

Event Format and Structure

Members and staff discussed different formats for the event:

- A workshop-style session with hands-on support
- A larger informational session with breakout groups
- A selective model where participants submit requests or proposals in advance

There was consensus that a workshop format might be more effective initially, with flexibility to scale based on interest. Rolanda Hampton advised against capping attendance due to potential noshows and suggested using MORPC's Town Hall space if needed.

Resource Development: Toolkits and Rubrics

Members and staff agreed that the next step is to identify existing DEI data toolkits, rubrics, or questionnaires that could be adapted for the event. Rather than creating new tools from scratch,

Members will research and contribute resources to a shared SharePoint folder. These materials will be reviewed and discussed at the next meeting.

Timeline and SMART Goal

The Working Group's SMART goal is to engage 20% of MORPC Members (approximately 20 organizations) by July 31, 2024. While this timeline is ambitious, it provides a target to work toward. Adjustments may be made based on planning progress and scheduling needs.
