Welcome & Introductions

Working Group Goals

Melinda Vonstein outlined the goals for the Working Group this year, which include maintaining the Regional Trail Vision, identifying connections to State Parks, aligning state and US bike routes, leveraging investment in Franklin County, identifying Gateways of Regional Significance, and holding Greenway Planning Studio Workshops.

Gateways of Regional Significance Definition Discussion

DRAFT Definition: A Gateway of Regional Significance is a premier trailhead located along a Trail of Regional Significance that provides and/or connects trail users to amenities, services, and information necessary to navigate the trail system.

Melinda presented a draft definition of a Gateway of Regional Significance and gathered feedback from the Working Group Members. Members and staff discussed the importance of both recreational and transportation uses for trails. The importance of amenities such as shade trees, water, and restrooms was also discussed, as these are essential for a comfortable and dignified experience for trail users.

Gateways of Regional Significance Identification Mini-Workshop

Members and staff discussed the potential connection between Gateways of Regional Significance and the Trail Town program. They considered whether Gateways should connect people to retail or destination centers with amenities like restaurants and shopping.

Types of Gateways

Member Fischer suggested that there could be different types of Gateways, such as commuter hubs or recreational family gathering places, each with different priorities and amenities. Staff and Members discussed the idea of having a checklist of amenities that Gateways must meet to be considered Gateways of Regional Significance, ensuring they cater to various needs. Examples would be Mobility Hubs, which would prioritize amenities like bus access and bike racks, catering to commuters, and Recreational Gateways, which would focus on amenities like fountains and family-friendly facilities, catering to recreational users.

Number of Gateways

Members and staff discussed the frequency of Gateways of Regional Significance, considering whether there should be a limited number of high-quality Gateways or a larger number of

Ben Kessler Secretary Gateways with varying levels of amenities. They also considered the differences between urban and rural areas, with urban areas potentially requiring more Gateways due to higher population density and usage. In rural areas, the focus might be on having fewer Gateways with concentrated high-quality amenities to ensure trail users have all necessary services in one place.

Trail Alignment & Realignment

Members and staff discussed the potential realignment of the Central Ohio Greenways network to follow the US bike route system. They considered whether to add proposed COG trails to serve the US bike route function and improve bike route facilities over time. Stakeholder input was deemed crucial in the realignment process to ensure the new routes meet the needs of the community and enhance connectivity.

Connecting to State Parks

Members and staff discussed the feasibility study for connecting the City of Bellefontaine to Indian Lake State Park. The study identified a preferred route and highlighted the importance of stakeholder feedback in the planning process.

State and US Bike Route Signage

Members and staff discussed the challenges of getting state and US bike routes signed and maintained. They noted that ODOT provides signs, but local jurisdictions must decide whether to sign the routes and maintain the signage.

Statewide Walk Bike Ohio Plan

Emma Kogge announced that she is working on the statewide Walk Bike Ohio Plan and suggested that the Working Group could be involved in the stakeholder engagement process. Members and staff expressed interest in participating and offered to help with the process.

Next Steps

Members agreed to send ideas for focus areas or conversations for the Greenway Planning Studio Workshops to Melinda Vonstein.
