PUBLIC BODIES

Decision-Making Boards

Central Ohio... Boards: Decision-making authorities in MORPC by-laws, only sharing information with Commission

Advisory Roundtables

Regional... Roundtables: Top advisory committees to Commission, not decision-making boards. Commission has decision-making authority

Commission Committees

Committees & Subcommittees: Named in MORPC by-laws and/or have a specific public function. Decision-making is defined by-laws, articles, or other policies.

NOT PUBLIC BODIES

Advisory Councils

Central Ohio... Advisory Councils: Standing subgroups of Advisory Roundtables and Decision-Making Boards, larger in size and range of topics

Working Groups

Working Groups: Ad hoc subgroups of Committees, Advisory Roundtables, or Advisory Councils, more focused membership and range of topics

NOTE: MORPC-Supported Committees are staffed by MORPC but are not in MORPC by-laws and are categorized based upon review of their oversight organization
