#### Afternoon All,

I wanted to provide you a quick summary of our conversation and reiterate a few of the next steps. First though, thank you everyone for participating! It's for sure going to be a fun ride .

After we went through some introductions, we began an open discussion/brainstorm session on potential projects and focus areas for the group. Below (in bulleted format) is a summary of those ideas:

### • Develop a coordinated approach to emergency response on the waterways

- Big problem is transmitting location information
  - Ohio EPA developed mile-marker system
- What3Words
  - Generated from RapidSOS
  - Transmitted to Dispatch Team
  - Can use for directions

### Hazard Identification Collaboration

- RiverRangers.org
  - Follow-Up about Drone flying for hazards
- Consortium for Hazard Removal
  - Budgeting ahead of time is helpful
  - Anticipate cost
- Signage Package
  - Access, Educational, Safety, Stewardship
- Delivery of Uniform Assets for the User Experience
  - Beyond Signage
  - Park and Paddle Locations
    - Amenities
  - Access Points
    - Amenities
    - Paths
    - Accessibility
- Onion Bag Project
- Livery Support
  - Help Coordinate Trips
    - Partner with Metro Parks, ODNR, City of Columbus, Experience Columbus

We also confirmed that the group is likely best served with a more informal structure to promote a more roundtable-type discussion.
