# Welcome & Introductions

## Finalize Data Day 2026 Theme and Tracks

Members and staff discussed potential themes for the 2026 event, focusing on the future of data and preparing data professionals for upcoming challenges. They considered incorporating student involvement and wisdom sharing from experienced professionals. Jordan Inskeep noted that MORPC staff is waiting for confirmation from Salima Rice about her potential role as a keynote speaker, which could influence the theme.

## Prepare for discussion with RDAC (Breakouts?)

Jordan Inskeep discussed the Call for Proposals, emphasizing the need for technical skill levels and session objectives. Staff plans to convert the Call into a Microsoft form and discuss it at RDAC on July 29. Staff and Members agreed that Proposals should include three objectives to provide a clear understanding of the main takeaways from each session.

#### **Discuss Sponsorships**

Staff and Members discussed the possibility of offering a la carte sponsorship options and adjusting the sponsorship levels to attract more sponsors. This option would allow organizations to sponsor specific items like afternoon coffee or lunch. They also discussed adjusting the sponsorship levels to make them more attractive, potentially lowering the tiers to \$750-\$1000 and \$2500. Jordan will consult Amanda McEldowney and Dave Dixon for further input on the proposed changes to the sponsorship packages.

Member Ebersole noted the success of the 2025 sponsorship model, which helped the event break even thanks to a platinum sponsorship from CMHA.

#### **Keynote Speakers**

Members and staff brainstormed potential keynote speakers, considering individuals from organizations like Nationwide Insurance and Cardinal Health, which are both known for their data-driven decision-making. Member Ebersole emphasized the advantage of choosing local speakers to avoid additional costs associated with travel and accommodation. They also discussed the possibility of Salima Rice committing as a keynote speaker.
