Meeting Called to Order at 1:00 pm.

Welcome

Chair Ebersole welcomed Committee members and staff, and introduced Dave Dixon, MORPC's new Director of Data Analytics & Strategy

Regional Public Policy Update - Joe Garrity / Kyle Probert

Joe Garrity provided an overview of updates to the 2023–2024 Public Policy Agenda. Key themes included digital equity, broadband access, and legislative advocacy. The Agenda emphasizes collaboration with the Franklin County Digital Equity Coalition and BroadbandOhio. Joe also discussed the importance of preparing for the State's operating and transportation budgets and highlighted federal funding deadlines.

MORPC Staff Updates

MORPC Team Updates

Data Team

Adam Porr shared that updated population forecasts through 2050 are in final review, incorporating Intel-related growth. The region is still projected to reach 3 million people by 2050. Other updates included modest 2022 population growth, ongoing work on housing strategy data, gentrification analysis, and management of PurpleAir sensor data.

Mapping Team

Adam summarized the December 1 COGUG meeting. Topics included ODOT's TIMS system upgrades, new orthographic imagery for Columbus, and GIS Conference endorsements. MORPC's 3D base map for ArcGIS Urban is complete, and a regional bike/pedestrian network RFP is forthcoming.

NNIP Conference Debrief

Ethan Hug reported on the recent NNIP Conference, noting shared challenges and growth trajectories among peer organizations. He highlighted valuable resources gained, particularly around community advisory boards.

Regional Information & Data Group

Ethan previewed the final RIDG meeting of the year, which would feature a panel of city auditors discussing data use. A follow-up survey will assess member systems and interest in leadership roles.

Central Ohio GIS User Group – Cheri Mansperger

Topic covered in Mapping Team update above.

Working Group Reports

Local Government Resources

Member Drummond outlined progress on a SharePoint-based resource library focused on data governance, cybersecurity, and public records. The Working Group aims to have 75% of key resources uploaded by Data Day 2023. RDAC Member Andrew Wilson will assume the Chair role for the Working Group in 2023.

Capacity Building & Partnerships

Member Masood provided updates on two initiatives: Data Day (scheduled for March 1 at the Ohio University Dublin campus) and a data library tool for the social sector. The Data Day agenda is expanding due to increased space, and a panel discussion will inform development of the social sector tool.

Regional Municipal Fiber Strategy

Member Orth reported on the evolving focus of the fiber strategy, now incorporating residential connectivity to address digital equity. The Working Group is splitting into two workstreams: one for investment planning and another for broader engagement. Municipalities can participate as anchors or tenants.

Regional Data Agenda Update Working Group

Chair Ebersole announced the formation of a Working Group to update the Regional Data Agenda for 2023–2024. Member Drummond and Chair Ebersole will lead the effort, with meetings starting in early January 2023. Volunteers were requested, especially from current working group chairs.

Other Business

Bridging the Digital Divide in Central Ohio" Event Debrief

Adam summarized a recent webinar featuring Smart Columbus and BroadbandOhio. The event highlighted regional and state-level digital equity efforts and opportunities for member participation.
