Welcome & Introductions

Jordan Inskeep opened the meeting and noted that Member Miller will be stepping away from the Working Group due to work commitments.

Update from RDAC

Dave Dixon provided a comprehensive update from the recent Regional Data Roundtable meeting. A key highlight was a presentation by Megan Ash on the evolving use of Al in K–12 education. Contrary to earlier resistance, a majority of teachers are now using Al tools to streamline repetitive tasks, such as creating individualized documents for students. Schools are also beginning to establish standards for appropriate Al use, led by both teachers and students.

Jessica Kuenzli discussed the restructuring of MORPC's committees in response to new legislation on virtual meetings. The RDAC is now the Regional Data Roundtable (RDR), aligning with other top-level advisory bodies. This change clarifies which groups are considered public bodies and which are not, affecting requirements for public notice and meeting minutes. Working groups like the Data Day Working Group are not public bodies and thus have more flexibility in format and documentation.

Member Stein reported that Regional Data Roundtable Members had reflected on how best to allocate limited volunteer time – either by initiating new projects or supporting existing regional efforts. There was consensus that a balance is needed. Data Day was cited as a valuable initiative worth continued investment, while other efforts might benefit more from collaboration with existing networks.

Finalize Theme

Members and staff finalized the theme for the upcoming Data Day event after extensive discussion. Feedback from RDR emphasized the importance of centering the human element in data work. Several theme options were considered, with strong support for equation-style phrasing.

The group unanimously agreed on the theme: "People + Data = Inspired Futures"

This theme was chosen for its simplicity, inclusivity, and alignment with both technical and human-centered perspectives. It allows for sessions on AI and machine learning while emphasizing the

critical role of people in shaping outcomes. Members and staff also discussed how to encourage presenters to tie their content back to the theme, particularly in their introductions and conclusions.

Finalize Keynote Format/Prepare for Follow-Up with Salema Rice

Members and staff discussed the keynote format and next steps for coordinating with confirmed keynote speaker Salema Rice. There was concern that earlier feedback may have unintentionally discouraged Salema from her original presentation style. The Group agreed to reassure Salema that her content is welcome and to clarify the audience's needs without limiting her approach.

Member Ebersole suggested leveraging Salema's professional network to identify a potential second keynote speaker or panelist. Members and staff also discussed the possibility of Salema moderating a panel, depending on her preference.

Assign Sponsorship Outreach Tasks

Due to time constraints, this item was deferred to follow-up via email. Amanda McEldowney, MORPC, will coordinate outreach assignments with the Members.

Next Steps

- Dave will draft language for the call for proposals (CFP) to encourage submissions in underrepresented areas such as GIS and social science research.
- Jordan and Dave will follow up with Salema Rice at an upcoming event to finalize keynote details.
- Members and staff will explore a potential lunch keynote or session focused on regional transit data, including LinkUS and other mobility initiatives across Central Ohio. This topic was seen as a strong fit with the theme and of broad regional interest.
- Early promotion of the event and keynote speaker will be prioritized to boost engagement and proposal submissions.
