






Historical and forecasted population, 15-County Region


HOW WE ESTIMATE COUNTY POPULATIONS





NATURAL INCREASE CONTRIBUTING LESS TO REGIONAL GROWTH THAN IN THE PAST



NEW METHOD IN 2025 IMPROVES EFFICIENCY AND REDUCES BIAS



How?

Leverage accessible & reliable inputs:

- Decennial census population count
- Decennial census housing unit count
- Census address count listing
- County auditors' new address points
- Multiple Listing Service (MLS) new homes

Why?

- More comprehensive snapshot of where people live within each county
- Overcomes shortcomings of relying on single dataset
- Not dependent on data contributions from member communities
- Reduce data collection burden

COMPARED TO LAST YEAR, POPULATION OF MEMBER COMMUNITIES INCREASED 2.1%



- Two new members:
 - Alexandria (pop. 509 in 2025)
 - Marion City (pop. 35,724)
- One member gained a Commission representative:
 - Canal Winchester (pop. 10,288)
- Two members joined MPO:
 - Johnstown (pop. 5,595)
 - Plain City (pop. 4,944)
- One city crossed 50k pop threshold:
 - Dublin (pop. 50,983)
- Two villages are approaching 5k pop threshold to become cities:
 - Ashville (pop. 4,796)
 - Plain City (pop. 4,944)
