I write to bring to your attention the competitive grant application submitted by the City of Columbus for funding in the FY18 Better Utilizing Investments to Leverage Development (BUILD) Discretionary Grant program.

I understand that Columbus, in partnership with the Ohio Department of Transportation and the Mid-Ohio Regional Planning Commission, seeks funding for Phase 4 of the Columbus Crossroads project. The main goal of the project is to improve the interstate 70/71 innerbelt corridor through Downtown Columbus, specifically by rebuilding the Front, High, Third Street, and Fourth Street bridges with caps and gateway features connecting Downtown and adjacent neighborhoods. This phase of the project would also add an eastbound ramp into downtown and retaining walls to allow Livingston Avenue to be converted back to a two-way street. Additionally, the city street grid would be improved upon to include complete street facilities, wider sidewalks and caps on bridges crossing the interstates, and streetscaping.

Assistance from your agency would improve safety at three of Ohio's top crash locations, remove bottlenecks, and reduce the need for weaving and lane changes by 70 percent. Further, as the largest job center in Central Ohio, improving access to Downtown would allow Columbus to continue its economic growth and leverage existing infrastructure.

As the U.S. Department of Transportation considers applications for the Better Utilizing Investments to Leverage Development (BUILD) Transportation Discretionary Grant Program, I would like to draw your attention to the City of Columbus's application for Phase 4 of the Columbus Crossroads project. Phase 4 of the Columbus Crossroads project will improve the I-70/I-71 Innerbelt corridor that passes through Downtown Columbus.

This phase of the project would improve the safety in Columbus, Ohio, the state's fastest growing metropolitan area. It would reduce the need for weaving and lane changes on these arteries by 70 percent, remove bottlenecks, reduce congestion, and improve the safety at three of the state's top 10 crash locations.

Further, the project would make improvements to the city grid, providing complete streets, streets aping, and wider sidewalks and caps on bridges that cross the interstates. This phase of Columbus Crossroads would facilitate the rebuilding of four bridges that cross the interstates (Front, High, 3rd, and 4th street bridges), providing gateways and caps to better connect Downtown Columbus with the adjacent neighborhoods and would allow for improved bike and pedestrian connections. This project would also build a new eastbound ramp into Downtown and build retaining walls that will allow Livingston Avenue to be converted back to a two-way street and open up 1.5 acres of key real estate for development.

The Columbus Crossroads project has widespread regional support and this application is supported by the Ohio Department of Transportation (ODOT), the Mid-Ohio Regional Planning Commission (MORPC) and a number of diverse community stakeholder and business entities. It was identified as a "top priority" for the region through the Competitive Advantage Projects initiative of Columbus 2020 and MORPC that is working to advance strategic infrastructure investments across Central Ohio.





The purpose of this letter is to express Columbus City Council's strong support for the City of Columbus grant application for Phase 4 of the Columbus Crossroads project. Columbus Crossroads casts an ambitious vision for the freeways and urban avenues that connect the Columbus region, specifically improving the I-70/I-71 Innerbelt corridor through Downtown Columbus. Not only does this project improve safety on the mainline interstates at three of Ohio's top 10 crash locations, Phase 4 includes significant upgrades to the city grid including complete street facilities, wider sidewalks and caps on bridges crossing the interstates, and streetscaping.

Decades ago the neighborhood immediately north of downtown, the Short North, was cut off by I-670. Pedestrians would avoid traveling from downtown to this underutilized commercial stripe except by car. With visionary leadership from public and private sectors, Columbus came together to cap the highway, including infrastructure for commercial development. Today, the Short North is the most popular visitor destination in Columbus, contributing to Central Ohio's population and economic growth. The caps for S. High Street and S. The purpose of this letter is to express our support for the City of Columbus, Ohio grant application for Phase 4 of the Columbus Crossroads project. Columbus Crossroads casts an ambitious vision for the freeways and urban avenues that move through and connect the Columbus region, specifically improving the I-70/I-71 Innerbelt corridor through Downtown Columbus. The Ohio Department of Transportation (ODOT), along with partners at the City of Columbus, the Mid-Ohio Regional Planning Commission (MORPC), and a diverse group of community stakeholders and business entities have collaborated to develop and implement this vision over the last decade.

ODOT, Columbus and MORPC have already invested nearly \$380 million in the I-70/I-71 Columbus Crossroads Project, including planning, engineering, right of way acquisition and construction of the phases completed to date. This includes \$285 million in Federal Transportation and Attributable funds, \$66 million in State Transportation funds, \$22 million in GARVEE monies, and more than \$5 million from Columbus.

The Columbus Crossroads BUILD Application is seeking \$20 million for construction costs for Phase 4 of the Columbus Crossroads Project. The City of Columbus has requested ODOT be the primary recipient of any BUILD grant funding awarded, and ODOT has agreed to be the primary recipient of any BUILD grant funding awarded for Phase 4.

The total project cost for Phase 4 is estimated to be \$224 million. This total cost will be shared by ODOT and its partners. The City of Columbus has committed \$35.1 million along with \$9.3 million of Attributable Funds through MORPC towards Phase 4's construction. ODOT has committed \$159.3 million in State and Federal Transportation funds for Phase 4's design engineering, right of way acquisition, construction, and construction engineering. Of the \$159.3 million, ODOT has already expended \$15.3 million on design engineering and right of way acquisition.

Improvements on the mainline interstates will improve safety at three of Ohio's top 10 crash locations, remove the need for weaving and lane changes by 70 percent, eliminate bottlenecks, and reduce significant congestion. Additionally, the city street grid will receive major improvements including complete street facilities, wider sidewalks and caps on bridges crossing the interstates, and streetscaping.


Specifically, Phase 4 includes rebuilding four bridges (Front, High, 3rd, and 4th streets) across the interstate trench with caps and gateway features that connect Downtown and adjacent neighborhoods. These bridges are used by more than 30 transit lines that provide more than 30,000 daily trips. This phase also includes a new eastbound ramp into Downtown and construction of retaining walls that will allow Livingston Avenue to be converted back to two-way traffic and 1.5 acres of high-value real estate to be reclaimed for transit-oriented development.

As the largest job center in Central Ohio with more than 100,000 workers, Downtown Columbus is a major economic generator with significant growth potential. Improving commuter access to Downtown is essential to ensuring that jobs remain in the center of the city and leverage existing infrastructure and COTA's transit assets. This investment will support the attractiveness of the C-pass program, an innovative initiative that launched in May 2018 that provides transit passes to Downtown workers through a partnership between downtown property owners, MORPC and COTA.

Additionally, improved bike and pedestrian connections to neighborhoods will help to build a transit-oriented, live-work environment. These investments support the economic vitality of our region, as demonstrated by the return on investment of similar projects at the I-670/US-23 and I-71/I-670 interchanges. These projects have fueled millions of dollars of commercial and community-serving development along North High Street and Long and Spring streets since their completion in 2003 and 2014.


