Columbus Region Coalition Strategic Planning Meeting

On February 5 MORPC staff coordinated and facilitated the Columbus Region Coalition's (CRC) 2019 strategic planning meeting. The goal of the meeting was for each member to share its individual priorities with our federal lobbyists and specify certain areas where the coalition can work collaboratively. This will assist the CRC to be more strategic in its advocacy efforts during this era of divided government at the federal level.

NARC Conference, Hill Visits, & 2019-2020 Public Policy Agenda

MORPC's Officers and Senior Staff attended the annual National Association of Regional Councils in Washington, DC. The MORPC delegation met with seven offices of the Central Ohio Congressional delegation to share MORPC's new public policy agenda and other federal priorities for the region.

Regional Policy Roundtable

The Regional Policy Roundtable discussed completion of the Public Policy Agenda, the state transportation budget, federal priorities, and upcoming energy issues where the Roundtable can collaborate with the Sustainability Advisory Committee.

Motor Fuel User Fee Press

MORPC was featured on *All Sides with Ann Fisher* to discuss and inform listeners on the importance of raising the state's motor fuel user fee and on Channel 10 WBNS regarding the same topic.

State Transportation Budget

MORPC testified to the Ohio Finance Committee on February 28 in support of HB 62 the State Transportation Budget. Highlights included support of an increase of the motor fuel user fee and indexing it to inflation; support of an amendment that would expand and increase the cap on permissive license plate fees for municipalities and townships; and support of an amendment that would provide funds to the six rural transportation organizations in the state and more funding for transit.

INFRA Grant Advocacy

MORPC reached out to federal, state, and local elected officials requesting support of the Columbus Crossroads INFRA grant application. Overall, in collaboration with ODOT and the City of Columbus (the lead applicants), MORPC received 18 letters of support representing 14 organizations, 5 members of Congress, and 20 Ohio General Assembly members.

State Advocacy

On February 26 MORPC met with Rep. Russo and Rep. Crawley to provide MORPC's public policy agenda and discuss the state transportation budget.

Transportation & Infrastructure Development

Metropolitan Transportation Plan

MORPC Team Members are working on three components of the MTP planning process:

- Population and Employment Forecasts for 2050
- Candidate Project Collection
- o Project Evaluation Criteria

Internal reviews of the 2050 population and employment forecasts are underway. Next steps include seeking input from local communities and publishing the forecasts for public comment. The forecasts provide estimates of where people will be living and working in the year 2050 and help to identify needs and demands on the transportation system looking into the future.

Team Members are also reviewing state, regional, and local plans and documents to identify transportation projects already identified through a planning process. These projects are added to a database to be evaluated as a potential regional priority for inclusion in the fiscally constrained MTP. Project collection will continue through the summer, with the opening of an interactive web map to solicit project needs from the public.

To help identify which projects will best help the region reach its transportation goals and targets, Team Members are developing project evaluation criteria to apply to each project,

measuring its impact in each goal area. This criteria will be applied to all candidate projects collected resulting in a draft project list in Fall 2019.

5310 Designated Recipient

MORPC received ten FTA Section 5310 applications for enhancing transportation for older adults and people with disabilities. The total ask was over \$1.8 million with \$1.06 million available. Five projects are recommended for approval by MORPC committees.

Gohio

Team Members presented at the Green Spot business education day. Green Spot students had the opportunity to learn about Gohio Commute and other sustainable programs.

MORPC met with City of Dublin to talk about synergies between city goals and Gohio Commute and how the Gohio Commute program can help local Dublin companies with transportation issues.

Team Members communicated initial planning efforts for the Central Ohio Commuter Challenge with program partners. The Challenge will use educational tactics and gamification to encourage transportation behavior change. Planning efforts will continue in the coming months.

Rapid Speed Transportation Initiative (RSTI)

The consultant AECOM continues to work on separate Purpose and Need Statements for the passenger rail project and the hyperloop project. A draft Purpose & Need statement was submitted for MORPC review on February 22 for the passenger rail project. The consultant narrowed passenger rail route alternatives and provided a map of the potential routes to MORPC for input. A matrix outlining the advantages/disadvantages of each route segment alternative is currently being prepared. The consultant reached out to the freight railroads regarding the EIS study and requested meetings to discuss the initial evaluation of route alternatives.

Hyperloop Feasibility Study

The consultant WSP is working closely with MORPC and Virgin Hyperloop One to identify the preferred hyperloop route. Once confirmation that the route is conducive of facilitating optimal hyperloop average speeds is received, the route will be shared with corridor partners to discuss potential portal (i.e. station) locations.

Central Ohio Rural Planning Organization (CORPO)

Team members are in the process of developing the FY 2020 Draft PWP to submit to ODOT by March 1. The CORPO Team plans to share a newsletter with members by the end of March detailing upcoming events, RTPO status, funding/application deadlines and other useful information. ODOT announced they will be hosting an RTPO Peer Review Workshop in April 2019.

MORPC Attributable Funding

The Attributable Funding Committee (AFC) met February 6th and approved a recommended program of projects for funding, largely concluding the attributable funding cycle. The new commitments represent approximately \$22 million in funding, in addition to previous commitments and cost increases totaling \$183 million. This recommended \$205 million in funding through FY 2025 will be considered for approval by the CAC, TAC, and Transportation Policy Committee in March.

Natural Resources Assistance Council (NRAC)

Final applications for the Clean Ohio Conservation Fund are due March 15. Approximately \$4.2 million is available for the current round.

BUILD

U.S. DOT released the Notice of Funding Opportunity for the FY2019 cycle of Infrastructure for Rebuilding America (INFRA) funding. INFRA provides federal financial assistance to highway and freight projects of national or regional significance, with an estimated \$850 to \$900 million available this round. MORPC is coordinating with local partners to ensure that quality applications are received from the region. Within MORPC's MPO territory, ODOT is expected to submit an application for Phase 4 of the Columbus Crossroads/Innerbelt project and the Village of Sunbury is expected to submit an application for the I-71 and US 36/SR 37/Sunbury Parkway interchange. Within the Central Ohio Rural Planning Organization's territory, the Village of West Jefferson is expected to submit an application for the I-70 and SR 29 interchange in Madison County, branded as "Ohio's Logistics Interchange."

Competitive Advantage Projects

The second round of the Competitive Advantage Projects (CAP) process is complete. In total, 43 projects were identified across ten different counties. The projects range from \$80,000 to over \$1 billion, and total more than \$5.2 billion. The list was first shared during legislative visits in February during the National Conference of Regions. The Committee will meet March 19 to continue work on formation of new working groups and the following 2019 priority projects:

- Creation of a Regional Data Users Group
- CURA Sustainability Observatory
- Regional Municipal Fiber Strategy
- Data Policy Needs Survey & Toolkit

Outreach and Collaboration

The Smart Region Task Force met to discuss deliverables -- the Smart Streets Policy and the Smart Region Playbook. The Task Force also reviewed their 2018 progress and their projected 2019 schedule. The next meeting is March 12.

Team Members and JMT Technology Group are continuing their work on the Paving the Way System Redesign.

MORPC Team Members continue to work on the U.S. Department of Energy's Transportation Energy Analytics Dashboard (TEAD). The dashboard kick-off was February 28.

Team Members continue to work on census mapping with the Ohio Census Advocacy Coalition and recently presented on Census efforts in Central Ohio at the National Conference of Regions.

SmartColumbus Operating System – Aaron Schill will participate in the Segment 4 of the Technical Working Group

MORPC is providing data support to COTA on their First Mile/Last Mile pilot program.

Planning & Sustainability

Complete Streets Review

Team members participated in a Phase 3B review of the Columbus Crossroads project and Stage 3 review of the Northeast Gateway project. Staff suggested recommendations for these projects to improve bicycle and pedestrian access.

Active Transportation Working Group (ATWG):

MORPC established the ATWG to create a forum to discuss regional active transportation opportunities. The ATWG will also guide Team Members in MORPC active transportation projects development and implementation, such as the Technical Assistance Program and Regional Active Transportation Plan. The first ATWG meeting was February 28.

Bicycle & Pedestrian Counts

Team Members facilitated discussions about technology and data collection options with peer MPOs and have begun to explore potential funding opportunities for improving regional multimodal data collection capabilities. Team Members also attended ODOT-hosted Streetlight Insight workshop to learn about available bike/pedestrian data and analytical tools.

Member Assistance

Team Members continued coordination with the Short North Alliance to supply counter equipment and data reports for the monthly Gallery Hop events. Team members also coordinated with the Central Ohio Hospital Council to create a new Trails 2 Health patient info form for a new OSU primary care facility in New Albany.

insight2050

Team Members continued close coordination with the Corridor Concepts project consultant team to draft a comprehensive finding report and implementation guide. The final product is anticipated to be completed by April 2019.

Team Members have completed the Violet Township Community Center project. A final report was submitted to township staff in early February.

Team Members presented an update of the Worthington Complete Streets project to Worthington City Council and provided materials for Worthington's Bike/Pedestrian Plan public engagement events led by the city's consultants. This project is scheduled to conclude by the end of February.

Team Members continue to work closely with staff at Westerville and Delaware to complete products for these communities. Both projects are anticipated to conclude in March.

The Spring 2019 Academy kicked off March 1. The Academy focuses on mobility and the future of transportation. Academy sessions occur each Friday throughout the month of March.

Transportation Safety

MORPC hosted the quarterly meeting of the Ohio Association of Regional Councils (OARC) Transportation Safety Planning working group. The working group discussed how states with a Traffic Records Coordinating Committee (TRCC) can leverage funds from NHTSA. In Ohio, there is \$1.5 million available annually, with a 5-year rollover, to support projects related to

enhancing traffic safety data systems. In addition, the working group noted that the TRCC will be updating its strategic plan this year and discussed how project proposals will need to show a direct nexus to the strategic plan to be eligible for TRCC funds.

The MORPC Team has drafted the Regional Safety Plan based on working group input and guidance. Team Members anticipate submitting the Draft Plan to MORPC Commission during its April meeting.

The 2013-2017 State of Safety Report is complete and will be available on MORPC's website by April.

Sustainable2050

Four more Sustainable2050 members certified their Tier Statuses at the February Commission meeting. Congratulations to Blendon Township (Silver), Grove City (Gold), Whitehall (Silver), and Metro Parks (Gold).

At the first Sustainable2050 meeting of the year, attendees will hear from newly certified members and will learn about the Ohio EPA's Encouraging Environmental Excellence award program. Team Members also engaged with Sustainable2050 Associate Members to have a discussion around the eligible activities for tier status certification and to collect input on additional activities that MORPC should consider since most of the objectives are geared toward local governments.

MORPC was joined by Andrew Kistler of the Columbus Metropolitan Library, Hon. Karen Angelou of the City of Gahanna, and Justin Milam with the City of Upper Arlington for a presentation titled "Sustainable2050: Central Ohio Communities Working Toward a Better Future" at the Ohio State University's Community Engagement Conference.

MORPC provided an overview of Sustainable2050 and the Regional Sustainability Agenda at the kick-off meeting of Dublin's newly formed Sustainability Advisory Team.

Central Ohio Greenways Board

At the next Central Ohio Greenways (COG) Board meeting a key agenda item will include a presentation from the Mollard Consulting team on their finding from the Planning Study. The results from this study will help provide a "case for support" for COG, an internal operational structure evaluation, and an actionable blueprint for engaging future donors and other partners. The results of the study will help guide the working groups' goals for this year. Additionally, the Board has invited a group of OSU graduate students to share their research on programing trail loops.

Central Ohio Water Resources Working Group

The Water Resources Working Group (WRWG) received a policy update at both the State and Federal levels, an update on the happenings in the Central Ohio Watershed Council, and a presentation from Alana Shockey regarding the newly formed Sustainable Columbus initiative. At the working session the group provided input on the activities and educational items for the 2019 Riverfest. The group also identified areas of the 2016-2020 Action Plan that have not yet been achieved, and outlined strategies and activities to help achieve the objectives of the Action Plan. The group meets again in March.

Central Ohio Water Resources Planning

Team Members attended a meeting with Ohio EPA and the Madison County Commissioners and administrative staff to discuss the Central Ohio Water Resources Planning effort and its

facility planning area priorities. Team Members are finalizing the Region 1 Plan to be submitted to Ohio EPA first quarter.

Energy & Air Quality

Air quality

Team members finalized the joint marketing plan with Gohio Commute staff for the 2019 calendar year and are in preparations for the kick-off of Ozone Season beginning March 1. The Idle Free Schools program received media coverage by 10TV news, and Air Quality staff served as the local air quality expert for the interview.

Energy & Air Quality Working Group

MORPC is supporting current members in personally inviting new and previously engaged members to the upcoming meeting in March. Allegra Wiesler of Ohio Health is the planned featured speaker and Joe Garrity will lead a discussion on energy and air quality relevant policy.

Local Government Energy Partnership

MORPC partnered with JadeTrack to provide an online dashboard to benchmark building performance. This tool allows participants to collect and visualize utility data to identify energy saving opportunities across all publicly-owned buildings and fleets. The pilot phase wrapped up in 2018 and this service is available at no cost to all MORPC members and Associate Members. This information was presented at the February 14, 2019 Commission meeting.

Training will be provided to develop the dashboard, and on-going support will be available. MORPC anticipates creating five dashboards per month. AEP-Ohio and Columbia Gas utility data is automated, and for all other utility providers the data will need to be entered manually. MORPC will roll out additional offerings later in 2019 under the Local Government Energy Partnership program, including an Energy Academy, Energy Consortium, and a Recognition Program.

City of Columbus Greenhouse Gas Inventory

MORPC held several training sessions with City of Columbus staff to prepare them for completion of the inventory. MORPC and City of Columbus staff are collaborating on data collection and data management efforts.

Sustainability Advisory Committee

The Sustainability Advisory Committee welcomed five new members. Glenn Taylor, Chief Sustainability Officer with COTA, was featured in the new member spotlight and presented information about COTA's commitment to sustainability with examples of their accomplishments around waste reduction and increasing ridership through several initiatives. The SAC approved the silver tier status designation for Blendon Township and discussed recommendations to consider updating the meeting format. MORPC updated the members about the partnership with the OSU Center for Urban and Regional Analysis to develop an interactive dashboard to visualize the Regional Sustainability Agenda metrics. WarmChoice

Initial and completion inspections are keeping up with, and currently exceeding YTD goals; however, we are still experiencing a severe lull in new applications.

Team Members attended a conference call with COH and other providers regarding the problems all are experiencing with the new Mi-apps software. Currently, all providers are under direction to revert to using the previous software (Mi-forms) until the issues are corrected and the new software is stable.

HWAP (Home Weatherization Assistance Program)

HWAP is currently on track.

ODSA has clarified the need to spend out Enhancement funds first. Spend-out priorities will now be (1) Enhancement, (2) DOE, and (3) HHS.

AEP-CAP

AEP approached MORPC to do a promotional interview and video. AEP will also film a contractor installing insulation in a home receiving AEP-CAP funding. Team Members also suggested an emphasis on the partnership MORPC has with IMPACT and the value of leveraging our combined resources.

OPAE confirmed the 2019 funding level will be at the \$300,000 level, with contract amendments addressing the increased allocation for 2018, and program changes as specified by AEP.

Home Repair Programs

The City of Columbus submitted a project amendment for NSP. The first unit has sold, and final payment was requested. Homeport is wrapping up punch out work on the second project and processing a potential buyer.

The Milo Grogan Area project with Homeport funding was extended into 2019.

The COCIC funded exterior home repair pilot was approved to continue for 2019.

Leadership Development Program

MORPC kicked off the third year of our Emerging Leaders Program for ten of our Team Members. The program includes workshops, coaching, mentoring, and an action learning project. The four workshops will be completed in the first half of the year, with the project work to be completed in the second half.

Information Technology

MORPC is partnering with KnowBe4 to launch a security awareness program to educate staff in cyber security through periodical video trainings, tests, recommended best practices and additional resources. The first mock phish test was sent in late 2018. As a result of the test, the first educational video was sent to "phish prone" users in February. All MORPC staff received the newly designed video training "2019 Common Threats" training to help guard MORPC's digital infrastructure.

As part of MORPC's new Computer Refresh Lifecycle Policy, launched November 2018, the MORPC IT team is replacing the oldest units in each department with laptops. Thirty-two units are being replaced this year.

In December 2018, the Commission authorized the executive director to enter into a lease amendment. Resolution 29-18 authorized a possible shift in space up to an additional approximately 1,300 square feet and could include additional costs up to \$120,000 per year with periodic increases.

Since the passage of Resolution 29-18, the shifted space option closed but a different expansion opportunity has presented itself that provides additional meeting and event space. This would allow more usable and functional space for our current space. The lower level of our building, the subject of this resolution, would allow for an increase in meeting and event space. The net cost would be fractional as we intend to enter into a sublease to share the lower level.

The cost for the additional space is still under negotiation, but is anticipated to be no more than \$22.39 per square foot in the approximately 5,400 square feet on the lower level with annual increases, including tenant improvement funding. For consistency with anticipated work to be managed by MORPC in our current space, MORPC may manage and pay for all or part of the tenant improvements and be reimbursed by the landlord for the payments. The anticipated term will be through October 31, 2027, with a five year renewal option, to align with MORPC's current lease plus renewal options.

MORPC's building fund was created in 2007 after the sale of the 285 East Main Street property. The proceeds of the sale were invested and partially reallocated, with approximately \$1 million remaining in the building fund.

MORPC renewed its current lease for a term of November 2017 through October 2022, with two additional five year renewal options remaining. In March 2018, the building ownership changed. The new owner is interested in MORPC having improved space. After consideration of options available, including a lease amendment, MORPC staff have determined that it is much more cost effective to improve the space with MORPC funds if available.

This resolutions seeks authorization to use the building fund for the purpose of upgrading the current space. After consultation with our broker obtaining assistance with initial space planning, staff anticipate this to include new carpet and paint, improved lighting, structural and other layout changes, space branding and more. To assist further with the space planning and execution, MORPC staff intend to hire an architecture firm and a construction and project management firm. Costs for these external experts were included in the 2019 budget approved in December.

MORPC staff also recommend that the building fund be replenished over ten years back to \$1,000,000. This is planned to occur by adding an average of ~\$100,000 annually back to the fund via member dues. MORPC staff does not anticipate increasing member dues for this purpose, seven cents per capita of which are used for building purposes currently. It is anticipated that indirect funding will cover more of the lease cost as a result.

- Section 1. That the executive director is authorized to use up to \$1 million from the MORPC building fund for space upgrades and improvements in a manner consistent with MORPC's bylaws and procurement policies.
- Section 2. That by the end of 2029 the building fund will be replenished to at least \$1 million by adding approximately \$100,000 to the fund per year beginning in 2020, unless otherwise determined by the Commission.
- Section 3. That following completion of the space upgrades, the Reserve & Investment Advisory Committee will reconvene to review the MORPC operating and capital reserve strategies.
- Section 4. That the executive director is authorized to take such other action and execute and deliver such other documents as, acting with the advice of legal counsel, he shall deem necessary and appropriate to carry out the intent of this resolution.

EXECUTIVE SUMMARY

The MORPC 2019 revised operating budget is \$19,078,175, an increase of \$1,000,000 (5.5%) from the original 2019 budget of \$18,078,175. This increase is the result of including \$1,000,000 from Building Reserve fund.

The \$1,000,000 will be available to be used to further enhance MORPC's work and meeting environment. Space planning efforts are under way as new furniture and space renovation is planned for 2019.

No revisions to member dues, indirect cost allocation budget, or the schedule of subcontractors are necessary for this revised budget.

SOURCES (Funding Sources - Page 7)

Total 2019 revised Sources increased by \$1,000,000 from \$18,078,175 to \$19,078,175 and is reflected in the Local and Other funding category for new furniture and leasehold improvements. The additional sources come from the building fund.

USES (Page 2)

The Services and Charges budget line increased by \$1,000,000 from \$4,105,018 to \$5,105,018 to cover the new furniture and leasehold improvements.

CAPITAL EXPENDITURES (Page 2)

The revised capital expenditures budget for 2019 increases by \$1,000,000 from \$733,500 to \$1,733,500. This budget includes an additional \$1,000,000 for furniture and leasehold improvements.

USE OF MEMBER DUES (Page 3)

There is no change in the uses of member dues.

APPROPRIATIONS (Page 4)

The revised 2019 appropriations closely mirror the agency operating expenses and capital expenditures, coming in at \$19,733,975 for 2019.

SUBJECT: Proposed Resolution 03-19: "Supporting House Bill 62: State Transportation

Budget"

One of MORPC's chief public policy goals is to achieve an advanced, inclusive, and exceptional transportation system that connects Central Ohio's people and products to the world. In working to achieve this goal, we collaborate with districts of ODOT to implement transportation projects throughout our region. We know first-hand of the unmet need for transportation funding requests. For example, MORPC currently has about \$25.8 million in federal funding available during our current round, but \$180 million in requests around Central Ohio that cannot be funded. It also has \$29 million in public-works dollars for Franklin County to address \$50 million in requests. This gap in funded projects represent a range of deferred maintenance, needed expansion, and upgrades critical to economic development and safety.

The preliminary budget plan for fiscal years 2020 and 2021 is troubling. The vast majority of revenues are allocated for maintenance rather than increasing capacity. This is demonstrated by the decreasing size of the ODOT capital program from a high of approximately \$2.4 billion in fiscal year 2014 to approximately \$1.7 billion in fiscal year 2020. In order to meet its requirement to present a balanced budget, ODOT is expected to make an across the board ten percent cut to discretionary funds. The anticipated reductions will eliminate funding for new projects aimed to adding capacity and relieving congestion on Ohio roads, as well as delay needed maintenance and upgrades to existing bridges and roadways.

A cutback in transportation investment will have a negative ripple effect throughout the state and Central Ohio is no different. Reduced funding will also worsen economic costs of congestion. For Central Ohio, MORPC estimates congestion to cost over \$921 million annually due to travel delay and excess fuel consumption as well as health impacts from reduced air quality. Poor road conditions from deferred maintenance cost each driver an estimated \$533 annually.

We have a transportation funding crisis on our hands and we must act now. In order to address this issue, MORPC supports Governor DeWine's increase to the motor fuel users' fee. With the advent of alternative fuel vehicles the motor fuel users' fee may not be as representative or as fair a fee as in

the past. However, until new mechanisms are developed nationally the fee is the most convenient collection mechanism since it is has been in place since 1925.

In a major collaborative effort last year, a group of MORPC community leaders and elected officials – rural, urban, and suburban representing each level of local government - met to create a working document of state policy recommendations that address current transportation maintenance needs and also plans for future mobility needs. MORPC staff will continue to advocate for these diverse recommendations to be adopted.

We commend Governor DeWine and ODOT Director Marchbanks for their leadership in crafting a budget that addressees the state's urgent need for sustainable transportation funds. We strongly advocate for solutions to help all of Ohio's rural, suburban, and urban communities and each region's unique needs. This is a period of rapidly changing transportation technology, but we can't get to the future of transportation if we can't fund the basics for our roads and bridges.

"Supporting House Bill 62: State Transportation Budget"

WHEREAS, Governor DeWine's proposed state transportation budget, House Bill 62, increases the motor fuel user fee and indexes it to inflation to help maintain our local roads and bridges; and

WHEREAS, the Ohio Constitution requires that 40 percent of revenue from the motor fuel user fee is dedicated to the construction and maintaining of local roads and bridges; and

WHEREAS, MORPC supports an offered amendment expanding the permissive vehicle license fee cap for municipalities and townships to assist basic maintenance needs; and

WHEREAS, MORPC supports increasing state funding for public transit; and

WHEREAS, MORPC supports an offered amendment creating a pilot program allocating \$1 million to each RTPO, and with modified scoring criteria to advance critical infrastructure programs throughout rural Ohio; and

WHEREAS, MORPC is committed to collaborating with the Ohio Department of Transportation, the General Assembly, and regional partners in maintaining and improving mobility options for residents; and

WHEREAS, Governor DeWine's proposed HB 62 is consistent with MORPC's 2019-2020 Public Policy Agenda in achieving an advanced, inclusive, and exceptional transportation system that connects Central Ohio's people and products to the world; now therefore

BE IT RESOLVED BY THE MID-OHIO REGIONAL PLANNING COMMISSION:

- Section 1. That MORPC supports Governor DeWine's proposed transportation budget HB 62.
- Section 2. That MORPC will work with its local government members and partners to educate state legislators on the important benefits of passing HB 62 to address the state's unmet transportation needs.
- Section 3. That the executive director is authorized to take such other action and execute and deliver such other documents as, acting with the advice of legal counsel, he shall deem necessary and appropriate to carry out the intent of this resolution.
- Section 4. That this Commission finds and determines that all formal deliberations and actions of this Commission concerning and relating to the adoption of this resolution were taken in open meetings of this Commission.

Meeting Called to Order

Chair Rory McGuiness called the Transportation Policy Committee Meeting to order at 2:04 p.m.

Metropolitan Planning Organization Report

• Transportation & Infrastructure Development – Thea Walsh, MORPC Transportation & Infrastructure Development Director

Thea Walsh reported MORPC Team Members William Murdock, Thea Walsh and Joe Garrity were in Washington, DC on January 28 with Virgin Hyperloop One executives to visit with congressional delegates to help find a regulatory home for Hyperloop.

The scoring round for 2019-2025 Attributable Funds projects is complete. The recommendations will go through public involvement once approved by the Transportation Policy Committee.

MORPC Team Members are developing a Western Fairfield County and Licking County Thoroughfare Plan for traffic moving between New Albany and Violet Township. The plan is expected to be complete in six to eight months.

The Rickenbacker Area Study is coming to a close. The results of the comprehensive study will be shared soon via a joint release with the Columbus Regional Airport Authority.

Central Ohio projects applying for the Infrastructure for Rebuilding America (INFRA) funding include:

- Phase 4 of the Columbus Crossroads/Innerbelt project submitted by ODOT
- I-71 and US 36/SR37/Sunbury Parkway interchange submitted by the Village of Sunbury
- I-70 and SR 29 interchange in Madison County submitted by the Village of West Jefferson

Final results for the insight2050 Corridor Study will be released in April.

Data & Mapping – Aaron Schill, MORPC Data & Mapping Director
 Aaron Schill presented the <u>Data & Mapping Update</u>. Mr. Schill will give regular updates
 on the 2020 Census. Work continues on updating census boundaries and addresses.
 The City of Columbus and Franklin County are launching their joint Complete Count
 Committee on March 6. MORPC is chairing the Local Government Subcommittee and
 will expand the work of the Complete Count Committee to other Central Ohio counties.

Key features of the redesigned Paving the Way System include:

- o Information on entire projects and individual closures
- o Ability for local agencies and contractors to manage project information
- Detailed project mapping
- Enhanced notification options
- Expanded geographic coverage

Commitments"

Proposed Resolution T-2-19 completes the biennial process of soliciting, reviewing and recommending requests for MORPC-attributable transportation funding. Attachment 1 to the proposed resolution is a summary of all the recommended commitments of MORPC-attributable funding for SFY 2020 and beyond.

Each year MORPC receives an allocation of approximately \$35 million of federal transportation funds for use in Central Ohio. MORPC-attributable funds come from three federal programs, which originated with ISTEA and continued under TEA-21 - SAFETEA-LU, MAP-21 and now the FAST Act. These programs are:

- Surface Transportation Block Grant (STBG), formerly the Surface Transportation Program (STP)
- Congestion Mitigation and Air Quality Improvement Program (CMAQ) part of large MPO CMAQ program
- Transportation Alternatives Program (TAP)

MORPC adopted its updated polices for allocating and managing MORPC-attributable funds by the passage of Resolution T-5-18. MORPC staff solicited and received applications for these funds during the summer of 2018. Over the past several months, the Attributable Funds Committee and staff members have been evaluating the applications to make funding recommendations.

With regard to CMAQ funding, staff will work within the large MPO CMAQ program process to secure the CMAQ funding. MORPC works with the other seven large MPOs to select projects for the large MPO CMAQ program. The commitments in this resolution reflect the results of the MORPC process.

The funding recommendations were made available for public review and comment from December 18, 2018, to January 18, 2019. MORPC received comments on the majority of recommended projects, most of which were in favor of funding for the projects. The Olentangy Trail project received the most comments, with 10 comments in favor, two opposed, and one neutral. Given the nature and quantity of the comments received, the funding recommendations were not adjusted.

Several projects in the portfolio of MORPC-Attributable Funding projects are anticipated to be ready for construction ahead of the fiscal year in which funding will be available. Accordingly, the resolution directs staff to work to identify solutions to make funding available earlier when projects are ready. This could include working with the sponsor on a financing mechanism and/or pursuing a loan from another metropolitan planning organization in the state.

In summary, as shown in the table below, Resolution T-2-19 commits approximately \$205 million in MORPC-attributable federal funding for SFY 2020 and beyond. This is for 41 projects or activities throughout the MORPC transportation planning area, 33 of which are continuations of previous commitments or significantly increased funding commitments and eight of which are new commitments.

RESOLUTION T-2-19

"Adopting MORPC-Attributable Funding Commitments"

WHEREAS, the Transportation Policy Committee of the Mid-Ohio Regional Planning Commission is designated as the Metropolitan Planning Organization (MPO) for the Columbus metropolitan planning area; and

WHEREAS, the MPO is responsible for allocating certain federal transportation funds that are attributed to it; and

WHEREAS, the Transportation Policy Committee adopted Resolution T-10-97, "Principles for Allocation of MORPC-Attributable Federal Funding," in order to fairly allocate these funds in conformance with federal and state laws and regulations; and

WHEREAS, it most recently adopted revised management tools in the Policies by Resolution T-5-18, "Adopting 'Policies for Managing MORPC-Attributable Funds'"; and

WHEREAS, in accordance with these principles, in June 2018 project applications were solicited to use MORPC-attributable funding, and the applications received were reviewed by MORPC staff and the Attributable Funds Committee; and

WHEREAS, a draft list of MORPC-attributable funding recommendations was released for public review and comment on December 18, 2018, with the public comment period ending on January 18, 2019; and

WHEREAS, MORPC staff and the Attributable Funds Committee reviewed the comments received, made minor adjustments to project costs and schedules, and updated expected MORPC-attributable funding available; and

WHEREAS, the projects, as shown in Attachment 1, are consistent with the transportation policies, plans, and programs, including the most recent Metropolitan Transportation Plan adopted by the Policy Committee; and

WHEREAS, with regard to CMAQ funding, MORPC will work within the large MPO CMAQ process to secure CMAQ funding for CMAQ-eligible projects; and

WHEREAS, to maintain fiscal balance, funds for construction of some projects are committed for a later State Fiscal Year (SFY) than when the project sponsor is currently expecting the project to be ready for construction; and

WHEREAS, the Community Advisory Committee at its meeting on March 4, 2019 and the Transportation Advisory Committee at its meeting on March 6, 2019, recommended approval of these funding commitments to the Transportation Policy Committee; now therefore

BE IT RESOLVED BY THE TRANSPORTATION POLICY COMMITTEE OF THE **MID-OHIO REGIONAL PLANNING COMMISSION:**

- Section 1. That it commits to allocating its attributable federal funding to the projects in the attached program of projects at the amounts and schedules shown in Attachment 1 pending continued availability of MORPC-attributable federal funding at the levels needed for the program.
- Section 2. That staff prepare an amendment to the State Fiscal Year 2018-2021 Transportation Improvement Program (TIP) consistent with the attached program of projects using MORPC-attributable funds through SFY 2021.
- Section 3. That it directs staff to prepare partnering or other appropriate agreements with project sponsors outlining the MORPC-attributable funding commitment.
- Section 4. That it directs staff to continue to actively participate in the large MPO CMAQ process to ensure the projects eligible for CMAQ shown in Attachment 1 receive CMAQ funds through the large MPO CMAQ process.
- Section 5. That it directs staff and project sponsors to attempt to provide construction funds when the project is ready through the management of the program and various financing mechanisms.
- Section 6. That this resolution will be transmitted to ODOT and all local agencies listed as sponsoring agencies in the attachments for appropriate action including ODOT reflecting the updated costs and schedules in Ellis.
- Section 7. That it directs MORPC staff to update, if necessary, the project information, including costs and schedules and the expected MORPC-attributable funding available prior to the adoption of the SFY 20-24 TIP in May 2020.
- Section 8. That it emphasizes the importance of the project sponsors maintaining the project schedule and remaining within the current cost estimates, as there is no guarantee that additional MORPC-attributable funding or statewide CMAQ funding will be available should costs increase or the project be delayed.
- Section 9. That the Transportation Policy Committee finds and determines that all formal deliberations and actions of this committee concerning and relating to the adoption of this resolution were taken in open meetings of this committee.

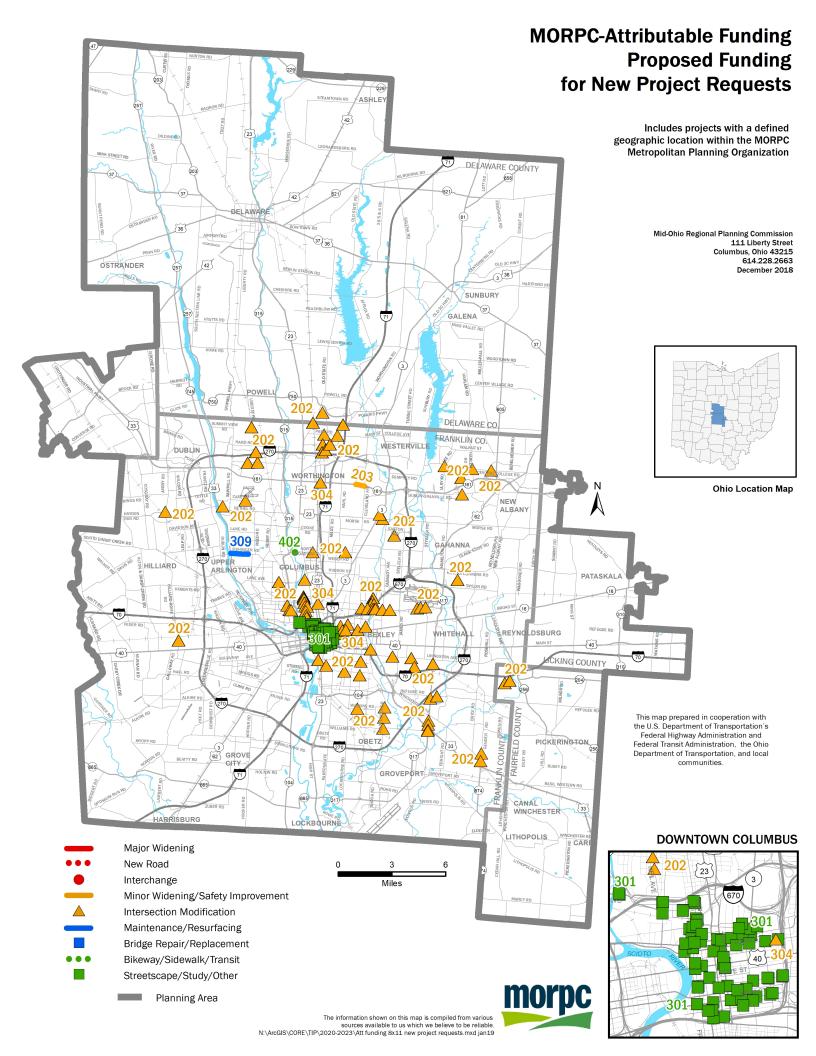

SUBJECT: Proposed Resolution T-3-19: "Amending the State Fiscal Year

(SFY) 2018-2021 Transportation Improvement Program"

Proposed Resolution T-3-19 will add or modify fourteen projects on the SFY 2018-2021 Transportation Improvement Program (TIP) with commitments totaling over \$220 million. This amendment includes MORPC's funding awards for the Federal Transit Administration (FTA) Section 5310 Enhanced Mobility for Seniors and Persons with Disabilities program. These changes are necessary to enable these projects to advance and to maintain fiscal constraint. In April, the Ohio Department of Transportation (ODOT) will ask the Federal Highway Administration (FHWA) and the FTA to amend the Statewide TIP to include these changes.

Attachment 1 to the resolution provides a description of the funding and scope of each project, including a description of the bicycle and pedestrian components. Attachment 2 maps those projects with a physical location. Nine of the projects have a commitment of MORPC-attributable funds. The changes with regard to MORPC-attributable funding are consistent with the adoption of MORPC-attributable funding commitments via resolution T-2-19.

An explanation of the proposed changes to the TIP follows.

<u>Bexley</u> has requested an increase in MORPC-attributable funding for the Bexley Signals Interconnect (PID 99789).

<u>Columbus</u> has requested the addition of the Morse Road from Seward to Stygler minor widening project (PID 106390) to the TIP.

<u>COTA</u> has requested the addition of the First/Last Mile Pilot Program (PID 106390) to the TIP using MORPC-attributable funds and local funds.

<u>Delaware County</u> has requested to apply for a State Infrastructure Bank loan to advance the construction of the Cheshire Road and Africa Road from Old State to Lewis Center resurfacing project to SFY 2020. The loan will be repaid with MORPC-attributable funds.

<u>Grandview Heights</u> has requested an increase in MORPC-attributable funding for the Grandview Heights Signals Interconnect (PID 99738).

<u>MORPC</u> requested the addition of the insight2050 Technical Assistance Program, FY 2020 to the TIP.

ODOT District 6 requested the following modifications to the TIP:

- Adding debt service for GARVEE (Grant Anticipation Revenue Vehicle) bonds to Phase 2E of the I-70/I-71 Innerbelt projects (PID 105322).
- Adding debt service for GARVEE bonds to Phase 4R of the I-70/I-71 Innerbelt projects (PID 105523) and incorporating the replacement of I-70 and I-71 bridge decks over SR-315 (planned under PIDs 105430 and 105437) into the same project.
- Adding right-of-way (ROW) funding to the US-42 and Industrial Parkway minor widening project (PID 107822).
- Adding the US-42 and US-33 interchange modification (PID 109519) to the TIP, splitting it from PID 107822

<u>Powell</u> has requested to apply for a State Infrastructure Bank loan to advance the construction of the Sawmill Parkway from Seldom Seen to Home resurfacing project (PID 105806) to SFY 2020. The loan will be repaid with MORPC-attributable funds.

<u>Upper Arlington</u> has requested the addition of MORPC-attributable funding to the ROW phase for the Fishinger Road from Mountview to Tremont reconstruction project (PID 105816).

Whitehall has requested an increase in MORPC-attributable funding for the Whitehall Signals Interconnect (PID 99827).

MORPC requested the addition of the FTA's Section 5310 Enhanced Mobility for Seniors and Persons with Disabilities program to the TIP. See additional detail below.

After soliciting projects from December 2018 to February 2019 and receiving over \$1.8 million in requests, MORPC staff identified administrative, operating and capital projects for funding totaling over \$1 million (PID 109918). Attachment 3 to the resolution provides FTA's standard program of projects (POP) selected. Selected projects' federal amounts are listed below. These projects are receiving 80 percent of the project funding, requiring a 20 percent match unless noted.

- 1. Central Ohio Transit Authority (COTA):
 - a. Operating Costs: \$337,684 (50% Match)
 - b. Miscellaneous Capital to Purchase Transportation: \$260,000
- 2. <u>Delaware County Transit Board (DCTB) operated by Delaware Area Transit Agency (DATABus):</u>
 - a. Operating Costs: \$35,774 (50% Match)
 - b. Three years of software: \$110,029
 - c. Capitalized Maintenance: \$94,191

- 3. City of Dublin: Older Adult/Individuals with Disability Shuttle, \$25,000

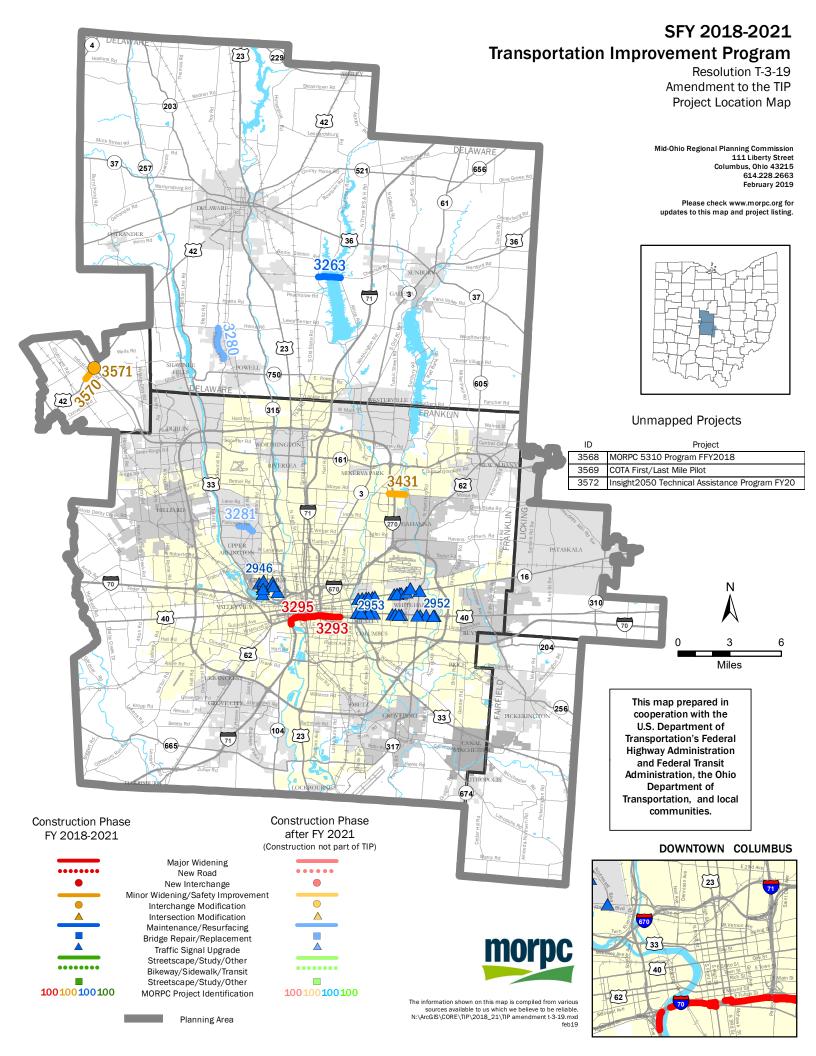

Meeting Called to Order - Rory McGuiness (City of Columbus), MORPC Chair

Chair Rory McGuiness called the Commission meeting to order at 1:34 p.m. Chair McGuiness led the Commission in a moment of silence for former MORPC member and City Manager of Upper Arlington Ted Staton. Mr. Ted Staton served on the Commission from 2011 to December 2018.

Chair McGuiness announced that MORPC Executive Director William Murdock is unable to attend today's meeting due to illness.

Chair McGuiness recognized guests and new representatives: Andy Shifflett, Kegler Brown Hill + Ritter; Andy Teater, City of Hilliard; Dave Gulden, City of Pickerington; Scott Owen, Perry County; Andy Ware, Morrow County; and Tom Whiston, Morrow County.

A group of MORPC Officers and Team Members just returned from the National Association of Regional Councils (NARC) National Conference of Regions in Washington, DC. Chair McGuiness reported this was his fifth trip, but the first time he has returned thinking something might happen on transportation funding at the federal level.

The City of Columbus is now incentivizing development and affordability in their neighborhoods. The City is working with MORPC and other regional partners to create a Regional Affordable Housing Plan. Chair McGuiness invited communities to participate.

<u>Executive Director's Report</u> – Shawn Hufstedler, MORPC Chief of Staff & Director of Operations

Shawn Hufstedler reported that MORPC Officers and Team Members met with members of the Central Ohio delegation while at the NARC Conference in Washington, DC.

The new MORPC brand is being rolled out and integrated as we move along. The new logo represents MORPC's innovative focus areas, departments, range of members, and diverse parts of the region coming together to make Central Ohio a better place. The logo re-design was developed by MORPC's Digital Communication Coordinator Hannah Schumick.
