PROJECT FUNDING UPDATES

The Franklin County Transportation Improvement District applied for ODOT TID Supplemental Funding in the spring of 2021 for the Rohr Road Corridor Improvements Project. This project aims to efficiently construct the necessary transportation improvements to support the rapid economic development along the corridor and the surrounding Rickenbacker Area. The FCTID was awarded \$68,000 for detailed design in SFY 2022.


The Franklin County Engineer's Office applied for OPWC assistance for the SR 317 at Rohr Road Improvements Project in the Fall of 2021. This project will receive a grant of \$1,942,750 for construction in SFY 2023. Additionally, the FCTID has committed \$450,000 to this project.

CONSTRUCTION BEGINS ON 50 E. MOUND STREET PARKING FACILITY

In coordination with the Franklin County Board of Commissioners, the FCTID has executed contracts for the construction of a new surface parking facility at 50 E. Mound Street. Construction of this project has begun and is expected to be completed by July of 2022. This facility will support the parking needs of Franklin County's Downtown Complex. This project is expected to cost \$1,023,159.20 and will be paid for with money made available to the FCTID by the Franklin County Board of Commissioners.

The 50 E. Mound Street parking facility is the second phase of the Franklin County Parking Facilities Improvement project. Future phases will address parking and building access issues caused by construction of ODOT's I-70/I-71 Phase 4R/6R project, which is set to begin in Spring of 2022.
