### Demographics

Aaron reported that the Survey will gather demographics such as jurisdiction type (city, village, township, county), generalized role of the respondent, and size of the municipality (either population or staff size). The responses will be grouped based on the size. If it is population-based, it would be a range, probably only 50,000+ at the highest. The ranges will be such that there will not be obvious outliers. The objective is to have groupings of small, medium, and large entities.

### Discussion

Members discussed and agreed that the four-point scale of prioritization discussed on November 25 will be used on the Survey. The goal is to not only understand the respondent's priorities, but also to find out what the respondent wants or needs in the Toolkit. Members discussed location of the priorities question: (1) at the bottom of each domain page, or (2) at the end of the Survey in a drop-down list. Members agreed to inquire about the respondent's priorities regarding digital equity, access, inclusion, and diversity.

Members also agreed that focus groups will be needed for final clarification after the Survey results have been analyzed.

### **Coordinate Delivery of the Toolkit with other Spring 2020 MORPC Releases / Events**

Aaron has requested that MORPC department heads identify projects and key deliverables being released in Quarters 1 and 2 of 2020. He also suggested coordinating the release with other key events in the region, and asked members to check with their municipalities for upcoming key events. Members agreed to discuss a release date at the January 7 meeting.

## Survey Question Domains

The Working Group discussed domains for the survey questions, and decided that each domain would have approximately ten questions related to it.

The proposed domains are:

Data Governance

- Personnel
  - Security (internal and third-party security)
  - Ethics
  - Privacy
  - Compliance

Data Management (how the data is organized; how it is kept secure)

- Inventory/Documentation
  - Storage/Retention
  - Disaster Prevention
  - Public Records and Access

## Data Sharing

- Data Sourcing/Ingestion (inbound)
  - Licensing/Contracting (agreements or restrictions on the ability to license data from third party providers)
  - Provisioning (outbound)
  - Open Data (providing data to the public)

Members agreed that after each question, the respondent will be able to pick one of four options to describe their priority: option 1 indicates that the respondent plans to address the subject within 12 months, option 2 – 12-24 months, option 3 – 24-36 months, option 4 – subject will not

be addressed in the foreseeable future. The group hopes to summarize the responses and (as an example) identify that jurisdictions of a particular size tend to have one set of characteristics, villages and townships tend to have another set of characteristics, etc. This type of summary will necessitate knowing the role of the respondent.

(n.) (1) The process of providing users with access to data and technology resources. The term typically is used in reference to enterprise-level resource management. Provisioning can be thought of as a combination of the duties of the human resources and IT departments in an enterprise, where (1) users are given access to data repositories or granted authorization to systems, applications and databases based on a unique user identity, and (2) users are appropriated hardware resources, such as computers, mobile phones and pagers. The process implies that the access rights and privileges are monitored and tracked to ensure the security of an enterprise's resources.

(2) The process of providing customers or clients with accounts, the appropriate access to those accounts, all the rights associated with those accounts, and all of the resources necessary to manage the accounts. When used in reference to a client, provisioning can be thought of as a form of customer service.
