Meeting Called to Order at 9:03 am.

Welcome & Group Administration

Members and staff introduced themselves.

Outcome of Presentation at November 1 COMMA Meeting

Chair Oliver reported that the members of the Central Ohio Mayors & Managers Association reacted positively to the presentation. Members asked that the Working Group continue its work and to provide more details of the plans regarding shared broadband infrastructure. Aaron Schill discussed the need for non-disclosure agreements (NDA) between the cities and MORPC.

Tasks and Timeline

Broadband

Working Group members discussed what is needed to move forward:

- a network model
- to know what entity will light the fiber
- a budget (Members will develop a budget and share that budget with interested parties.)
- to understand what data will be shared

The NDA will obtain clearance from cities to commit to sharing fiber information, which will result in further development of the current map.

Todd Jackson suggested creating a sub-group to meet separately and advance this discussion on a separate timeline. Members agreed. Todd Jackson will lead the sub-group. The sub-group, Fiber Network Working Group, will refine use cases and definition of scope, roles, timeline, and budgets.

Fiber Mapping

Members agreed that maintaining the fiber map has value, and that MORPC should continue to maintain the map. Members also agreed that the map will show only information that the users

are comfortable with sharing. Fiber location information is shared by agreement and is considered protected information.

The data model will be a user contributed model. Therefore, wherever the fiber map is posted, there will be contact information for a user to request more detailed information.

Members discussed whether MORPC will be the steward of the data, and whether it would be beneficial for MORPC to become a member of <u>Fiber Locator</u>. Fiber Locator will show some of the private fiber available in the region, which can be added to the data provided by municipalities. Sam Orth noted that the City of Columbus data is not on Fiber Locator, as Columbus is not a member.

Other Business

Cadence and Schedule of 2020 Meetings

Cadence of future meetings will be discussed at the January 10 Working Group meeting.
