## What's Happening

### *Ohio General Assembly Primary Sets Stage for November*

In a rare second primary election, 7.9 percent of Ohio registered voters turned out to participate on Tuesday, August 2, to nominate candidates from both major political parties to appear on the November ballot's Ohio General Assembly contests. These primary contests were delayed from the original May 3rd election date due to a series of lawsuits that led to the Ohio Supreme Court invalidating various versions of Ohio House and Ohio Senate maps that had been drawn by the Ohio Redistricting Commission.

Some highlights from Tuesday's contest include:

- » Rep. Bride Rose Sweeney (D-Cleveland) garnered 56.2 percent of the vote to defeat Rep. Monique Smith (D-Fairview Park) in the General Assembly's only head-to-head incumbent matchup for the newly drawn 16th House District Democratic primary. The two were drawn together in redistricting. Sweeney will face Republican Michael Lamb in November.
- » Rep. Mark Fraizer (R-Newark) was one of two incumbent members to be defeated by a challenger, losing a rematch from two years ago to Thaddeus Claggett, a civil engineer and construction contractor who collected 58 percent of the vote in the Republican primary for the 68th House District. Claggett will be unopposed in the General Election.
- » In the other incumbent defeat, recently appointed Rep. Shawn Stevens (R-Sunbury) lost to Beth Lear, the vice president of government affairs for Associated Builders and Contractors of Ohio, in the Republican primary for the 61st House District. Lear, who had sought the appointment to the House seat that had been vacated by former Rep. Rick Carfagna (R-Westerville), garnered over 58 percent of the vote and will face Democrat Louise Valentine in November.
- » The closest contest of the day was the Democratic Primary for the 3rd House District in Franklin County for an open seat. In a five-way contest attorney Ismail Mohamed held a 37 vote lead over Kelly Harrop, a former aide to Rep. Kristen Boggs (D-Columbus). The winner of this contest will face Republican Josiah Lanning in the General Election.

# What's Happening?

## ***CHIPS Act Clears Congress With Bipartisan Support***

The United States Chips and Science Act (or Creating Helpful Incentives to Produce Semiconductors for America Act), better known as the "CHIPS Act" was passed by the U.S. House on July 28th, a day after the U.S. Senate's vote. President Biden plans to sign it into law on August 9.

Both U.S. Senators Sherrod Brown (D-OH) and Rob Portman (R-OH) voted for the bill, which passed 64-33 in the U.S. Senate. Twelve members of Ohio's U.S. House delegation supported the CHIPS Act and four voted against it, as it cleared the chamber 243-187.

Voting in favor of the CHIPS Act were Representatives Troy Balderson (R-Worthington), Joyce Beatty (D-Columbus), Shontel Brown (D-Warrensville Hts.), Mike Carey (R-Hilliard), Steve Chabot (R-Cincinnati), Bob Gibbs (R-Ashland), Anthony Gonzalez (R-Canton), Bill Johnson (R-Marietta), Dave Joyce (R-Twinsburg), Marcy Kaptur (D-Toledo), Tim Ryan (D-Youngstown) and Mike Turner (R-Dayton).

U.S. Reps. Warren Davidson (R-Troy), Jim Jordan (R-Lima), Bob Latta (R-Bowling Green) and Brad Wenstrup (R-Cincinnati) voted against it. The vote comes recently after Intel announced its delay of the ceremonial groundbreaking for its \$20 billion semiconductor manufacturing facility in Licking County, citing concerns about the then stalled federal legislation. The legislation provides \$52 billion in federal investment for semiconductors such as the Intel factory proposed for Licking County.

## ***U.S. Senate Passes Inflation Reduction Act***

On Aug. 7th, the U.S. Senate passed a \$430 billion Inflation Reduction Act, a bill intended to fight climate change, lower drug prices and raise corporate taxes. The vote took place following a 27-hour weekend session of debate and efforts by Republicans to prevent passage. The Senate passed the reconciliation bill 50-50 without a Republican vote and with Vice President Kamala Harris voting to break the tie.

Now the bill heads to the U.S. House of Representatives where a vote on the measure will likely occur this Friday.

The package includes \$369 billion in renewable sources of energy to reduce carbon emissions by 40 percent by 2030. In addition to climate change, the legislation also cuts drug prices for Medicare recipients and extends expanded health insurance subsidies under the Affordable Care Act. Finally, the bill includes tax provisions that Moody's Analytics says will raise \$313 billion in additional taxes over ten years by imposing a 15% minimum tax on corporate profits for businesses that earn at least \$1 billion a year.

The deadline to use reconciliation to pass this legislation is September 30th, the end of the federal fiscal year.

## ***Rickenbacker Receives Senate Earmark***

The U.S. Senate Appropriations Committee has added an \$8 million earmark to relocate the firing range at Rickenbacker Air Force Base. The earmark, requested by Senator Sherrod Brown, is a priority of the Columbus Region Coalition and the Central Ohio Defense Group.

The project will result in better trained Ohio National Guard men and women, in addition to opening up acres of land for development. The earmark, now part of the Military Construction/Veterans Affairs Appropriations Bill, must receive approval through both chambers as Congress takes action on the full appropriations bill.

# What's Happening?

## ***PUCO Chair Encourages Energy Efficiency Initiatives***

At the July 27th meeting of the Public Utilities Commission of Ohio (PUCO), Chair Jenifer French stated prior to adjournment that she and her fellow commissioners encourages jurisdictional and non-jurisdictional interested parties to work collaboratively and cooperatively to propose energy efficiency initiatives. Parties interested in pursuing these energy efficiency initiatives are also encouraged to incorporate these into either comprehensive or standalone proceedings before the Commission for its consideration.

Chair French made these remarks after giving praise to the PUCO Energy Efficiency Workshops she and her fellow commissioners attended that she found to be educational and informative for commissioners, staff, stakeholders, and the public at large.

“The varying positions of the participants on how to efficiently and cost-effectively introduce energy efficiency initiatives was evident in the testimony and comments submitted to the PUCO,” French said. “The information shared at the Energy Efficiency Workshops will serve as a basis of understanding of this critical issue.”

## Top News

### ***FY22-23 Budget***

Tax collections generated nearly \$180 million more than expected in June, bringing Ohio's revenue surplus to more than \$2.7 billion at the close of FY22 on June 30, according to data from the Office of Budget and Management (OBM). The state collected \$28.1 billion in taxes through the fiscal year, compared to expectations of \$25.4 billion, a difference of nearly 11 percent. Personal income tax collections made up the bulk of that overage, bringing in \$1.85 billion or 20.8 percent more than expected. June's collections themselves were \$50.1 million or 5.1 percent ahead of estimates.

### ***Economic Development/Urban Revitalization***

The DeWine administration announced grant funds totaling almost \$42.2 million as part of the first phase of the Ohio Building Demolition and Site Revitalization Program. Communities will be able to use the money to “turn blighted properties into new opportunities that attract investment, business and jobs.” Funds will go to 87 counties up to their \$500,000 set-aside under this round, and seventy-two counties requested the full amount. Remaining funds will be awarded on a first-come, first-served basis to counties that applied for funding in excess of \$500,000. The total program funding is approximately \$150 million, and is part of the Ohio BUILDS effort along with the Brownfield Remediation Program.

The third application round of the Brownfield Remediation Program opened, and more than \$30 million is available according to the Ohio Department of Development (DOD). The round will remain open until Friday, Sept. 30 or when funds are depleted. The program focuses on industrial, commercial and institutional brownfield sites that are abandoned, idled or underutilized because of the known or potential release of hazardous substances or petroleum.

Ohio fell to 15th in a recent CNBC ranking of “Top States for Business in 2022,” after being ranked 10th in 2021 and 2019. During the Ohio Chamber of Commerce's workforce summit President Steve Stivers said the Ohio Chamber is “focusing on what policy changes it would take to move us to number one [in the CNBC rankings] and then starting to enact those.”

# Top News

## Energy/Utilities

Reps. Latyna Humphrey (D-Columbus) and Dontavius Jarrells (D-Columbus) joined American Electric Power (AEP) CEO Marc Reitter to announce another half million dollars in company funding to expand the \$1 million previously announced for four Columbus-area nonprofits in response to food losses during June power outages.

The Ohio Power Siting Board's (OPBS) massive rule overhaul marks a proliferation of solar power plants in numerous counties and seeks to increase energy developers' accountability to both the public and the state for all generation technologies. They include wind and gas-fired plants and are reinforced by expanded rules governing major transmission corridors and natural gas pipelines. Siting board disclosures to the governor's Common Sense Initiative (CSI) say the 218-page rule package likely will increase costs and reduce profits for energy developers and operators regulated by the state. The Ohio Democratic Party (ODP) moved to block any effort by the DeWine administration to destroy documents regarding House Bill 6 (133rd General Assembly). The motion for a preliminary injunction against document shredding or deletion follows ODP's January records request and May lawsuit complaining of extensive redactions from Gov. Mike DeWine's personal calendar provided to Democrats.

Parties before the Ohio Supreme Court debated whether the Public Utilities Commission of Ohio (PUCO) has authority to order the collection of a flat \$20 million from all electric ratepayers for the annual solar subsidy of 133-HB6 (Callender-Wilkin) and 134-HB128 (Hoops-Stein) or must first calculate solar credits eligible generators have actually earned. The Ohio Manufacturers' Association (OMA) and PUCO also differed over the meaning of billed "customers" – whether they constitute single entities with more than one location or individual accounts for which an entity may pay multiple charges. The Office of the Ohio Consumers' Counsel (OCC) says the state's four 133-HB6-related investigations into FirstEnergy provide the perfect opportunity for the Public Utilities Commission of Ohio (PUCO) to apply the same judicial conduct standards to commissioners and administrative law judges that attorneys must follow who appear before PUCO. OCC is requesting commission adoption of the Ohio Supreme Court Code of Judicial Conduct in the single "review" and three ongoing audits of FirstEnergy's political and charitable spending, corporate separation, distribution modernization rider (DMR) and delivery capital recovery rider (DCRR), respectively. Northwest Ohio Aggregation Coalition (NOAC) has joined the OCC in the first two cases.

American Electric Power (AEP) Ohio said that a series of internal emails between the Public Utilities Commission of Ohio (PUCO) and AEP's regulatory director 24 hours before the June outages were "fairly common" in the face of severe weather and did not signify a lack of readiness on the utility's part. The company also responded to PJM Interconnection's comments to the Office of the Ohio Consumers' Counsel (OCC) Governing Board about hypothetical AEP non-compliance and related fines, saying the utility is committed to a full accounting of conditions leading up to and during the Central Ohio outages from June 14 to 16.

The Public Utilities Commission of Ohio (PUCO) both expanded and potentially narrowed the class of customers eligible for the Percentage of Income Payment Plan (PIPP) program. Commissioners approved rule changes raising the PIPP threshold from 150 percent to 175 percent of the federal poverty level. Simultaneously, they rejected American Electric Power (AEP) of Ohio's appeal to suspend work on converting five massive apartment buildings to sub-metered accounts lacking state protections for regulated utility customers, including PIPP. The order denying AEP's appeal provokes the larger question of sub-metering companies or utility resellers in multi-family complexes. Residents of these facilities — often lower-income — do not enjoy regulatory safeguards including commission-approved rates, competitive choice, disconnection protocols, and PIPP, among others. Over a year and a half ago, the Ohio Supreme Court struck down PUCO's previous four-prong test for public utilities exempting sub-meterers and remanded the Capital area appeal of Cynthia Wingo to the commission for a new standard. PUCO has yet to do so.

# Top News

## ***Environment***

Ohio EPA issued an isolated wetlands permit for a project to construct semiconductor manufacturing facilities — Intel — in Licking County. Discharges from the activity will affect approximately 10 acres of isolated wetlands. MJB Holdings, LLC will offset these impacts with more than 20 acres of wetland mitigation.

A coalition including the Ohio Environmental Council (OEC) says local governments around the state will be forced to spend billions of dollars by 2050 on weather-related impacts to roads, drinking water and other public services under one of four climate-change models developed by the United Nation's Intergovernmental Panel on Climate Change (IPCC). The projected dollar cost cited by the new report, "The Bill is Coming Due: Calculating the Financial Cost of Climate Change to Ohio's Local Governments," ranges anywhere from \$1.8 billion to \$5.9 billion.

## ***General Assembly/Statehouse***

The Controlling Board approved an additional \$100 million in spending for rental and utility assistance from the American Rescue Plan Act (ARPA). The request was an emergency add-on by the Ohio Department of Development (DOD). According to the Department, the funds are the second round of emergency rental assistance dollars from APRA; \$196 million is available to the state through the second round of funding, with Ohio set to receive around \$496 million through 2025. The funds will be used by eligible households for regulated gas and electric utility payments and for community action agencies to use for rental assistance.

## ***Judicial***

The American Civil Liberties Union (ACLU) of Ohio is joined by Black Lives Matter (BLM) Cleveland and eight other organizations in calling for a major shift in the felony sentencing database being developed by the Ohio Criminal Sentencing Commission (OCSC), which Chief Justice Maureen O'Connor chairs. The coalition, which also includes Common Cause Ohio, Ensuring Parole for Incarcerated Citizens (EPIC), Freedom BLOC (Black Led Organizing Collective), Heartbeat Movement, Ohio Fair Courts Alliance, Ohio Families United for Political Action & Change (OFUPAC), Policy Matters Ohio, and River Valley Organizing, has issued a six-page letter and attachments to OCSC Executive Director Sara Andrews.

## ***Lieutenant Governor***

The Ohio's Broadband and Cable Association presented Lt. Gov. Jon Husted its inaugural Champion of Broadband Award, which was established to recognize those who are leading advocates of broadband connectivity. The association noted Husted's role in broadband efforts through his leadership of InnovateOhio and the Governor's Office of Workforce Transformation, as well as the DeWine administration's creation of BroadbandOhio to oversee the \$270 million expansion grant program and development of a workforce strategy for expansion.

## ***Natural Resources***

Gov. Mike DeWine and Ohio Department of Natural Resources (ODNR) Director Mary Mertz announced plans for more than two dozen new H2Ohio wetland projects to improve water quality across the state. The 25 new wetland projects will soon launch in 22 counties and will be funded through ODNR's \$25 million H2Ohio allocation in the current state operating budget. Wetlands help improve water quality by trapping, filtering, and removing excess pollutants and nutrients, like phosphorus, from the water before the materials flow into waterways and where it can contribute to harmful algal blooms. To date, ODNR has completed or restored 23 wetlands in the state, and the 25 new wetlands bring the total number of projects underway or complete to 113.

# Top News

## ***Nonprofit Organizations***

The Ohio State Bar Foundation (OSBF) has awarded \$91,042 in grants to two Ohio nonprofit organizations through its Racial Justice Initiative.

The Mental Health & Addiction Advocacy Coalition will receive \$41,400 to research and identify areas of racial and ethnic inequity in Ohio's community behavioral health system. The project will collect and analyze available data and make recommendations to improve data collection and eliminate the disparities, inequities and negative effects that result in poor outcomes for minority populations. The report will suggest strategies to improve data collection to help eliminate disparities, examine possible solutions and make practical and actionable recommendations. Partnering organizations include Central State University, Multiethnic Advocates for Cultural Competence and Ohio University. The project will serve all counties statewide.

## ***Public Safety***

Ohio personnel once again joined law enforcement officers from five other Great Lakes states for this year's National Highway Traffic Safety Administration (NHTSA) Region 5 high-visibility Speed Awareness Day. Officers from Illinois, Indiana, Michigan, Minnesota, Ohio and Wisconsin were to combine increased, zero-tolerance enforcement with effective communication to motorists on the importance of obeying speed limits. The DeWine administration says high-visibility enforcement (HVE) is a "proven countermeasure for reinforcing driver compliance with posted speed limits."

Gov. Mike DeWine and the Ohio Traffic Safety Office (OTSO) released a new educational video for use by parents, teachers, and driver education instructors to help them explain the dangers of distracted driving to teens. The light-hearted video targets youthful drivers and features a pair of young hosts answering the distracted driving questions that instructors get the most.

## ***Technology/Aerospace***

The U.S. House passed the legislative package including the CHIPS Act a day after the U.S. Senate's vote and President Joe Biden's statement urging its passage. U.S. Sens. Sherrod Brown (D-OH) and Rob Portman (R-OH) both voted for the bill, which passed 64-33 in the Senate. The U.S. House voted 243-187-1, with support from Ohio's delegation divided up 12-4. U.S. Reps. Troy Balderson (R-Worthington), Joyce Beatty (D-Columbus), Shontel Brown (D-Warrensville Hts.), Mike Carey (R-Hilliard), Steve Chabot (R-Cincinnati), Bob Gibbs (R-Ashland), Anthony Gonzalez (R-Canton), Bill Johnson (R-Marietta), Dave Joyce (R-Twinsburg), Marcy Kaptur (D-Toledo), Tim Ryan (D-Youngstown) and Mike Turner (R-Dayton) all voted for the bill. U.S. Reps. Warren Davidson (R-Troy), Jim Jordan (R-Lima), Bob Latta (R-Bowling Green) and Brad Wenstrup (R-Cincinnati) voted no.

## ***Telecommunications/Broadband***

The DeWine administration recently announced four teams representing 11 counties would serve as the first cohort in a planning and capacity-building program to help leverage "historic" funding for broadband infrastructure as part of a "community-driven" broadband expansion. Participants in the BroadbandOhio Community Accelerator Cohort include individual teams from Defiance, Shelby and Tuscarawas counties and Adams, Brown, Fayette, Highland, Lawrence, Pike, Scioto and Vinton counties as members of the Ohio Valley Regional Development Commission (OVRDC). The program is a collaborative effort between BroadbandOhio, Heartland Forward, the Benton Institute and Ohio State University's (OSU) Office of Extension. Heartland Forward initiated and funded it.

# Top News

## ***Transportation/Infrastructure***

Gov. Mike DeWine announced that several state and local agencies are joining forces on a pilot program to make transit in Coshocton, Guernsey, Muskingum and Tuscarawas counties easier to navigate and more efficient. The new program, Mobility Ohio, will be a one-stop hub that will rely on agency coordination and next-generation software tools to allow people to conveniently schedule trips by phone or online. The \$2.8 million grant to create and fund Mobility Ohio is part of the Federal Transit Administration's Innovative Coordinated Access and Mobility Program. For decades, state agencies across the U.S. have acted independently to develop their own programs and policies to provide transportation to eligible customers.

DriveOhio is seeking written and in-person comments on its newly released draft deployment plan for building out Ohio's portion of the electric vehicle (EV) infrastructure authorized under the Bipartisan Infrastructure Law (BIL). The National Electric Vehicle Infrastructure (NEVI) Formula Program enacted as part of the BIL will establish a nationwide network of EV chargers that support access and reliability for all users. Specifically, the BIL provides \$7.5 billion for that EV charging infrastructure that will encompass a nationwide network of 500,000 EV chargers by 2030.

The Ohio Department of Transportation announced it is now taking applications for the Municipal Bridge Program, which provides federal funds to municipal corporations, metro parks and regional transit authorities (RTA) for roadway bridge replacement, bridge rehabilitation or bridge demolition projects. In April, Gov. Mike DeWine announced a \$47.5 million increase in Ohio's yearly funding allocation for local bridge projects for the next five years, bringing Ohio's annual investment in county and municipal bridges to \$112.5 million per year. The additional money comes from the federal bipartisan infrastructure law. ODOT said completed online applications are due by Friday, Aug. 15, and selected projects will be announced in November.

U.S. Sen. Sherrod Brown (D-OH) joined Federal Transit Administrator Nuria Fernandez for an event in Columbus with the Central Ohio Transit Authority (COTA) to promote funding from the bipartisan infrastructure law. COTA is planning on using funds to build new bus lines, reduce travel times and create new jobs. COTA President and CEO Joanna Pinkerton also spoke of using federal funds to buy electric buses later this year as the agency seeks to become diesel-free by 2025 and carbon free by 2040. Fernandez said COTA's plans to transition its fleet to zero emissions is what public transportation needs. She called public transportation "the greatest equalizer" and a catalyst for more development.

The Ohio Department of Transportation (ODOT) announced a new litter control program that brings in the business community to help in the effort. Over the past few weeks, the first signage related to the Sponsor-A-Highway program has been installed along highways in the northeast Ohio area. The statewide program allows businesses and groups to fund litter removal services along one mile, one-direction segments of state highways. In exchange for their sponsorship, the name of the business or group is displayed on a sign within their sponsored segment, ODOT said. The program complements ODOT's existing Adopt-A-Highway program, where volunteer groups adopt a two-mile segment of two-lane highway.

## ***Workers' Compensation***

Intel is hiring experienced professionals for management and engineering positions at its New Albany factory, mostly in terms of facilities and site services. Some positions involve temporarily relocating to Arizona or another site for training assignments lasting from six months to one year. Management roles include site operations and commissioning, as well as project manager roles. There are also openings for chemical, mechanical, electrical and manufacturing network engineers. # Legislative Updates
