Introduction

This document provides a draft listing of projects proposed to receive federal transportation funding attributable to the Mid-Ohio Regional Planning Commission (MORPC). In accordance with the *Policies for Managing MORPC-Attributable Federal Funding*, updated in May 2022, MORPC solicited applications for MORPC-attributable federal funding and developed the draft funding recommendations included in this document. As part of the process, MORPC convened the Attributable Funds Committee (AFC) to review the funding requests and propose these recommendations. The AFC will review comments received and may modify its recommendations, if necessary, prior to finalizing them. MORPC's Transportation Policy Committee is expected to officially adopt the final recommendations during its March 9, 2023 meeting, with any changes the AFC may approve, at its meeting on February 15, 2023. The adopted funding commitments in a State Fiscal Year (SFY) prior to 2028 will be incorporated into the SFY 2024-2027 Transportation Improvement Program (TIP).

Background

In 2021, Congress adopted the Infrastructure Investment and Jobs Act, or the IIJA. This law reauthorized the Surface Transportation Block Grant Program (STBG) [formerly the Surface Transportation Program], the Congestion Mitigation and Air Quality Improvement Program (CMAQ) and the Transportation Alternatives Program (TAP), and it also authorized the new Carbon Reduction Program (CRP). A portion of the STBG, TAP, and CRP program funds are allocated to MORPC by the IIJA. The Ohio Department of Transportation (ODOT) also suballocates a small amount of their portion of these funds to MORPC. Additionally, ODOT has historically sub-allocated CMAQ funds to MORPC. Because of IIJA and the ODOT policy, MORPC can make approximately \$89 million available to the central Ohio region every two years: \$52 million for STBG, \$25 million for CMAQ¹, \$6 million for TAP, and \$6 million for CRP. MORPC's program depends upon the continuation of federal funding and ODOT's policy.

MORPC has established a competitive evaluation process to determine which of the projects submitted will receive funding. The process is conducted once every two years. MORPC solicited requests for funding in the summer of 2022. MORPC staff and the AFC evaluated and made the recommendations for funding listed in this document using criteria that MORPC had established previously.

¹ CMAQ funding is distributed through a committee of the eight large Ohio Metropolitan Planning Organizations. This process of selecting projects was done in conjunction with the statewide committee. The amount of CMAQ funding forecasted to be available for projects selected by MORPC are assumed to be equivalent to its historical share.

Report Organization

The intent of this report is to provide basic project information in a format understandable by anyone interested in surface transportation improvements. The applications in this table are ones to which no MORPC funding is proposed. This table includes the project's map ID number, the sponsoring agency, a brief description of the project, the total project costs, and the amount requested.

Summary

Approximately \$345 million in attributable funding is forecasted to be available for SFYs 2024 to 2029. In total, MORPC received applications for 42 new funding requests.

The proposed AFC recommendations provide funding for 34 projects/programs to which MORPC previously had committed funding. For these, the proposal is to provide the funding requested in their updated application. Total funding for these 34 projects/programs is approximately \$178 million. The AFC also proposed funding for 23 new projects while not proposing funding for 19 projects because of a lack of available funding. The following table summarizes the MORPC-attributable funding program proposal.

Overview of the Evaluation and Selection Process

The entire procedure for selecting projects for MORPC-attributable funding, including the application process and selection criteria, is outlined in the *Policies*, which can be found on MORPC's website https://www.morpc.org/program-service/morpc-attributable-funding-for-transportation/.

The *Policies* state that MORPC will use its funding to provide funding for a variety of different categories of projects which are:

- Roadway Capacity/Operational Changes Projects that increase the motor-vehicle capacity of the regional transportation system or result in operational changes comprise this category. Examples include the addition of through lanes to a facility, new roadways, intersection modifications (such as the addition of turn lanes and/or traffic signals or construction of a roundabout), the addition of a center left-turn lane to a corridor, intelligent transportation systems, and any traffic signal infrastructure modifications (including equipment upgrades) that will result in operational changes to motor vehicle traffic.
- <u>System Preservation</u> This category includes projects that are solely replacement or maintenance of existing roadway infrastructure without resulting in operational changes to motor vehicle traffic. Examples include bridge maintenance and replacements, and pavement preservation, resurfacing or rehabilitation. The maintenance or replacement of traffic signal infrastructure may be considered for this category only if it will not result in operational changes to motor vehicle traffic. For example, replacement of signal infrastructure with improved communications capabilities would likely be considered in the Minor category.
- <u>Bike and Pedestrian</u> This category includes any activity that primarily benefits bicycle
 and pedestrian transportation. Examples include installing or modifying multi-use paths,
 bicycle lanes, sidewalks, provided that they are not part of a roadway modification
 project. It also includes funding requests for education, encouragement, enforcement,
 and other activities to promote non-motorized modes of transportation.
- <u>Transit</u> This category includes any activity that primarily benefits public transportation.
 Examples include transit vehicle replacements, park and rides, transit centers, enhanced bus stops, capital projects related to new or expanded service, streetcar, bus rapid transit, or rail transit.

 Interchange/Freeway – Projects which are constructing a new interchange or modifying an existing interchange or other component of a freeway project and the benefits generally are focused on improving travel on the freeway system as opposed to the local system.

If a funding request does not fit in any of the above, it falls into an "other" category. These may be education or enforcement activities, non-transit engine retrofits, and alternative fuels projects, etc. The determination of whether to fund these requests are made on a case-by-case basis. No projects fell into the other category during the most recent evaluation process.

The evaluation of the projects was completed to determine the best projects in each category according to the criteria outlined in the *Policies*. The AFC then used this information to propose funding across the categories. Within the guidelines outlined in the *Policies*, the AFC has discretion in determining the amount of funding to provide for each category or project.
