I. Welcome & Introductions

- Vice-chair Rollins called the meeting to order at 5:30 p.m. There was a quorum present.

II. Approval of November 2, 2022 Meeting Minutes

- Vice-chair Rollins asked for a motion to approve the November 2, 2022 minutes. Mr. Paul moved; Mr. Allman seconded; and the motion passed.

III. Metropolitan Planning Organization (MPO) Report – Nick Gill, MORPC

- Mr. Gill provided an update for Delaware County Transit (DCT), informing the committee that DCT is working on their 2023 budget for December approval by the Board.
- Mr. Gill stated that DCT has onboarded their new operators and are seeing immediate relief in operations from their assistance.
- Mr. Gill announced that DCT will be embarking on a Strategic Plan in 2023. They are laying the groundwork now and hope to have an RFP out within first quarter of 2023. This plan will help guide DCT in its decisions for service within the community by understanding community and stakeholders needs and execute desired service for the community and stakeholders.
- Mr. Gill informed the committee of COTA Service Change Meetings. The meetings will be held Thursday, December 8, 2022 at 6:00 p.m. and Tuesday, December 13, 2022 at 12:00 p.m.
- Mr. Gill introduced the new Programing Executive Assistant, Kelsey Matson.

- Mr. Gill concluded his report introducing the new Director of Data Analytics & Strategy, Dave Dixon, who started on November 28, 2022. Mr. Dixon comes to the agency with a diverse public service background, and a history of serving public and nonprofit organizations in Central Ohio. He is an Ohio native, living in Worthington. He received his Bachelors and Master Degree from Ohio State holding a master's degree in Public Administration (MPA) from John Glenn College and a Bachelor of Science in Political Science.

IV. Resolutions

- T-16-22 Amending the SFY 21-24 Transportation Improvement Program – Thomas Graham, MOPRC
 - Mr. Graham informed the committee that this TIP amendment will modify six projects to the current TIP with commitments totaling over \$61 million.
 - Mr. Graham informed there are two project modifications being made for COTA projects related to adding OTP2 funding, a state-wide funding source for transit initiatives a COTA/Plus operating expansion project, and a digital ticketing vending machine and transit management advanced communications system. The COTA/Plus expansion would reach three to four new zones.
 - Mr. Rist asked if there are enough drivers for the COTA/Plus expansion to be possible. Mr. Gardocki stated both projects were applied for in cooperation with Licking County, Etna Township, Madison County, and West Jefferson Township. The funding can be spent over two years and finding drivers will be part of the plan.
 - Mr. Graham stated the next project is for the Licking County Transportation Improvement District for a widening of Refugee Road. It is a minor widening adding turn lanes and round-a-bouts. The limits would be from Mink Street to Etna Parkway. Some reconstruction is also involved to accommodate the anticipated increase in truck traffic.
 - Mr. Graham stated the next amendment would be adding \$50,000 in right-of-way funding to the TIP for ODOT project on I-270 and US-23. This project was already on the TIP; however, the right-of-way phase was not within the state fiscal 2021 timeframe.
 - Mr. Graham continued with the amendment for noise walls on SR-161. The project is to add noise walls within the same limits as the SR-161 widening in the last TIP amendment.
 - Mr. Gardocki introduced Section 5310 Enhanced Mobility of Seniors with Disabilities to the committee. The funds are used to increase access to the community with transportation options through coordination, expansion of efforts and resources of public transportation agencies, human services agencies, and private providers of public transportation services. The majority of funds are spent to meet the needs of seniors and individuals with disabilities when public transportation is insufficient, inappropriate, or unavailable. Mr. Gardocki highlighted eligible project criteria. Due to global production delays MORPC made the choice not to approve any vehicle purchase this year. The December CAC Meeting Packet includes an attachment of

2022 Program of Projects agreed upon by the 5310 Advisory Committee.

- Ms. Girves asked if the projects highlighted by Mr. Graham and the 5310 are voted on together or if they are separate. Mr. Gill clarified that the approval is for incorporating the projects discussed into the TIP.
- Mr. Allman asked if companies like UBER or LYFT offer any provisions or recognition to those with disabilities. Mr. Gardocki stated that while he is not familiar with any UBER or LYFY programs that apply specifically to ADA accessibility as they are private entities; however, there are several providers like COTA, which utilizes UBER, to provide ADA accessible services to the community.
- Mr. Weiss asked if there is a reason there are no bike or pedestrian components to the Licking County Refugee Road project. Mr. Graham responded that there may be bike and pedestrian components but were not properly included in the amendment as it is currently shown. He will follow up with the Licking County TID to confirm what accommodation will be available.
- Mr. Roehm asked for clarification if MORPC is a direct provider of transportation services as they are included in the list of other agencies that do. Mr. Gardocki clarified that MORPC is the Mobility Manager for Franklin County and helps administer the Health and Human Services Contribution Coordinated Plan for a nine-county region in central Ohio. MORPC uses the funds to provide our Mobility Management Services to Franklin County.
- Vice-chair Rollins asked for a motion to approve Resolution T-16-22; Mr. Paul moved; Mr. Curlis seconded; and the motion passed.
- T-17-22 Amending the SFY 2023 Planning Work Program – Nick Gill, MORPC
 - Mr. Gill provided details on the Planning Work Program. In September MORPC provided the committee with a completion report for the fiscal year 2022. Each spring MORPC develops a Planning Work Program for the following fiscal year. The first element of the proposed modification is to increase the mobility management program from \$130,000 to \$150,000. The second item is to add a new work element to the 2023 Planning Work Program for determining short-term and long-term transportation needs in the area surrounding the Intel project. MORPC will continue discussions with ODOT in February 2023 regarding their funding of approximately \$1 million for planning activities.
 - Ms. Girves asked if MORPC's Complete Streets philosophy will be included in planning efforts as she has some concerns regarding pedestrian and bicycle access in the area. Mr. Gill confirmed the planning efforts will be multi-modal focused.
 - Mr. Rist asked for clarification on "Attachment 2" as there does not appear to be any reference to transit serving the area surrounding Intel. Mr. Gill stated transit, and modes of transportation besides cars, will be part of the planning process. COTA is part of the discussion.

- Mr. Allman asked if the state or ODOT has sought any funds from Intel to pay for some of the planning process. Mr. Gill stated there is no funding from Intel. The state is providing the resources to support the planning efforts and gauge the impact of development, and how communities can better prepare and plan for growth for the entire region.
- Mr. Roehm asked for clarification if the Intel location is outside of MORPC's boundaries, and outside of COTA's jurisdiction for collecting tax for transit. Mr. Gill clarified that the Intel site is part of a larger industrial area that has been annexed into the City of New Albany which is within MORPC's planning area. It is outside COTA area for collecting its sales tax.
- Vice-chair Rollins asked for a motion to approve Resolution T-17-22; Ms. Girves moved; Mr. Rist seconded; and the motion passed.

V. 2024-2050 Metropolitan Transportation Plan

- 2024 - 2050 Metropolitan Transportation Plan Update – Maria Schaper, MORPC
- Ms. Schaper informed the committee of the development of the objectives and measures of the Metropolitan Transportation Plan. A public comment period will be opened ahead of the February 2023 meeting where the proposed objectives and measures will be presented. Upcoming 2023 milestones include 2050 population and employment forecasts, compiling candidate projects, and the development of project evaluation criteria. The completion of a full draft document, and eventual adoption, will occur in May 2024.

VI. Informational Items

- Air Quality Update – Prince Kwarteng-Crooklynn, MORPC
- Mr. Kwarteng-Crooklynn provided the committee with an update on the Central Ohio Region's air quality with has shown continuous improvement over the last 29 years. The region experienced high pollution levels in June 2022. June was the first month MORPC issued an Air Quality Alert in two years. Ozone precursors include elevated temperatures in the mid-90's, wildfire smoke, and light winds. The End of Season Report 2021 is expected to be released in mid-January 2023.
- Mr. Kwarteng-Crooklynn updated the committee on the Burnwise Fall Campaign in October 2022 which was acknowledged by the US EPA in the past.
- Mr. Kwarteng-Crooklynn stated that MORPC has been awarded the US EPA Grant for the Air Monitoring & Source Apportionment in Underserved Communities project in the amount of \$500,000.
- Bill Allman commended the community for the improvement of air quality in the region.
- Mr. Rist asked if MORPC has made a comparison of air quality and vehicle miles traveled, with the assumption that vehicle miles traveled has increased over the 29-year period. Mr. Gill cited emission reductions and national regulations have played a part in vastly decreasing the mobile emissions footprint since the 1990's.

- Mr. Weiss stated that the first presentation slide is even more significant as air quality standards have become stricter over the years. He encouraged the committee to purchase hybrid and electric vehicles. He commended COTA for their efforts to move toward electric from diesel.
- Mr. Paul asked if homeowners will be offered any incentives for participating in PurpleAir air quality monitoring. Mr. Kwarteng-Crooklyn stated that there are no incentives offered at this time.
- Clean Ohio Conservation Program Update – Dr. Edwina Teye, MORPC
 - Dr. Teye provided an update on the Clean Ohio Conservation Program. The District 3/Franklin County Preliminary Screener Application was due December 9, 2022 while the Final Applications are due on March 10 2023.
 - Dr. Teye informed the committee of conservation funds awarded by the Natural Resources Assistance Council. On average, six applications are received and five of those are funded in Franklin County each year.
 - Dr. Teye also informed the committee of a shift in schedule with the Clean Ohio program moving from rounds to fiscal year similar to the Infrastructure Program.

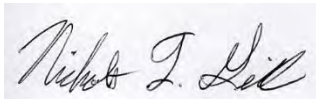
VII. Other Business

- Member Application Update – Nick Gill, MORPC
 - Mr. Gill stated some committee members' terms are expiring this year and have reapplied. Their reappointment process has begun for Mr. Roehm, Ms. Rollins, and Ms. Synk. Two new members from the New Albany area will be joining in February.
- Secretary Appointment – Nick Gill, MORPC
 - Mr. Gill updated the committee on the appointment of the position of Secretary. The position is typically filled by the Transportation Director at MORPC. Vice-chair Rollins asked for a motion to approve Mr. Gill as Secretary; Ms. Girves moved; Ms. Synk seconded; and the motion passed.
- Mr. Allman asked for clarification on what the COMTO Columbus organization is. Ms. Girves clarified that the Conference of Minority Transportation Officials is a national organization with a focus on ensuring opportunities and participation in the transportation industry for minority individuals, veterans, people with disabilities and certified DBE businesses.
- Mr. Allman asked for the status of Amtrak funds and who is trying to accelerate the process.
 - Mr. Gill noted the state has been quiet regarding Amtrak this election period. MORPC is taking steps needed to remain available for funding.
 - Mr. Gardocki informed the committee that the next major milestone is expected in December 2022 from the Federal Railroad Administration on any notice of funding opportunity for the Intercity Passenger Rail Program.
 - Mr. Rist asked if there is a local operating match required for federal dollars, and if so, for how many years.
 - Mr. Gardocki stated there will be a requirement – the federal government covering five years' worth of operating costs. The operating cost will be shared at 50/50.

- Mr. Beltran asked if there are any current initiatives for programs such as recycling tires and solar panels at MORPC. Mr. Gill noted those types of projects are driven at the state level but encouraged the committee to suggest similar initiatives be included in the development of the MTP.

VIII. Adjourn

- The meeting was adjourned at 6:40 p.m.

PROGRAMMING

Transportation

Metropolitan Transportation Plan:

- A public comment period occurred December 23, 2022 through January 23, 2023 on the proposed objectives and performance measures. Three sets of comments were received, considered, and incorporated as appropriate.
- MORPC began reviewing local, regional, and state plans and collecting candidate projects to be evaluated for potential inclusion in the fiscally constrained plan.
- Work continues developing the 2050 population and employment forecast that will inform the plan.

Transit, Mobility & Human Services:

Mobility Management

- Emma Strange started as the new Mobility Coordinator for Franklin County and administrator of the Region 6 Regional Mobility Plan (RMP). She is undergoing training and reaching out to community agencies to form an advisory committee for Franklin County.
- The Mobility team participated in the monthly mobility management call with the other state mobility managers. Discussion revolved around the new requirements that will go into place in 2023 for coordinated plans and Mobility Manager roles. MORPC will comply with the requirements.
- MORPC and ODOT are working towards finalizing the Gohio Mobility Platform which is anticipated to launch in the first half of 2023 to be a statewide accessibility tool.

FTA Section 5310 Designated Recipient

- The FTA approved MORPC's program of projects for 5310 funding. Award letters went out to subrecipients on January 18, 2023. Through January and February, MORPC will be working on getting approvals through the federal grant system, TrAMS for subrecipients to access their funds.
- Vehicle orders were placed for past funding rounds as we continue to experience issues related to global production problems.
- Transit Asset Management planning is underway to update MORPC's three-year plan and coordination with the regional transit agencies, COTA, Delaware County Transit, and Licking County Transit.

Gohio Commute

- Two new vanpools were added traveling to the Chalmer P. Wylie VA Center.

Transportation Planning Activities:

US 23 Connect Study

- A public comment period was held November 2022 through January 2023. Commentators could identify concerns and suggest projects along the corridor utilizing a webmap.
- The project team will review the comments and identify solutions and concepts to be studied in a feasibility study over the Summer 2023.
- There will be additional public input opportunities in Fall 2023.

LinkUS Mobility Initiative

- The partners held a public involvement station design workshop for the East Main and West Broad Street corridors on December 5, 2022 and are receiving public input on the conceptual design..
- MORPC hosted a LinkUS grants workshop on December 6, 2022 to discuss strategic planning for going after state and federal funding to complete action steps identified in the LinkUS Community Action Plan.
- MORPC continues to work with partners to develop and establish a Transit Supportive Infrastructure Committee.

Interregional Connections

- An RFP for intercity passenger rail station siting is under final internal review and scheduled for release in February.

Central Ohio Rural Planning Organization (CORPO):

- CORPO continues to develop their 2024-2027 TIP, which will be completed in May 2023, and the 2023-2050 Transportation Plan, which will be completed in November 2023.

Active Transportation Planning:

- The MORPC Active Transportation Committee will hold its first meeting for 2023 on Tuesday, March 14, 2023 from 10:00 a.m. to noon.

- MORPC is collaborating with Franklin County Public Health (FCPH) on active transportation planning assistance to Franklin Township, which kicked off in January. This work was enabled by a grant FCPH received from the Ohio Department of Health.
- MORPC will be hosting virtual group viewings of the [APBP monthly webinars](#) again in 2023. These webinars are eligible for 1.0 hour of AICP Certification Maintenance credit. Contact Jordan Petrov (jpetrov@morpc.org) if you are interested in attending any of the MORPC group viewings.

Transportation Safety:

- MORPC drafted and proposed strategies that MORPC is committed to work with the City of Columbus on in support of the VisionZero 2.0. initiative.

Technical Assistance Program:

- MORPC received six applications this year for the 2023 Technical Assistance Program. Based on assessments from a formal evaluation committee and staff capacity for 2023, the following five Central Ohio communities were awarded: Berlin Township, Brown Township, the City of Delaware, the City of Grove City, and Violet Township. Four of the five awards focus on providing services related to active transportation planning and Central Ohio Greenways vision refinement. The fifth award includes development of a local safety action plan.
- Kick-off meetings were held for each of these awarded activities to review activity scopes, establish timelines, and introduce the project teams.

Infrastructure Funding:

Transportation Improvement Program (TIP)

- The 1st draft of the SFY 2024-2027 TIP will be submitted to ODOT on February 1, 2023. Development of the TIP will continue through the Spring with a final draft completed by March 10, 2023, Open House on March 21, 2023 and adoption in May.

MORPC-Attributable Funding

- Draft funding recommendations for SFY 2024-2029 are open for public comment through February 8, 2023. These funding recommendations include \$148 million in new funding commitments.

Transportation Review Advisory Council (TRAC)

- TRAC released their draft funding awards for the Major New Construction Program at their January 25, 2023 meeting. The Council is expected to finalize the awards and the full 2023-2026 Program List at its February 22, 2023 meeting at 10:00 a.m. at the ODOT Central Office.

Federal Competitive Programs

- MORPC staff has been assisting and supporting several local members with their respective RAISE grant applications.

Competitive Advantage Projects (CAP)

- The CAP team has been creating one-page project descriptions for identified projects. These one-page project descriptions will be used as presenting materials when MORPC's team meets with central Ohio's Congressional Representatives and Senators.

Economic Development

Comprehensive Economic Development Strategy (CEDS):

- Following the submission of the Economic Development District designation application, the Economic Development team continued to be in contact with federal Economic Development Administration (EDA) project managers for regular updates.
- The Economic Development team hosted EDA representative Ellen Heinz at MORPC to discuss central Ohio economic development projects.

Brownfield Assessments:

- MORPC contacted the Mayor of Somerset regarding a final brownfield project under the grant for this year.
- The team hosted a meeting with the Buckeye Hills Regional Council and the Ohio Environmental Protection Agency (EPA) regarding EPA brownfield resources and the Appalachian Community Grant Program.

Funding Opportunities Database:

- The Economic Development Team continued to add and monitor funding opportunities in MORPC's version 1.0 database.
- Version 2.0 of the funding database has been under development and nearing completion.

PLANNING

Community Development

Central Ohio Greenways:

- The COG Board met January 18, 2023 to review working group reports and approve and agenda for the Spring 2023 COG Board Retreat.
- The COG Trail Development and Partnership Working Group met on December 15, 2022. Members requested advice on nomenclature for trail types and names and strategies for cohesive trail name hierarchy on signage. MORPC is beginning a wayfinding study with a consultant in February. The consultant will be tasked with offering advice on hierarchy and nomenclature.

- The COG Marketing and Operations Working Groups met December 13, 2022. The group developed a strategy for incorporated curated trips into the Outdoor Trails Passport and hopes to launch an updated pass in April 2023 with 1 to 2 curated trips. The group will also offer advice on the COG website update, a brand refresh, and the Rails to Trails Celebrate Trails Day. The Outdoor Trails Passport, a program in collaboration with Experience Columbus, is live. Residents and visitors are invited to access the passport online any time they explore a greenways trail. By checking in at locations across the COG network, passport users become eligible to win prizes.
- MORPC and the City of Columbus Recreation and Parks partnered on a trail count equipment pilot project that launched in the summer of 2021. The results are available in a final project report that provides equipment recommendations to regional partners as well as a detailed model for collaboration between MORPC and partners to collect, process, and analyze data moving forward. MORPC is seeking grant funding to update the non-motorized count program based on recommendations from the report. Additionally, MORPC will purchase five trail counters to be installed by partners along the Ohio to Erie Trail.

Central Ohio Blueways:

- An Advisory Panel has been formed and convened on January 27, 2023. The initial meeting reintroduced Central Ohio Blueways as an initiative in Central Ohio aimed at promoting natural resource conservation and outdoor recreation in partnership with MORPC members, RAPID 5, and other community partners. The Advisory Panel is anticipated to meet monthly for 6 to 8 months and will focus on providing direction and guidance towards Water Trail Designation through the Ohio Department of Natural Resources (ODNR) for the Central Ohio Blueways team and Partnership Groups.

LinkUS Mobility Initiative

- Together with the Programming Department, team members are engaged in ongoing committee and Working Group meetings for the LinkUS initiative.

RAPID 5

- MORPC is engaging with RAPID 5 on its Central Ohio Greenways and Blueways programming. Team members continue to provide transitional support to RAPID 5, which includes assisting with processing speaker requests and presentation needs. MORPC team members are also assisting with developing a resource library of data, resources, insights and information about pertinent topics, including land use, multi-modal transportation systems, sustainability, economic development, etc. Finally, MORPC attended all RAPID 5 organized local government meetings to share more about the direction of RAPID 5. Stay up to date with RAPID 5 news and events at rapid5.org. MORPC's main contact for the RAPID 5 initiative is Chief Regional Strategy Officer, Kerstin Carr (KCarr@morpc.org).

Regional Housing Strategy (RHS):

Outreach

- Team members discussed regional growth and housing/development needs with several audiences, including local media, in-person presentations to community groups and conversations with MORPC members. Ongoing coordination with industry organizations includes Affordable Housing Alliance of Central Ohio, Affordable Housing Trust, BIA, City of Columbus, and others.

Implementation Assistance

Sustainability

Sustainability Advisory Committee:

- The Sustainability Advisory Committee met on December 14, 2022. Agenda items included a Summit on Sustainability recap, US EPA Air Monitoring Grant overview, Blueways presentation, and more. The members were engaged and provided their input on the air monitoring and Blueways projects. The team is working to wrap up member appointments for the 2023-2024 term and will host a new member orientation meeting in February. The next meeting will take place on February 15, 2023 at 2:30 p.m.

Sustainable2050:

- The fourth quarter meeting on December 9, 2022 included an overview of member priorities and speakers from MORPC, Ohio EPA, and SWACO providing information about funding opportunities to support priorities in the areas of waste reduction, natural resources, and energy/climate. MORPC has partnered with the Ohio State University's City & Regional Planning Program and Sustainability Institute to provide free technical assistance for jurisdictions and organizations associated with MORPC's Sustainable2050 initiative. Selected applicants will have the opportunity to work with several of The Ohio State University's studios and capstones to complete this technical assistance. The deadline is February 10, 2023 so please contact Brandi Whetstone (bwhetstone@morpc.org) for more information and to fill out the application form.
- Membership and tier status certification is open to MORPC members. Please contact MORPC's Sustainability Officer, Brandi Whetstone, for more information (bwhetstone@morpc.org).

Water Resources Program

Sustaining Scioto Board

- The Sustaining Scioto Board met on December 15, 2022 and heard a presentation from Dr. Linda Weavers, co-Director, Ohio Water Resources Center- OSU on PFAS (Perfluoroalkyl and polyfluoroalkyl substances) routes of exposure and presence in

drinking water. Dr. Weavers talked about routes of exposure and emerging methods on how to treat PFAS and other similar chemicals. The Board also heard a presentation titled Biological and Water Quality Assessment of the Middle Scioto and Lower Olentangy Rivers 2020: Showing Past Successes and Planning for the Future from Chris Yoder with the Midwest Biodiversity Institute. The board will meet again on February 23, 2023.

- The Agricultural & Rural Communities Outreach Team met on January 19, 2023. Members listened to a presentation from the Director of Licking Soil and Water Conservation District, Kristy Hawthorne on the District's programming areas with a focus on agriculture and water quality. Director Hawthorne highlighted cost share programs administered through the district and collaboration with landowners to help address water quality issues. The team as part of this year's programming discussed a potential field day event in April targeted at farmers, landowners, and the public. Speakers and topics during the event are still being identified. This working group will meet again on March 16, 2023.
- Ohio EPA Water Resources Planning Work: MORPC in partnership with the Ohio Environmental Protection Agency hosted a Central Ohio Water and Wastewater Planning Workshop on Dec. 6, 2022 with over 80 attendees representing municipalities and other local governments, county engineers, regional planners, administrators, water and wastewater superintendents, consultants, and others, the participants discussed water quality issues and wastewater planning and expansion efforts. The speakers also shared funding and resources available for communities to move to a long-term strategic planning effort.

Energy & Air Quality:

Energy & Air Quality Working Group

- The Working Group met on January 24, 2023 where they elected the chair and vice chair for the next term, as well as hear programmatic approaches and priorities for 2023.
- The Subcommittee on Power Siting Issues held its second meeting on January 20, 2023 which included broad representation across multiple counties. The group provided great feedback as MORPC develops its "Education, Engagement, & Empowerment Strategy" to provide guidance on all aspects surrounding utility-scale solar and SB 52. Additionally, the group expressed interest in utilizing federal funding opportunities to double as an economic development tool. MORPC will continue to provide updates on both at future Subcommittee meetings. The next meeting will be held sometime in mid- to late February 2023.

Energy Planning:

- MORPC conducted the City of Columbus' most recent greenhouse gas inventory—2021—which was a part of the City's annual submission to the international nonprofit, Carbon Disclosure Project protocol. The City of Columbus was recognized as one of 122 "A List" cities and counties for taking bold leadership on environmental action and transparency. Read more here from the Sustainable Columbus website.
- The Rickenbacker Energy Consortium (REC) met for the first time in person on November 30, 2022 at the Rickenbacker Airport. The focus of the meeting was to continue the conversation and to build a roadmap toward clean energy projects. REC's

next meeting will be on February 9, 2023. Anyone interested in learning more or joining should contact Brian Filiatraut (bfiliatraut@morpc.org).

- The MORPC team will continue to partner with the City of Columbus, Solar United Neighbors, IMPACT Community Action, and Simply Living to kick off another residential solar co-op round. Planning is underway but expect the second round to open this April.
- The Regional Schools Energy Strategy (ReSES) is an opportunity for schools, school districts, and local governments to move forward with onsite solar power generation through a collaborative solar co-op to secure best pricing on installation and electricity rates. MORPC is in discussions with interested entities. If any local government or school leader is interested, please contact Brian Filiatraut (bfiliatraut@morpc.org).
- Federal Funding opportunities are a priority as the Team continues to coordinate across departments and with regional partners on identifying opportunities for clean energy and sustainability. Further, the Team is working in partnership with Smart Columbus and HNTB to produce an EV Charging Siting Study for MORPC's 15-county region to position our communities to secure competitive, non-NEVI funding.
- Residents for a Sustainable Central Ohio (RSCO) met for an in-person meeting on December 6, 2022 at MORPC. The group heard updates from MORPC and learned about the newly formed Electrify Central Ohio (ECO) group, which focuses on homeowners learning about electric alternatives and new federal incentives for domestic hot waters, induction stovetops, EVs and EV chargers, among other opportunities. The next RSCO meeting will be held in March 2023.

Clean Ohio Conservation Fund:

- Preliminary Screeners for Round 17 were due on December 9, 2022 and applicant presentations were held on January 10, 2023. The NRAC received 6 preliminary applications and provided feedback to applicants on eligibility and any clarifications needed to be made in the Final Applications. Final applications are due on March 10, 2023. For more information, please contact Edwina Teye at (eteve@morpc.org).

Data, Mapping & Modeling

Regional Data Advisory Committee (RDAC):

The Regional Data Advisory Committee met on December 8, 2022 to discuss new membership, the update of the Regional Data Agenda, and to hear updates from the working groups.

Working Groups & User Groups:

- The Regional Data Agenda Update Working Group
 - The Group met on January 17, 2022 to first review the status of the existing agenda items and related objectives and tasks and then discuss ways in which the agenda may be improved and updated looking ahead to 2023-2025. The Group met for the next 6 months to assemble a list of proposed agenda items and determine the most impactful evaluation criteria to be used for selection and refinement. This process will include review input from RIDG survey respondents.
- The Capacity Building & Partnerships Working Group

- Discussion about the data resource for local partners was finalized as a panel during Data Day, with panelists from Rise Together, the Affordable Housing Alliance of Central Ohio, MORPC, and Catholic Social Services.
 - Data Day is officially scheduled for March 1, 2023, from 9:00 a.m. to 4:00 p.m. at the Ohio University / Dublin Integrated Education Center in Dublin. Registration is Open: www.morpc.org/event/dataday
 - MORPC toured the facility on February 2, 2023 to verify the spaces, determine needed signage, and confirm the technological capabilities.
 - One sponsorship has been secured through Expedient, with another in discussion.
- The Local Government Resources Working Group is seeking recommendations and requests for data policy resources and best practices. Members are encouraged to share sources, resources, and/or suggestions with the Working Group. Meetings are held the fourth Tuesday of every month.
 - The Regional Information & Data Group (RIDG) met on December 7, 2022.
 - The December meeting featured City Auditors and City Financial Directors: Megan Kilgore from the City of Columbus, Brad Lutz from the City of Marysville, Terry Scott from the City of Mount Vernon, and Matt Stiffler from the City of Dublin. The guests participated in a round table discussion on the various impacts to local budgets and the use of data to inform decisions from regional and national events like: Intel, Inflation, Work-from-Home, and other topics affecting local finances.
 - The previous Steering Committee Chair's term ended in December 2022, a new Chair and Vice-Chair will be selected after the December RIDG meeting at the steering committee meeting before the first full RIDG meeting in Q1 2023.
 - The RIDG Steering Committee plans to shorten the length of full RIDG meetings to 90 minutes and to primarily be virtual. The Steering Committee hopes to proactively engage with RDAC Members to help implement RDAC initiatives and goals. The Committee also hopes to welcome additional members in 2023.
 - The first General RIDG meeting will be held on Wednesday, March 22, 2023 from 2:30 p.m. to 4:00 p.m.
 - The Central Ohio GIS User Group (COGUG) will meet on February 22, 2023.

Data Management

- Staff continue to explore ways to standardize data tools and workflows and to improve data and workflow version control and documentation. The Data team is exploring graphical data pipeline development tools to better document processes and reduce the learning curve.
- Data Team staff are working with other departments to evaluate the usability of and extract insights from existing bike/ped counter data and to help plan for deployment of future counters and monitoring and analysis of their data.

Outreach

- Staff continue to provide timely data and analysis support for requests received from member communities, regional partners, and the media.

- Staff continue to participate in digital inclusion efforts, specifically the Franklin County Digital Equity Coalition, as well as the Regional Digital Inclusion Alliance for the Central Ohio region in support of a statewide digital inclusion initiative.

Data Analytics, Mapping, and Research:

Data & Research Activities

- Data and research activities are focused on inputs to the land use allocation model for the coming cycle of the MTP / CTP. County-level forecasts of population, households, labor force, and employment have been completed and are expected to be released on MORPC's Population Resource Hub around the end of January. These forecasts explicitly account for growth expected to be induced by the Intel development.
- 2022 population estimates for sub-county jurisdictions have been finalized and are expected to be released on MORPC's Population Resource Hub by the end of January.
- Staff are reviewing data quality requirements in preparation for execution of the recently awarded EPA air quality monitoring grant.
- The data team continues to work on updating data and visualizations associated with the Regional Housing Strategy Dashboard and the Gentrification and Displacement Risk Analysis.
- Program, Data, and C&E team members are collaborating with CHRR at OSU on a first ever MORPC American Population Panel (APP) public opinion poll. The initial survey is surrounding transportation needs and experiences. As part of this burgeoning partnership, MORPC is working to help expand the APP participants to include more racially, geographically, and socio-economically diverse individuals. You can sign up for the APP and learn more here: <https://go.osu.edu/JOINNOW>. We encourage everyone to share and help spread the word.

Mapping Activities

- Team members are finalizing existing household and job data for 2021 to be used as part of the MTP land use model existing conditions.
- Staff is reviewing 2 submittals from consultants to have an active transportation (bike/ped) network created, along with scalable methodology to improve accessibility measures. A small selection committee is being assembled with both internal and external stakeholders. Sidewalk inventory layers are being reviewed and updated in preparation for the Active transportation network.
- The Central Ohio Greenways bikeway layer was updated to reflect changes provided by the COG board.
- Existing and Future land use in Licking County is being updated per inputs from Heath and other officials. This new information will be included as part of the 2024 MTP.

Modeling Activities

- The team is preparing inputs for the Land Use Allocation Model of the MTP and continues to maintain the Traffic Count Program.

- Staff completed several members requests:
 - AQ conformity analysis for Phase 2 SR-161 widening in Licking County
 - Provided consultants with LinkUS W Broad BRT diversion map for wider network
 - Provided consultants with O-D information for COTA's Short-Range Transit Plan
 - Worked with ODOT to improve scripting related to coding transit in the travel demand model
 - Completed 10 of 12 Traffic Growth Rate requests received this month for various locations.

SUBJECT: **Proposed Resolution T-1-23: “Adopting Objectives and Performance Measures to be included in the 2024-2050 Columbus Area Metropolitan Transportation Plan”**

Resolution T-1-23 builds upon the goals adopted via Resolution T-15-22 for the 2024-2050 Columbus Area Metropolitan Transportation Plan (MTP) and establishes objectives and performance measures to track regional progress in advancing each of the goals. Each objective has several performance measures identified, for which short- and long-term targets will be established. The objectives and performance measures also incorporate the required performance measures from the U.S Department of Transportation (U.S. DOT) federal performance management program.

The draft objectives were presented to MORPC’s CAC, TAC and Policy Committees in November 2022. The draft objectives and performance measures were posted on the MORPC website, and a comment period was held from December 23, 2022 through January 23, 2023. Comments were received from seven people. These comments were carefully reviewed and considered, however did not result in direct changes to the proposed objectives and performance measures. Many of the suggestions will be incorporated into the methodology for certain performance measures or incorporated into more detailed data included in the full MTP document during development of strategies.

Recognizing that completion and adoption of the 2024-2050 MTP will not occur until May 2024, benchmark data and target-setting will take place over the course of 2023 so that the best data can be utilized. Adoption of the MTP will reaffirm the MTP objectives and performance measures.

A next step in the 2024-2050 MTP development process is establishing a process for evaluating strategies and candidate projects for inclusion in the MTP. The objectives form the framework for criteria to evaluate candidate transportation projects. Resolution T-1-23 directs staff to develop the evaluation criteria which will be adopted in 2023.

RESOLUTION T-1-23

“Adopting Objectives and Performance Measures to be included in the 2024-2050 Columbus Area Metropolitan Transportation Plan”

WHEREAS, the Mid-Ohio Regional Planning Commission (MORPC) is designated as the metropolitan planning organization (MPO) by the governor acting through the Ohio Department of Transportation (ODOT) and in cooperation with locally elected officials; and

WHEREAS, MORPC is developing the federally required, long-range, regional transportation plan for the MPO area that will guide regional transportation strategies and projects; and

WHEREAS, the Infrastructure Investment and Jobs Act (IIJA or BIL), the federal transportation legislation with which MORPC's transportation planning must comply, requires a performance-based transportation planning process; and

WHEREAS, the goals for the 2024-2050 Columbus Area Metropolitan Transportation Plan (MTP) were adopted by Resolution T-15-22; and

WHEREAS, Resolution T-15-22 directed staff to develop the objectives and performance measures for the 2024-2050 MTP consistent with the adopted goals and Federal requirements; and

WHEREAS, the objectives and performance measures will be used to track progress in advancing the goals of the MTP; and

WHEREAS, the objectives and performance measures, as shown in the attachment were developed based on current available data and rule-making from the U.S. Department of Transportation on incorporating performance measures into the MTP; and

WHEREAS, the objectives and performance measures were distributed for public review and comment; and

WHEREAS, the Community Advisory Committee at its January 30, 2023 meeting and the Transportation Advisory Committee at its February 1, 2023 meeting recommended approval of these objectives and performance measures; now therefore

Objectives and Performance Measures

MORPC has begun the development of the 2024-2050 Metropolitan Transportation Plan for the Columbus Urbanized Area. The Metropolitan Transportation Plan (MTP) is the long-range planning document that identifies transportation priorities, strategies, and projects over the next two decades. It is updated on a four-year cycle. We coordinate the development of the MTP with communities throughout Central Ohio and with other local, state, and federal agencies.

The MTP makes the greater Columbus region eligible to receive a large amount of federal transportation funding to improve, maintain, and operate public transit, highways, bikeways, sidewalks, and related facilities. Transportation projects must be included in the MTP to be eligible to receive federal funding.

The MTP is developed based on a set of regional goals. The regional goals guide the development of the MTP and give direction to investments in the regional transportation system and were updated for the 2024-2050 version of the plan. For each of these goals, measurable objectives are developed, that are intended to track regional progress toward advancing the MTP goals, and for developing criteria for evaluating strategies and projects to be included in the MTP.

The Moving Ahead for Progress in the 21st Century (MAP-21) surface transportation legislation established a performance- and outcome-based program. As part of this program, MAP-21 and the Fixing America's Surface Transportation (FAST) Act legislation requires that States prepare and use a set of federally established performance measures. The December 2021 Infrastructure Investment and Jobs Act (IIJA or BIL) continues the performance measure requirements.

In alignment with federal requirements, ODOT develops performance measures that set targets in the areas of safety, bridge and pavement condition, and roadway performance. As the Metropolitan Planning Organization for the Columbus Urbanized Area, MORPC also participates in the federal performance management program by incorporating performance measures into the MTP. These measures include the federal measures the state and region are required to report on as well as additional measures included specifically for the goals established for the central Ohio region. The objectives and performance measures below are related to the goals and objectives adopted for the 2024-2050
