Project Updates

<u>Cherrybottom Park Expansion – Venice Club</u>

Request for extension until July 31, 2023; negotiations are ongoing.

Member Studenmund moved to extend, Member Stevenson seconded the motion, motion carried.

Big Walnut Acquisition

Request for extension until December 31, 2023; purchase price negotiations took longer than expected.

Member Craven moved to extend, Member Studenmund seconded the motion, motion carried.

Blacklick Creek Stream Restoration and Riparian Corridor Enhancement (City of Reynoldsburg) EMHT was engaged to perform engineering design and permitting services in July 2022. Extension requested to July 1, 2025, after the Ohio Mussel Survey Protocol has been completed.

Member Craven moved to extend, Member Farst seconded the motion, motion carried.

Schleppi Run Acquisition

The acquisition transaction has closed.

Big Walnut South Protection (City of Columbus)

The City of Columbus has canceled this project and will return \$304,000 to the PWC, which will be added to the available funds.

West Franklinton Green Space (City of Columbus)

Request for extension until December 31, 2023. The City of Columbus has requested that the OPWC review proposed deed restrictions. A Request to Proceed is expected for February 1, 2023, with demolition to begin July 2023.

Member Farst moved to extend, Member Craven seconded the motion, motion carried.

Glover Groff Restoration Phase II (City of Hilliard)

Expected completion is 2024. Tree clearing to be completed April 2023, with restoration commencing in June 2023. There may be a need for an extension at a later date.

Dry Run Stream Restoration

No update is available.

Utzinger Bog Conservation

Two acquisitions have been completed. Two other owners still need to close.

Eastmoor Green Line (City of Columbus)

No update is available.

Marsh Run Stream Restoration in Gantz Park (Grove City)

Request for extension until July 1, 2023. Planting review should be completed by Spring 2023. Member Brown moved to extend until July 31, 2023, Member Farst seconded the motion, motion carried.

Taylor Farm Acquisition on Rocky Fork Creek (City of New Albany)

Closing out soon. No other update was provided.

Chair Wilson requested Jennifer Kline contact City of New Albany staff for either an update, an extension request, or a notice to close.

Stockbridge Urban Forest

Request for extension until July 31, 2023.

Member Palus moved to extend, Member Brown seconded the motion, motion carried.

Utzinger Bog Expansion & Enhancement - Scioto River Flyway Corridor

Project is virtually complete. It is planned to close out by March 31, 2023.

Refugee Road - Mason Run Protection

Request for extension until July 31, 2023. Deed restrictions will be submitted in February 2023. Member Brown moved to extend, Member Farst seconded the motion, motion carried.
