Welcome – Chris Amorose Groomes

Chair Amorose Groomes called the meeting to order at 1:31 p.m.

Commission Chair Erik Janas announced the following appointments effective April 2023:

- Nancy White, Mifflin Township Fiscal Officer Reserve & Investment Advisory Committee Chair
- Jennifer Gallagher, City of Columbus Director of Public Service Bylaws Committee Chair

Consent Agenda

Chris Amorose Groomes made a motion to approve the Consent Agenda, second by Nancy White; motion passed.

Executive Director's Report – William Murdock

William Murdock introduced Kelsey Matson, the new executive assistant for Mr. Murdock and Joe Garrity. She is the new point of contact for them. Today Dave Dixon is filling in for Kerstin Carr and Maria Schaper is filling in for Nick Gill.

It's been an impactful year already. Our Drive Investment Strategy kicked off with the Driving Investment to Our Region luncheon held just before this meeting. Last week we partnered with MODE on the Central Ohio Supply Chain Economic Outlook & Impact on Infrastructure luncheon. And yesterday was our first Data Day with over 160 people in person and online.

Mr. Murdock announced the City of Newark has started the process to join MORPC. There are also a couple smaller communities considering joining MORPC. Member visits continue. Conversations are focusing on housing, federal resources, the transportation budget, and the struggle to hire entry level positions.

The job announcement for the Chief Mobility & Infrastructure Officer & Senior Director of Programming, Thea Ewing's former position, is posted. The Strategic Director of Technology position is also posted.

Kerstin Carr continues to work on the Planner Pool concept. She identified potential funding and will share more information this spring. We continue to work with the Residential Services Team looking at

financial stability and community impact. We kicked off a return-on-investment study looking at the community and environmental benefits of the programs.

Mr. Murdock shared that there will be several vacancies on the Executive Committee next year and asked committee members to start thinking now about individuals that could fill the positions.

Executive Committee members will receive a pre-audit letter on behalf of our financial auditors, Plante & Moran. This is part of a required communication process for the auditors that shares information about the audit. In the past the phrase, "identified the following significant risks of misstatement," caused confusion. The phrase does not mean the auditors found any problems. It means they evaluated the areas which are at greatest risk of misstatement given our financial statements and the types of activities we have. Auditors identify "significant risks of misstatement" for every entity they audit. The pre-audit letter identifies the auditors' areas of focus and approach. They are coming to MORPC in April for field work.

The Executive Committee Retreat is March 10 in New Albany. Mr. Murdock thanked New Albany for hosting the retreat that includes:

- Kenny McDonald from The Columbus Partnership leading a discussion on growth
- A tour of the Intel site and other New Albany sites
- MORPC's Strategic Framework Messaging
- Jamie Greene leading a discussion on housing

Two passenger rail applications are moving forward on routes coming through Columbus. The Ohio Rail Commission is the applicant for the 3C+D route. The City of Fort Wayne is the applicant for the Pittsburgh, Columbus, Chicago route. MORPC is a supporting partner and every MPO on that route is on board. Communities can help by supplying support letters. Send letters to Joe Garrity by March 17. Mr. Garrity will send a template. The business community is highly active in the process.

Mr. Murdock is a panelist on the March 15 CMC Forum, Laying Track for Amtrak's Expansion. Other panelists are Erin Rosiello, All Aboard Ohio Vice Chair; Elizabeth Blount McCormick, Uniglobe Travel Designers President and Owner; and likely an Amtrak representative.

The first Money Mondays is March 20. The weekly sessions led by Dr. Todd Bradley will present the latest grant information and provide an opportunity to ask questions.

Charles Small, U.S. DOT Deputy Assistant Secretary, is the keynote speaker for the March 31 State of the Region. Jack Marchbanks will lead a panel discussion on transportation. Award recipients were announced this week:

- Mayor David Scheffler, City of Lancaster Regional Leadership Award
- Christie Angel, YWCA William H. Anderson Award
- One Columbus William C. Habig Collaborative Achievement Award

Níel Juríst shared we have exceeded our sponsorship goal and over 600 are registered so far. The limit is 990. Executive Committee members are invited to a reception the night before with Mr. Small.

Over 1,000 people responded to the American Population Panel Public Opinion Poll on transportation in partnership with the Columbus Dispatch and CHRR (Center for Human Resources Research) at The Ohio State University. Results will be shared at the State of the Region.

The recommendations are announced in March and voted on at the April Commission meeting. New terms start in May.

Regional Data Advisory Committee – Dave Dixon

Dave Dixon reported he received positive feedback on the inaugural Data Day Mr. Murdock mentioned earlier. The keynote speakers were Dr. Anirudh Ruhil, Ohio University and Michael Wilkos, United Way Central Ohio. The event focused on data use, governance, and visualization. Mr. Dixon thanked the Capacity Building Working Group, Jonathan Miller, and Amanda McEldowney for their support. Presentations will be made available online.

The Regional Data Advisory Committee is welcoming three new members at its next meeting:

The Regional Data Agenda Update Working Group is overhauling the Regional Data Agenda. The agenda will look different than in the past. The Working Group is working backward from the impacts they hope to have in the region. The Regional Data Advisory Committee will review the draft agenda to decide the items they are best positioned to work on.

Over 1,000 responded to the transportation survey adding over 1,000 to the American Population Panel. That's a forty-seven percent participation rate, increasing the value of the panel for every person who uses CHRR in the future.

Regional Policy Roundtable – Joseph Garrity

Joe Garrity provided a legislative update highlighting:

• Importance of the Governor's support for passenger rail and how thankful Mr. Garrity is for the persistent efforts of the regional leaders and business community to secure that support.

- Mr. Murdock provided testimony to a subcommittee of the Finance Committee on Transportation. He focused on safety, trails, and rails.
- Transportation budget passed out of the House March 1. Includes \$1 billion fund for rural highways.
- Preparing for the state operating budget. Being assertive on increasing the local government fund. Will also advocate on increasing the competitive bidding threshold due to inflation.
- Concerned with HB 1, proposing a flat rate for the state income tax, and HB 64, regarding imminent domain and recreational trails.
- Columbus Region Coalition Meeting on March 14 at MORPC with Congressman Brad Wenstrup to introduce regional partners competing for funds. Congressman Wenstrup serves on the House Ways and Means Committee.
- Applications for FY 2024 member directed spending.

Transportation Policy Committee – Maria Schaper

Maria Schaper reminded committee members that the Metropolitan Transportation Plan (MTP) is the guiding document for federal investment in the region. This year is a big year for developing the 2024-2050 MTP. The goals, objectives, and performance measures are adopted as of February 2023. Upcoming activities include population and employment forecasts at smaller geography, candidate project collection, and project evaluation criteria.

The other major product we produce as the Metropolitan Planning Organization is the Transportation Improvement Program (TIP). We are submitting the final draft for the 2024-2027 TIP to ODOT on March 10. The TIP lists projects and programs and the specific funding sources committed to each. All projects receiving federal funding must be included. We try to include local projects to show a full regional snapshot of transportation projects. It totals \$2.4 billion. Public comments are accepted through April 10. There is an Open House March 28 for the MORPC and CORPO TIPs.

The Transportation Review Advisory Council (TRAC) voted on a draft project list at their February 22 meeting. All applications submitted for projects in Central Ohio (six from the MPO area and two from the CORPO area) were recommended for funding in some capacity. The downtown innerbelt projects (Phases 2D and 3) did not receive construction funds but did receive detailed design funding. The public comment period is open through March 23. TRAC votes on the final project list March 29.

<u>Proposed Resolution EC-01-23</u>: "Adopting MORPC's Executive Succession Policy" – Shawn Hufstedler

This resolution adds understanding and guidance for the officers and Executive Committee should the executive director position turnover. We have an internal management policy for absences of less than 30 days. MORPC HR Director Andrea Doolittle drafted the policy after researching best practices. The policy is congruent with Mr. Murdock's contract.

Kim Maggard made a motion to approve Resolution EC-01-23, second by Franklin Christman; motion passed.
